## **Recommended Land Pattern: [mm]**





# **Maximum Peak Pulse Power Rating**






# **Peak Pulse Power and Current Derating**





# **Steady State Power Dissipation Derating**





After the potting material is cured, the body and termination of the product have to be checked if any reduced electrical or mechanical functions or destructions have occurred.


