Collector Current vs. Irradiance:

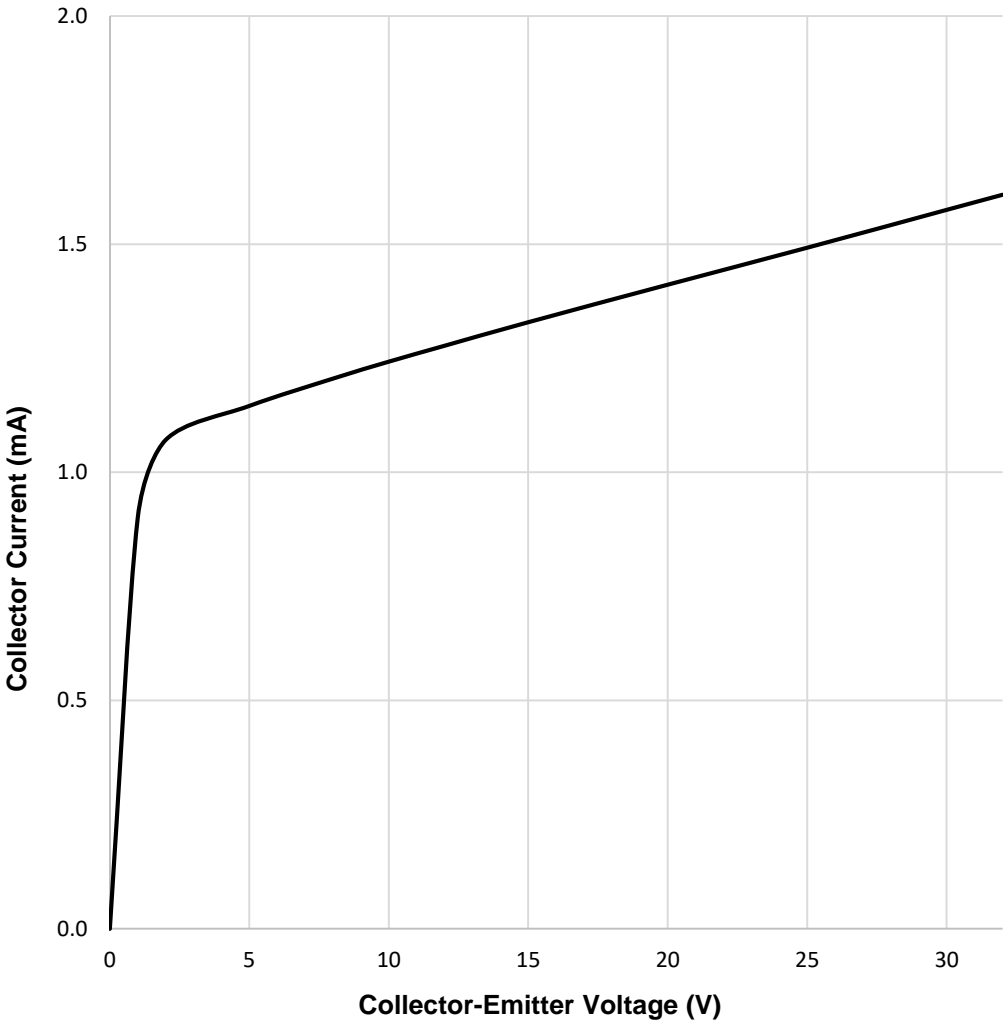

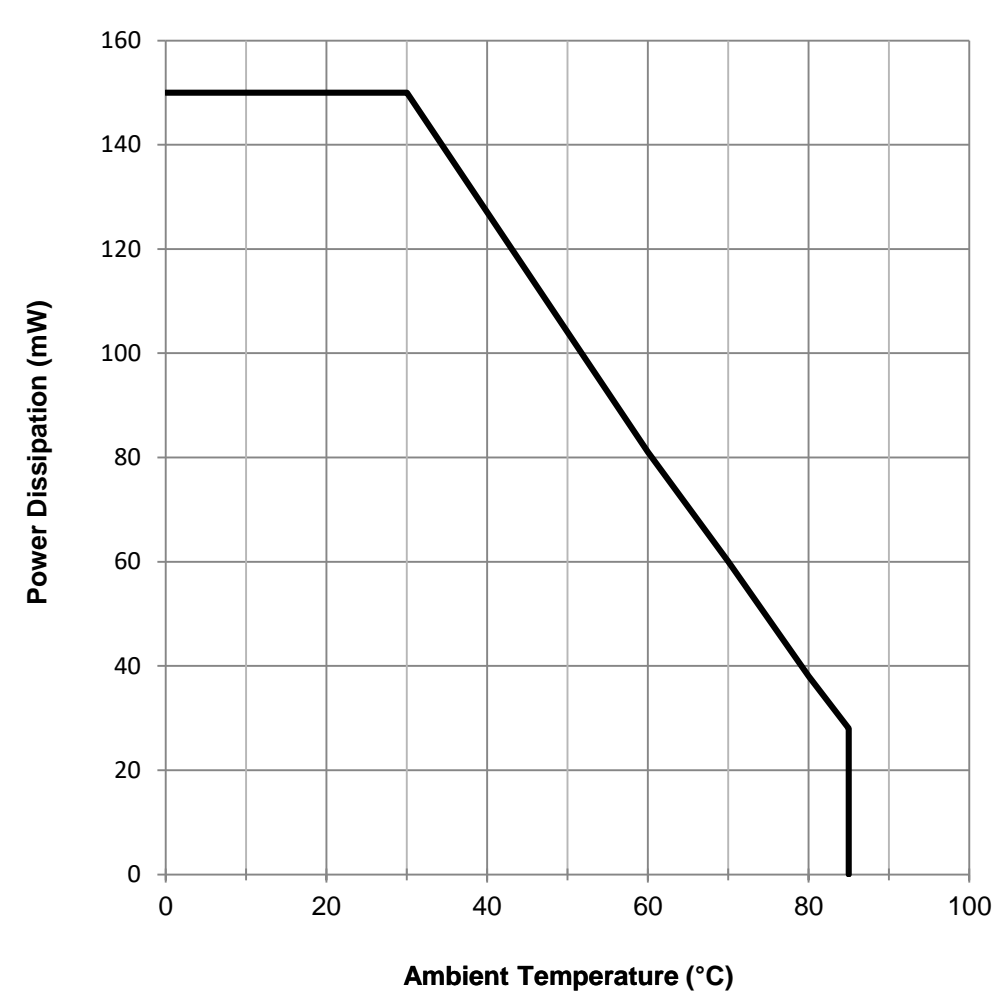



Collector Current vs. Collector-Emitter Voltage:

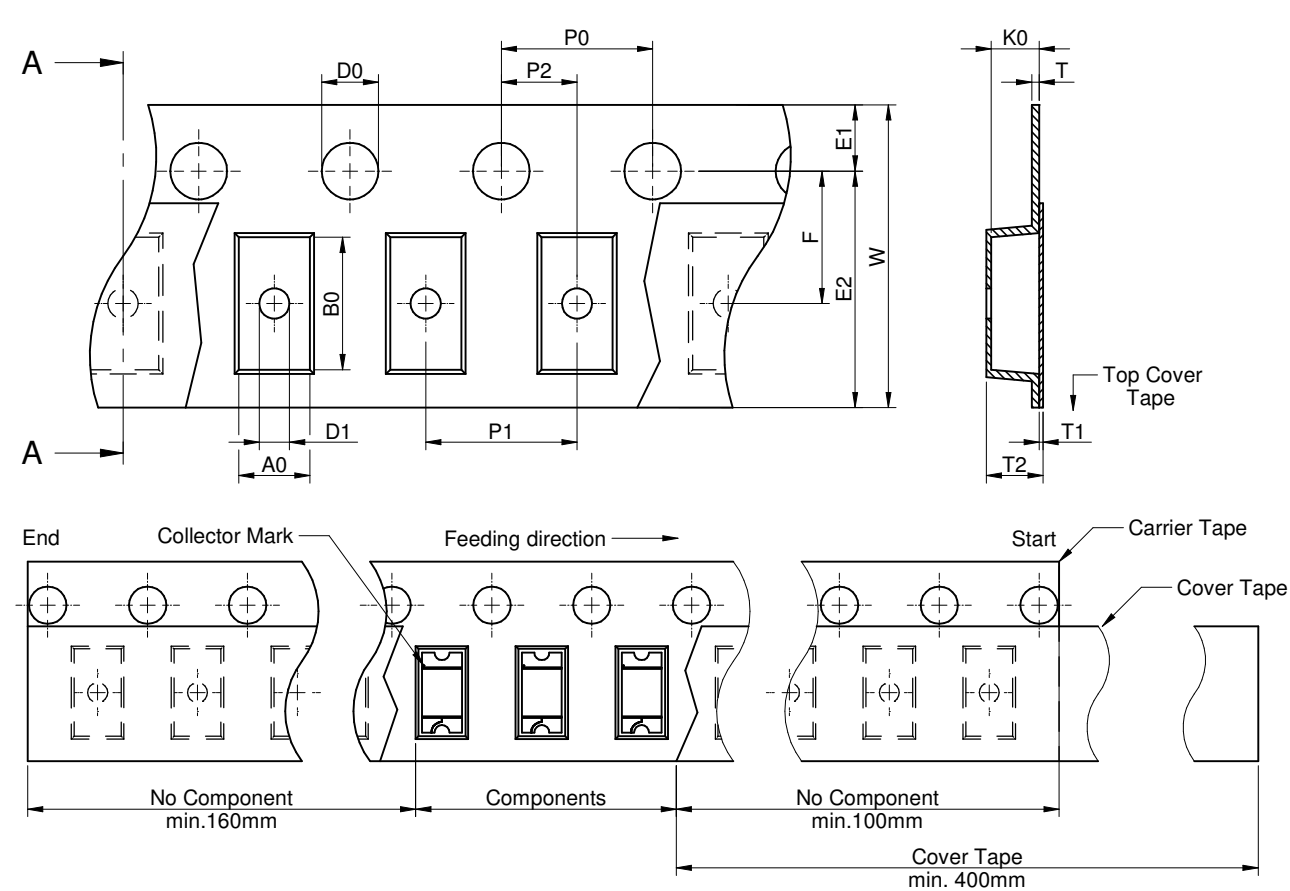
Derating Curve:
