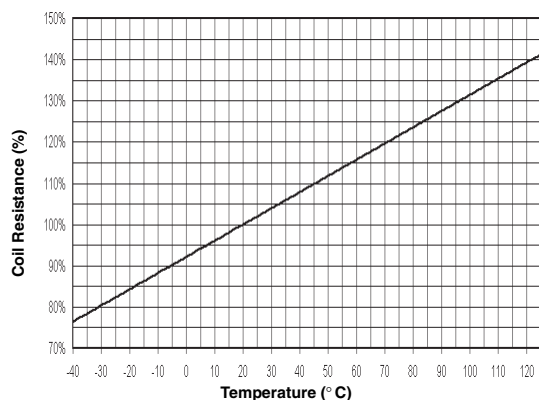

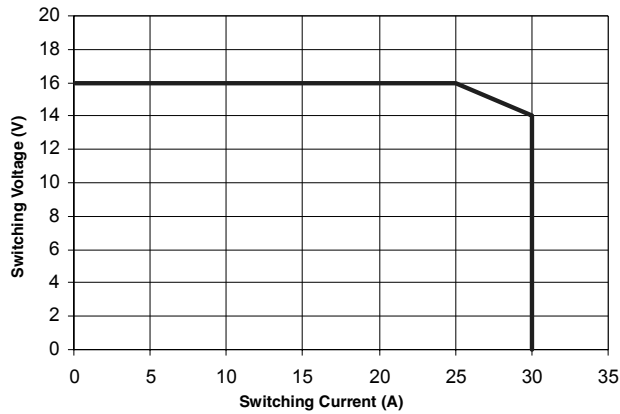

### Normalized Coil Resistance vs. Temperature (20°C reference)

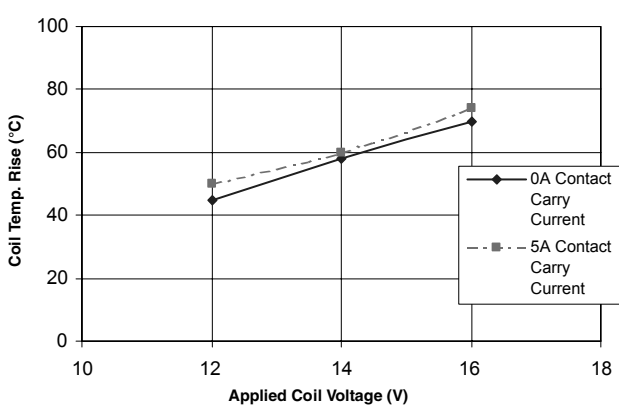


Example: Resistance of 225Ω coil

 = 125% of 225Ω at 85°C, or 281Ω

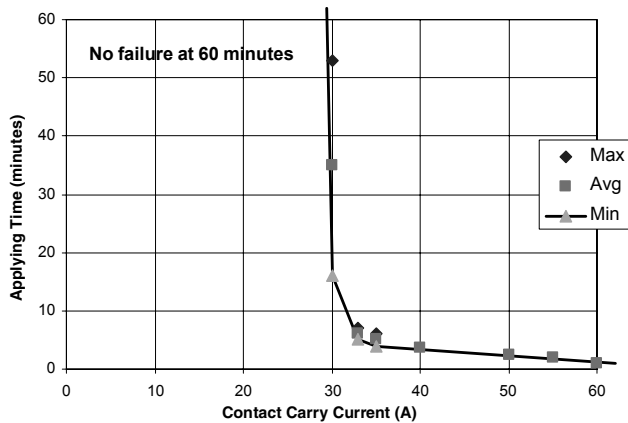
Load Limit Curve



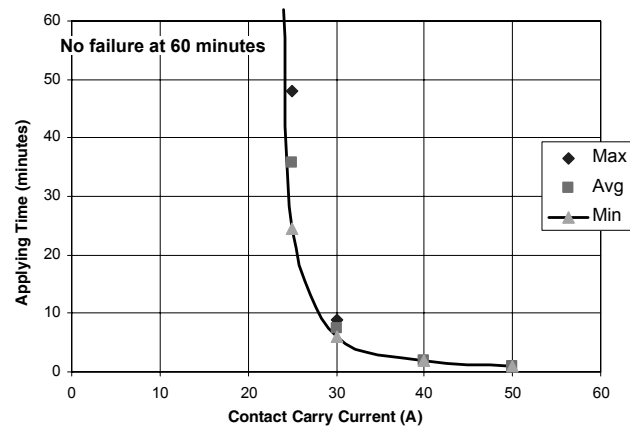
Coil Temperature vs. Applied Voltage  
at 20°C (G8N-1, 225Ω coil)



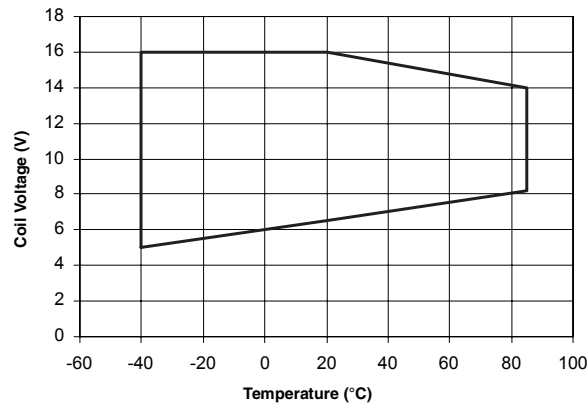
Overcurrent Energization  
(20°C, G8N-1 225Ω coil, 4 samples)



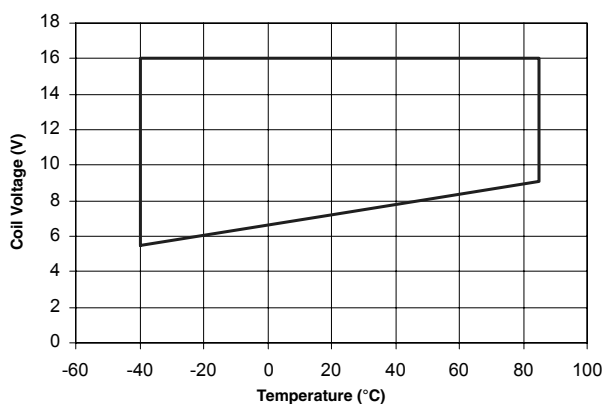
Overcurrent Energization  
(85°C, G8N-1 225Ω coil, 4 samples)



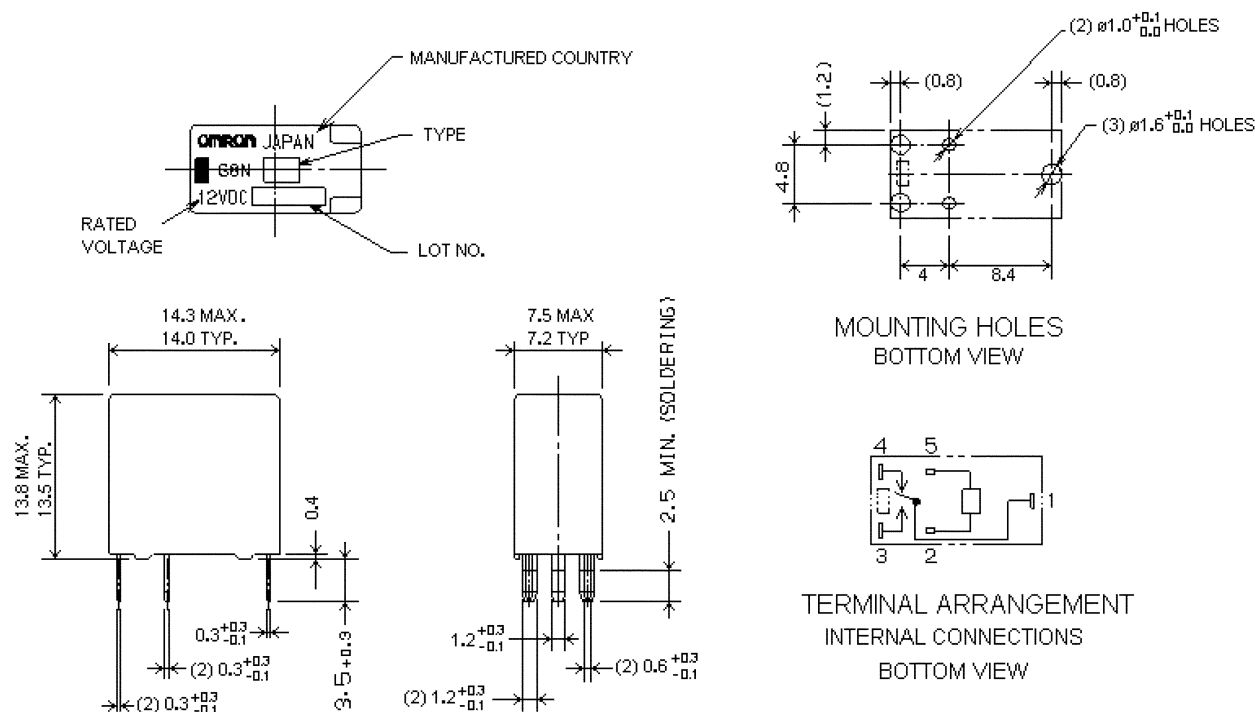
Operating Voltage Range

(G8N-1, 225Ω coil)

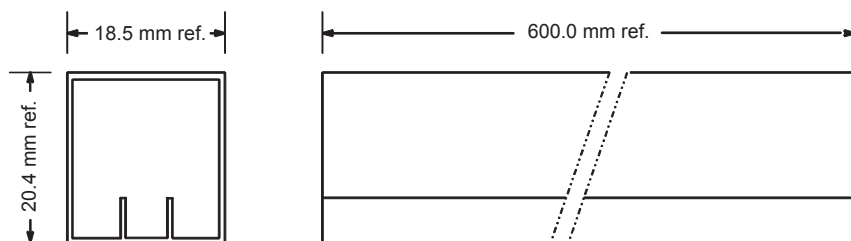
