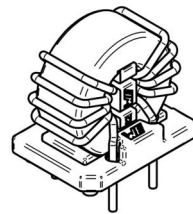

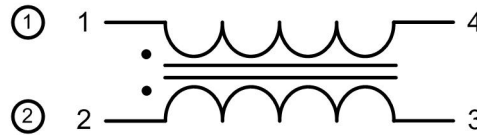

### F Typical Insertion Loss Characteristics:



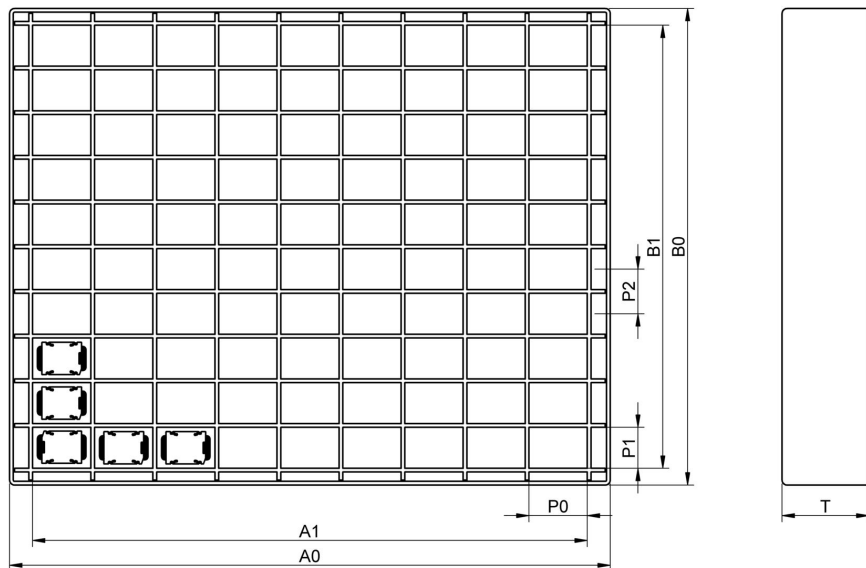

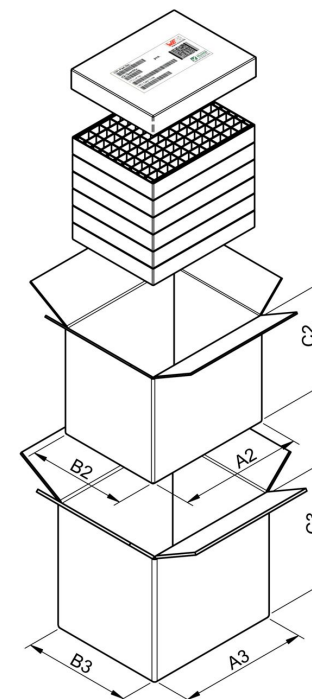


