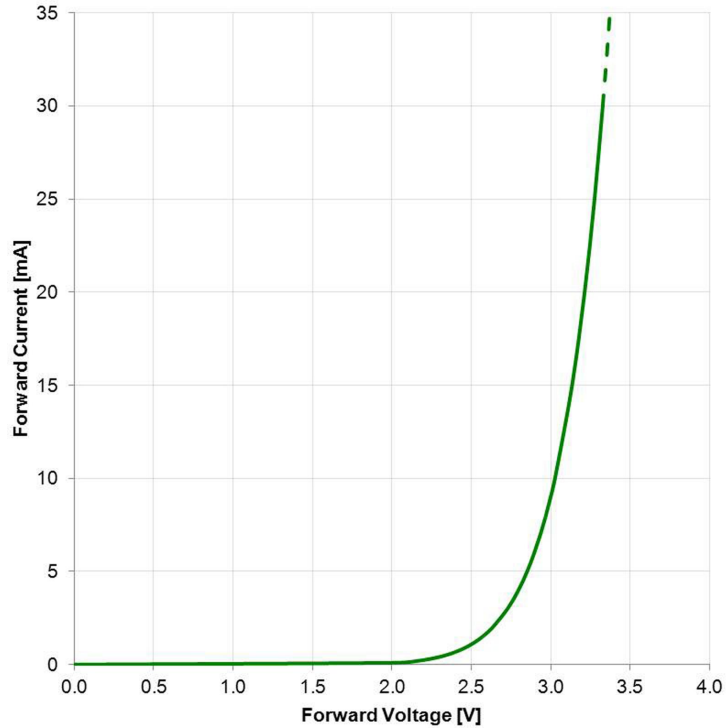

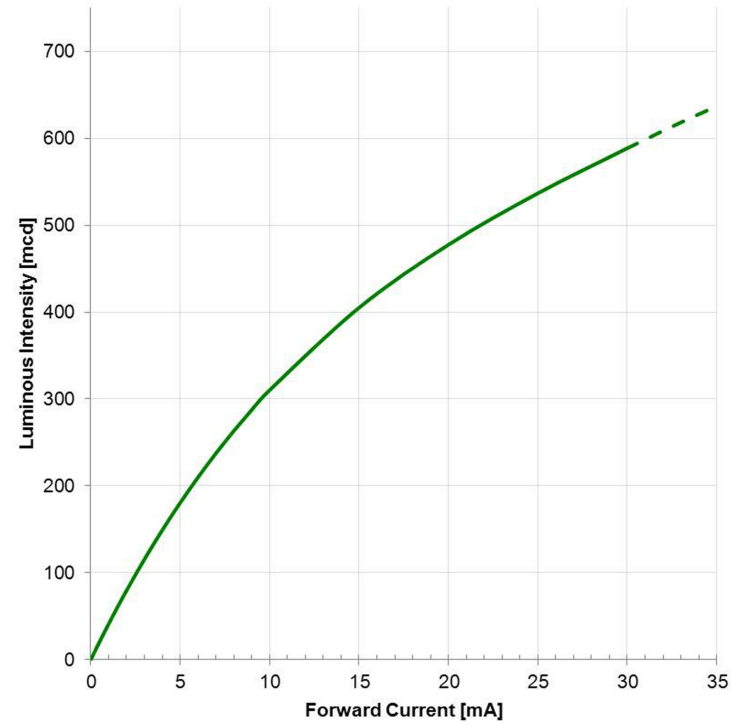

**F5 Derating Curve:**



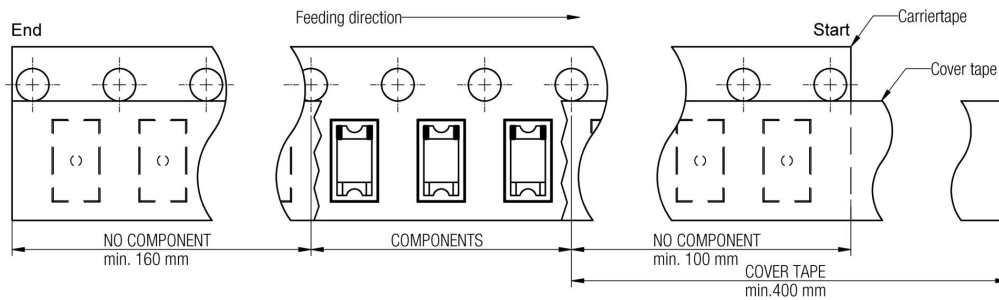
