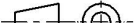

F Typical Impedance Characteristics:

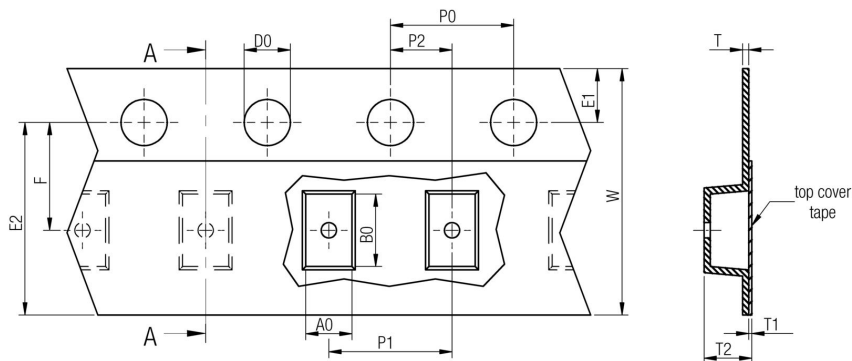


Differential Mode

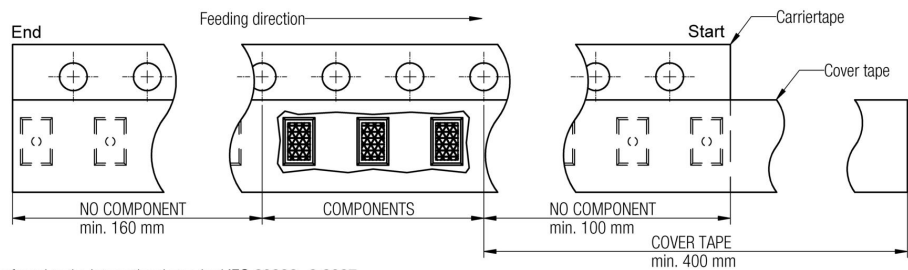
