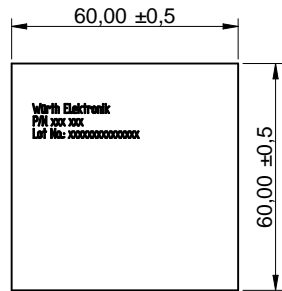
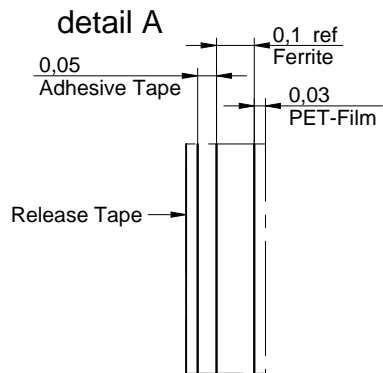

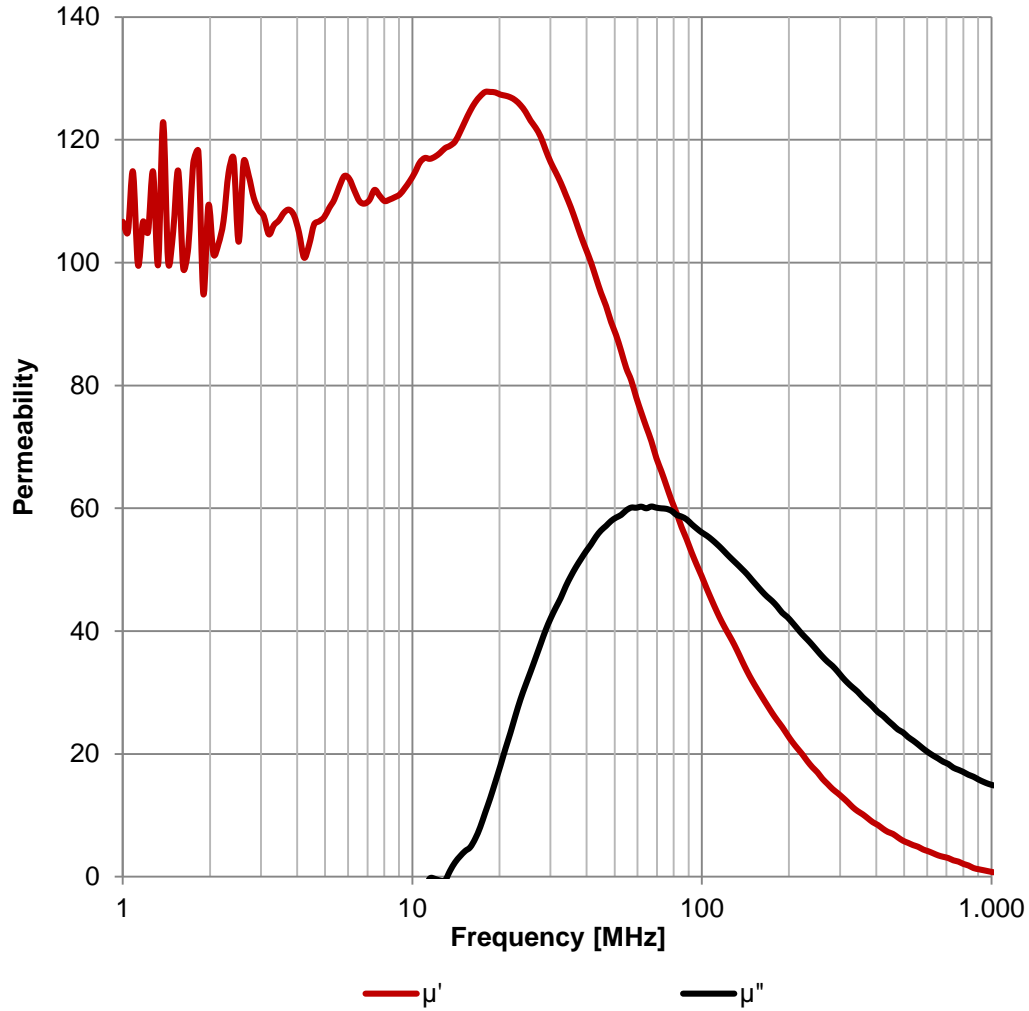

## Permeability vs. Frequency:






