


# Forward Current vs. Collector Dissipation Temperature Rating



Light Current vs. Collector–Emitter Voltage Characteristics (Typical)




Response Time vs. Load Resistance Characteristics (Typical)




Forward Current vs. Forward Voltage Characteristics (Typical)




Relative Light Current vs. Ambient Temperature Characteristics (Typical)




**Sensing Position Characteristics** (Typical)




## Light Current vs. Forward Current Characteristics (Typical)




#### Dark Current vs. Ambient Temperature Characteristics (Typical)

#### II. SALES
