F Derating Curve:

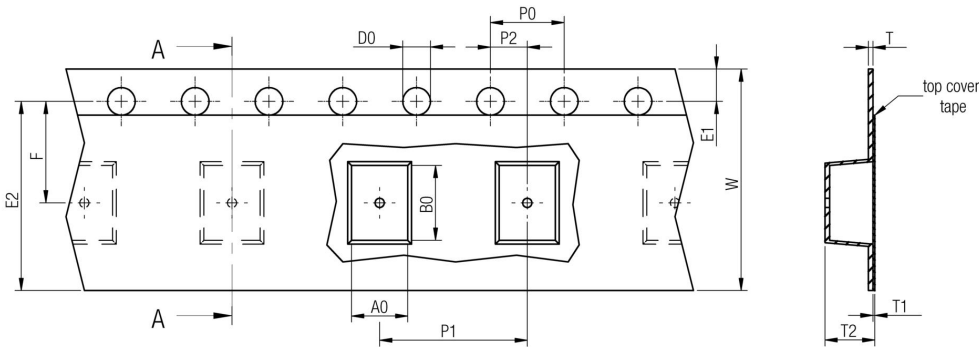
