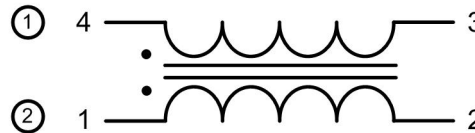

Differential Mode

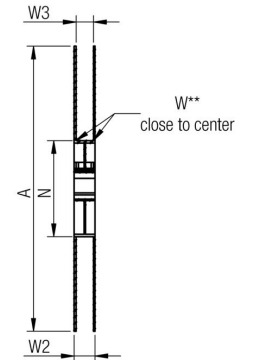
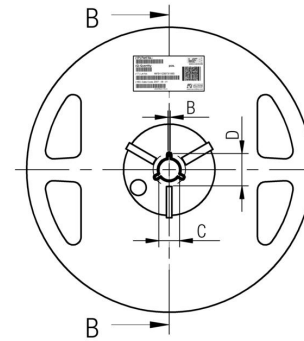
