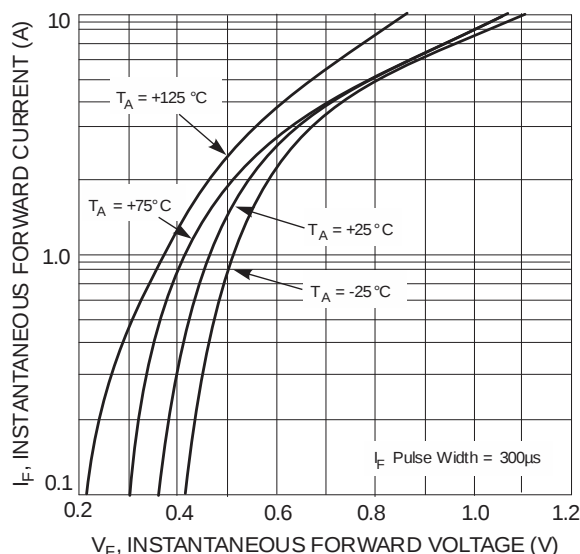


Fig. 1 Typical Forward Characteristics - B140Q/BQ

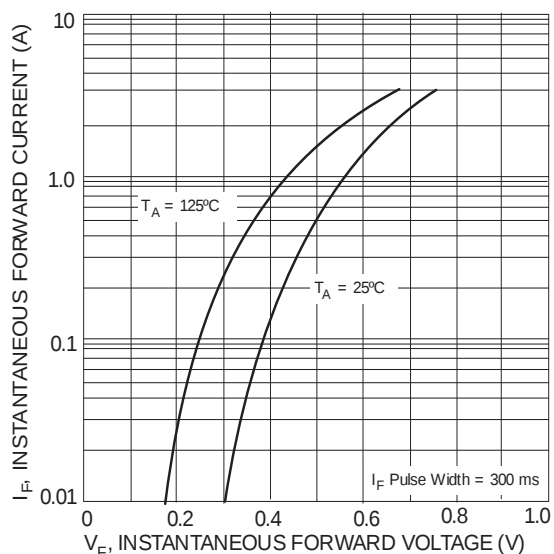
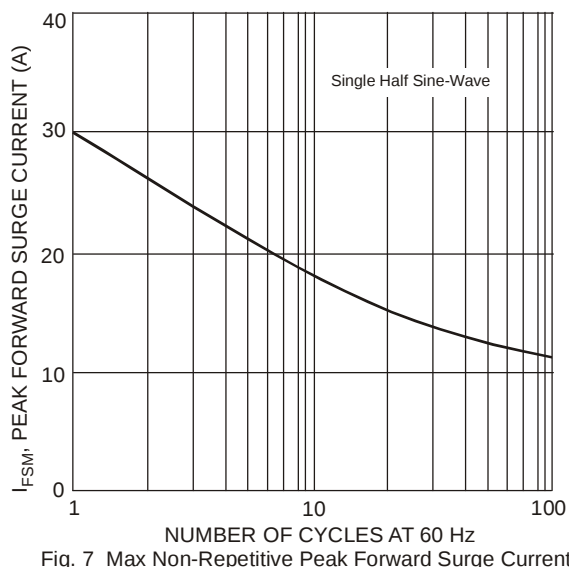
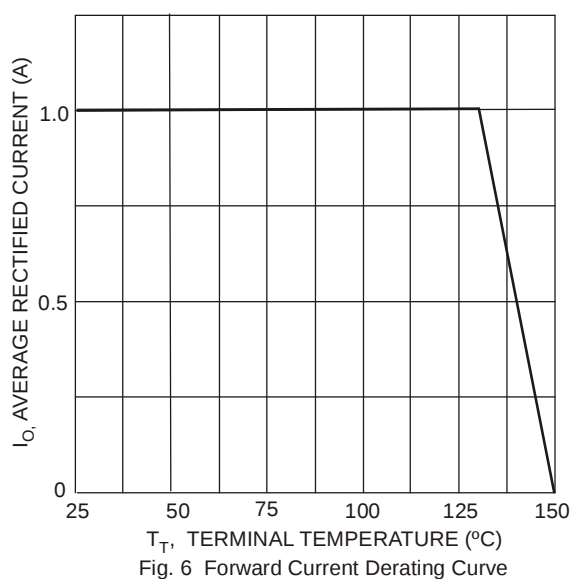
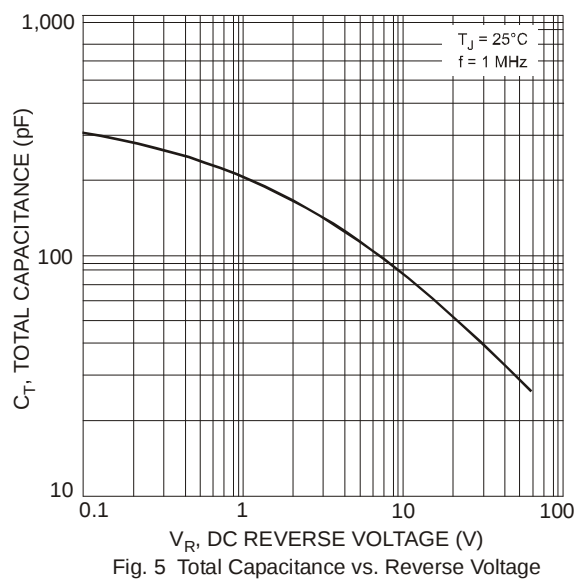
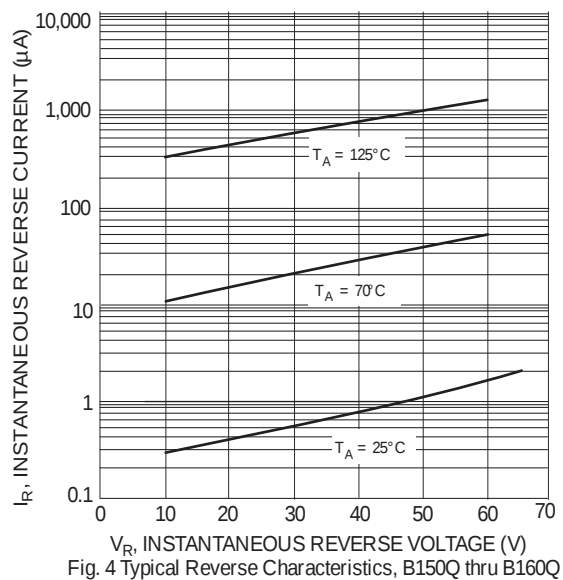
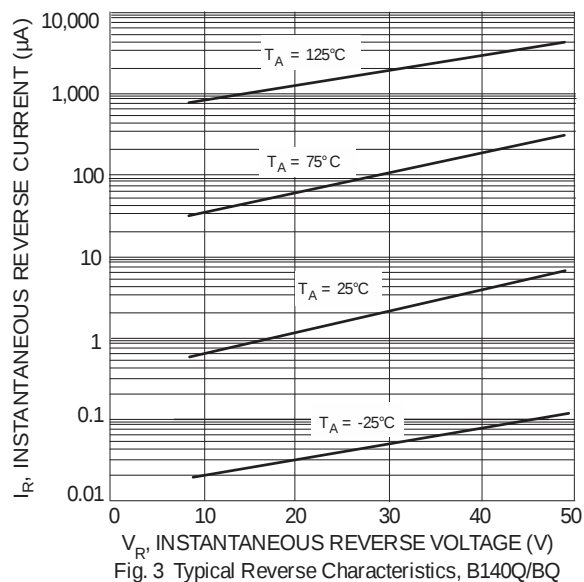


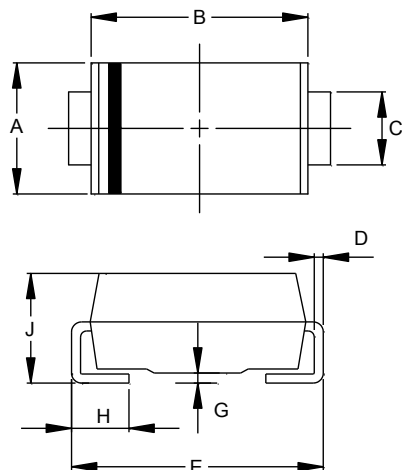
Fig. 2 Typical Forward Characteristics - B150Q thru B160Q

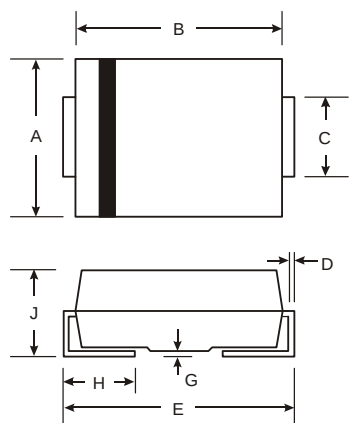

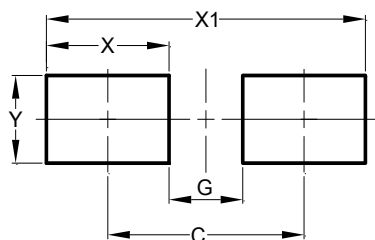

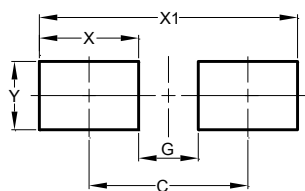
