The 74HC2G08; 74HCT2G08 is a dual 2-input AND gate. Inputs include clamp diodes. This enables the use of current limiting resistors to interface inputs to voltages in excess of V_{CC} .

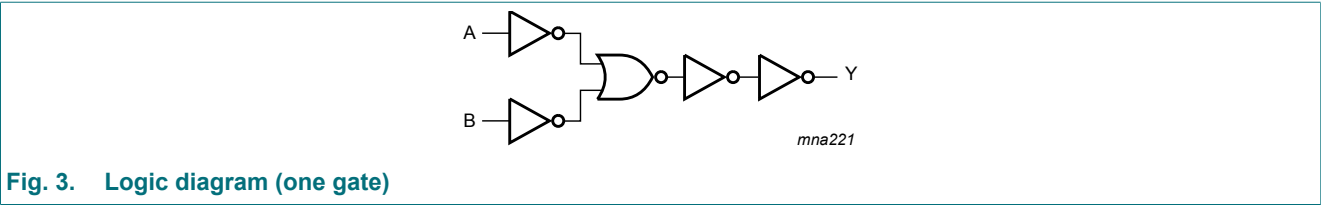

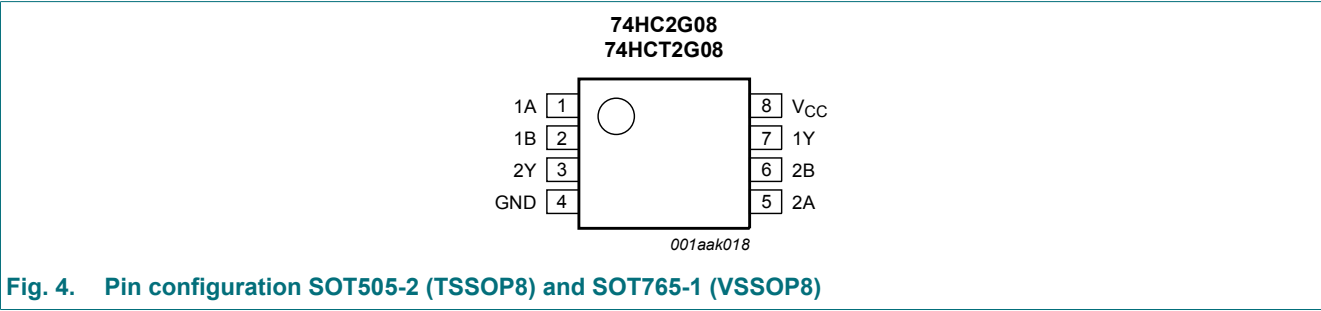

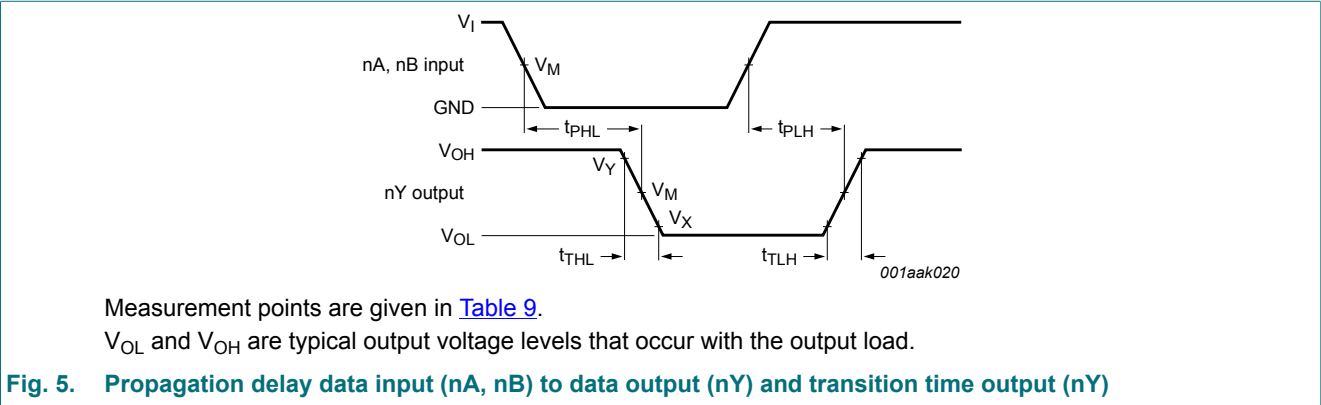

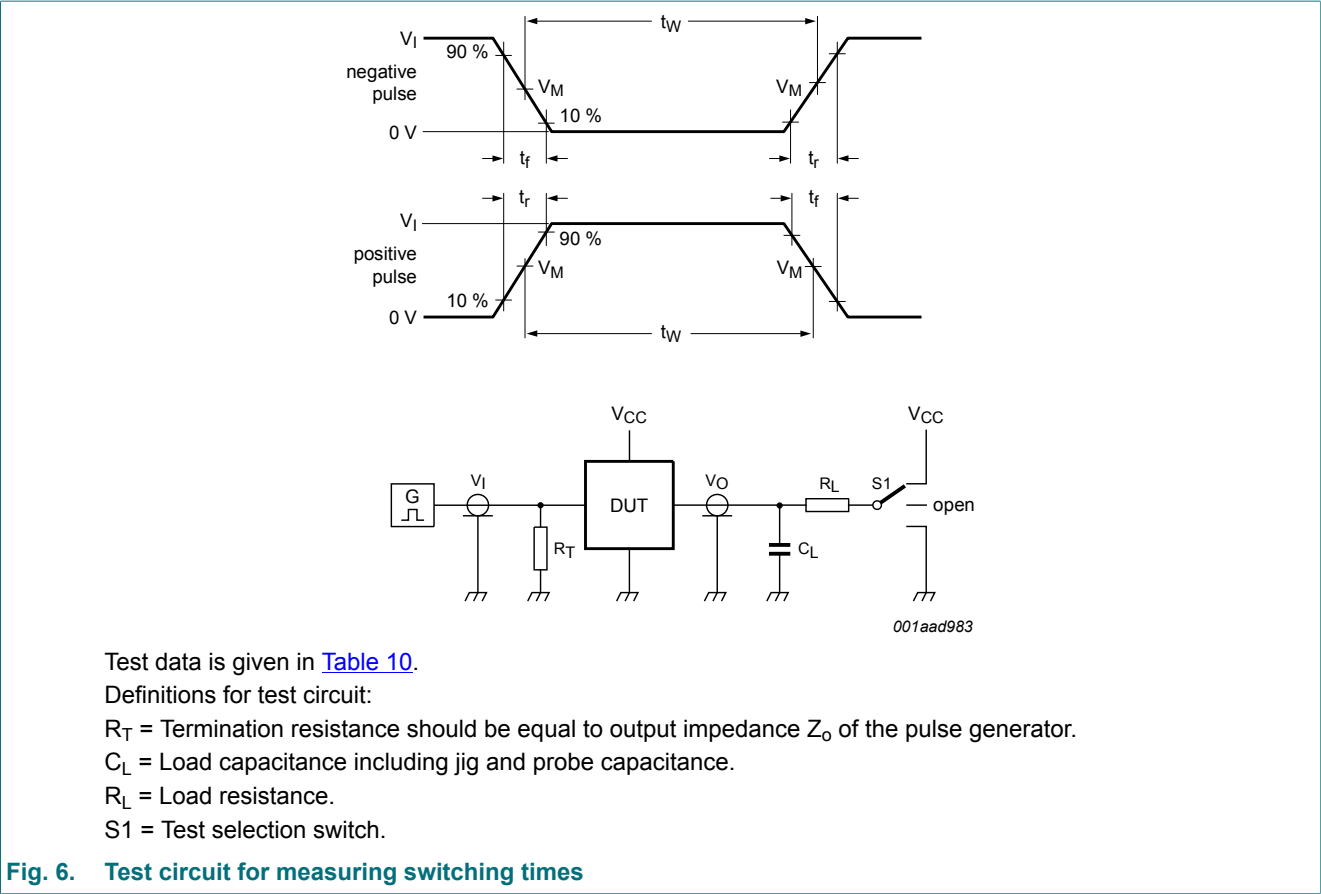


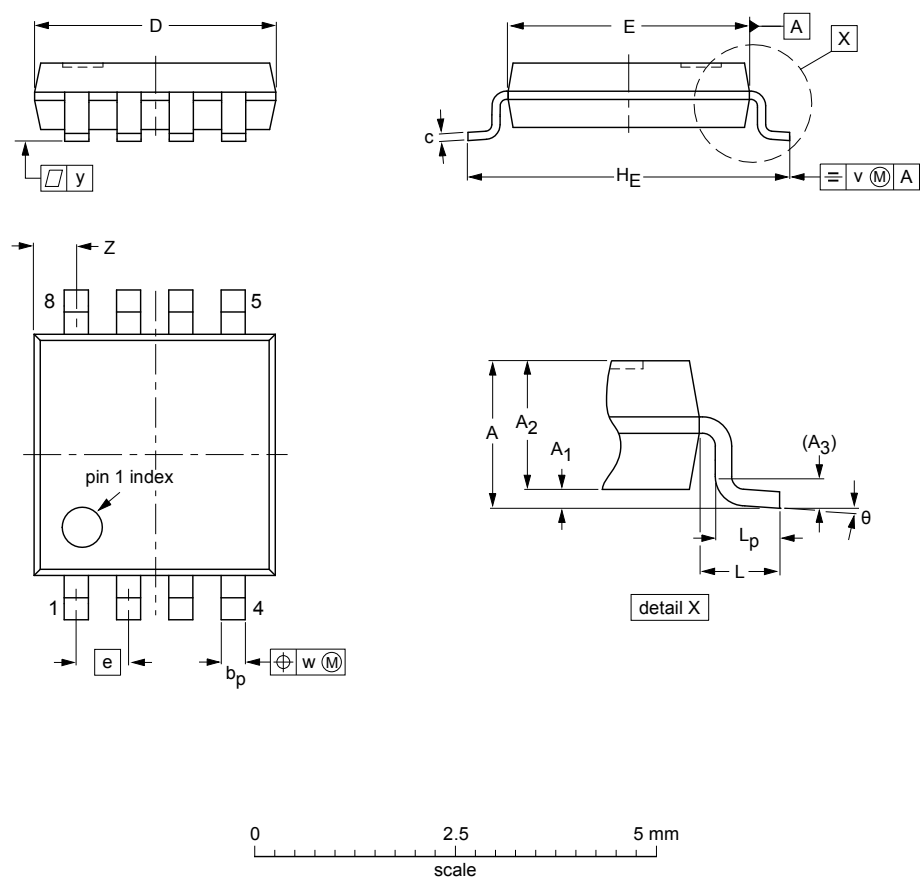
Fig. 6. Test circuit for measuring switching times

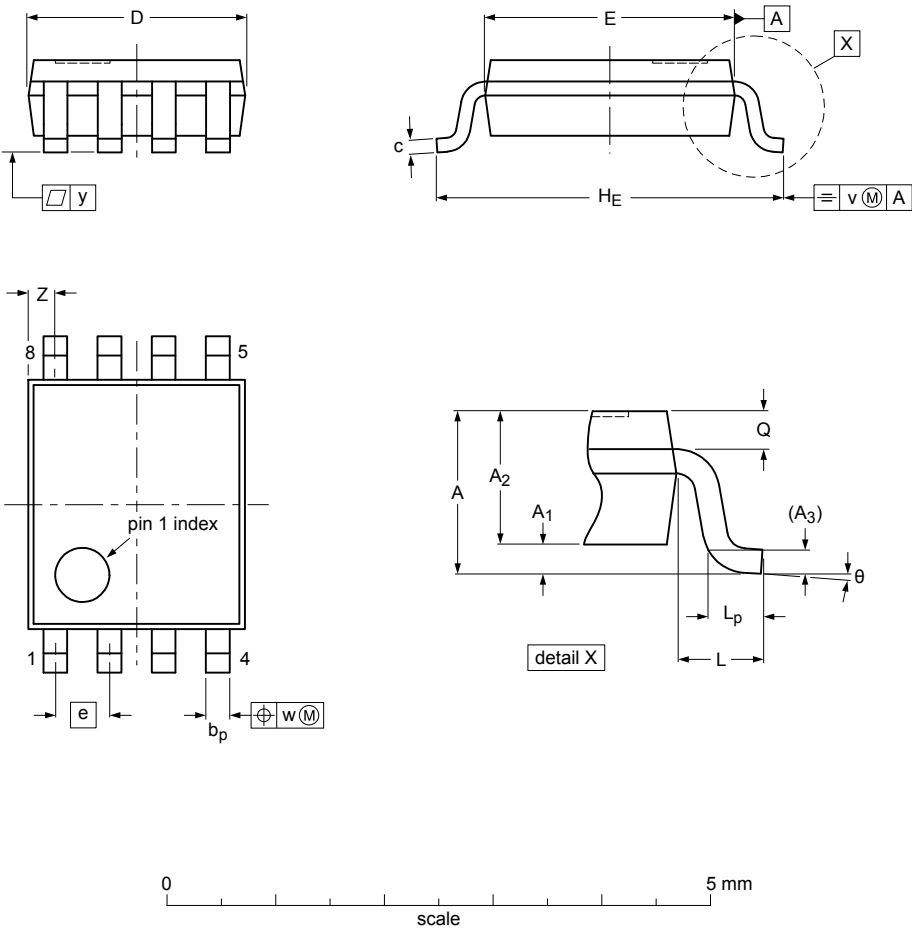
