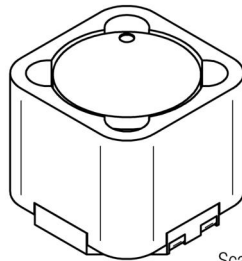

**C Schematic:**



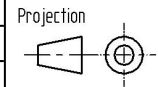

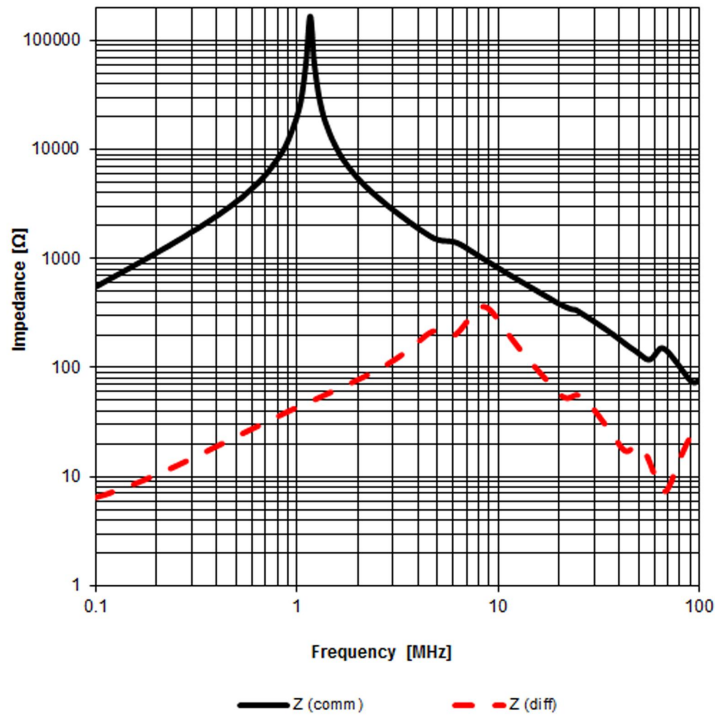
