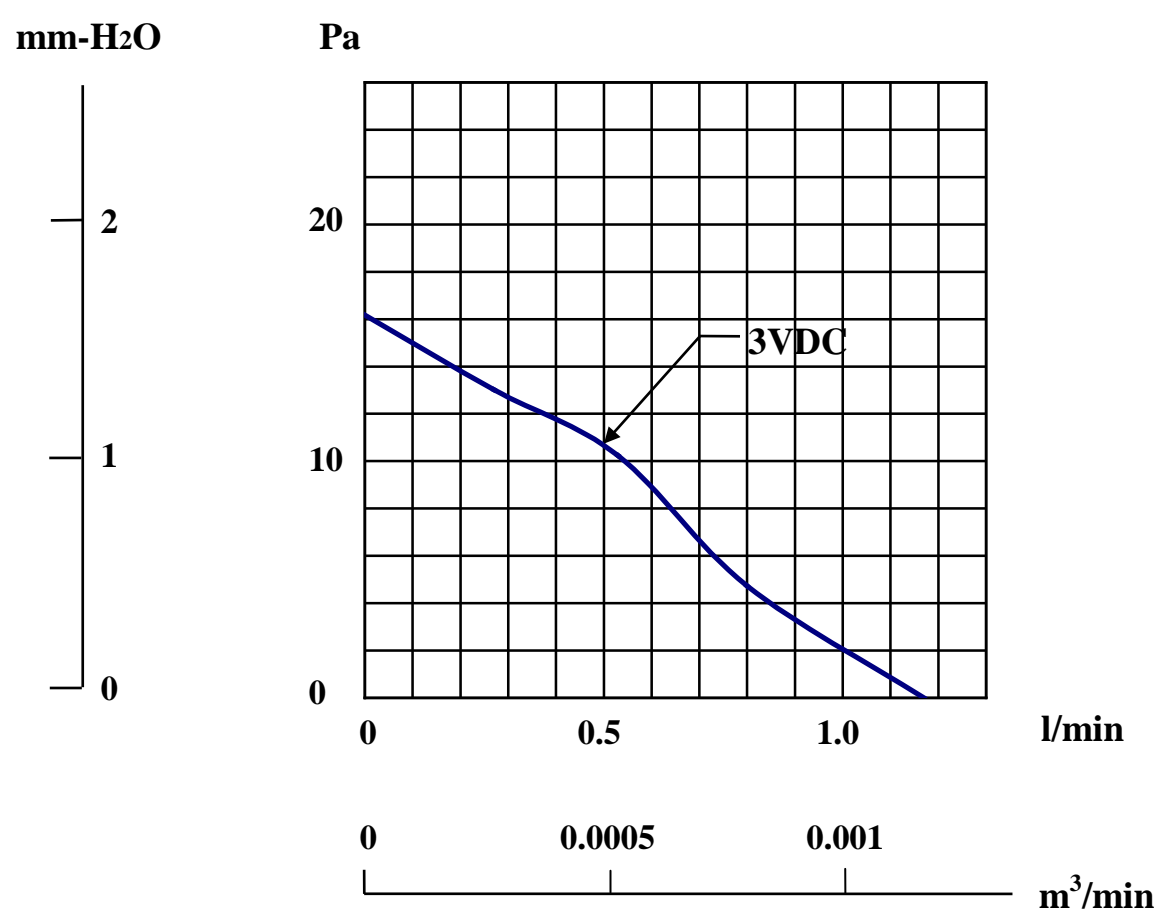

PRESSURE**

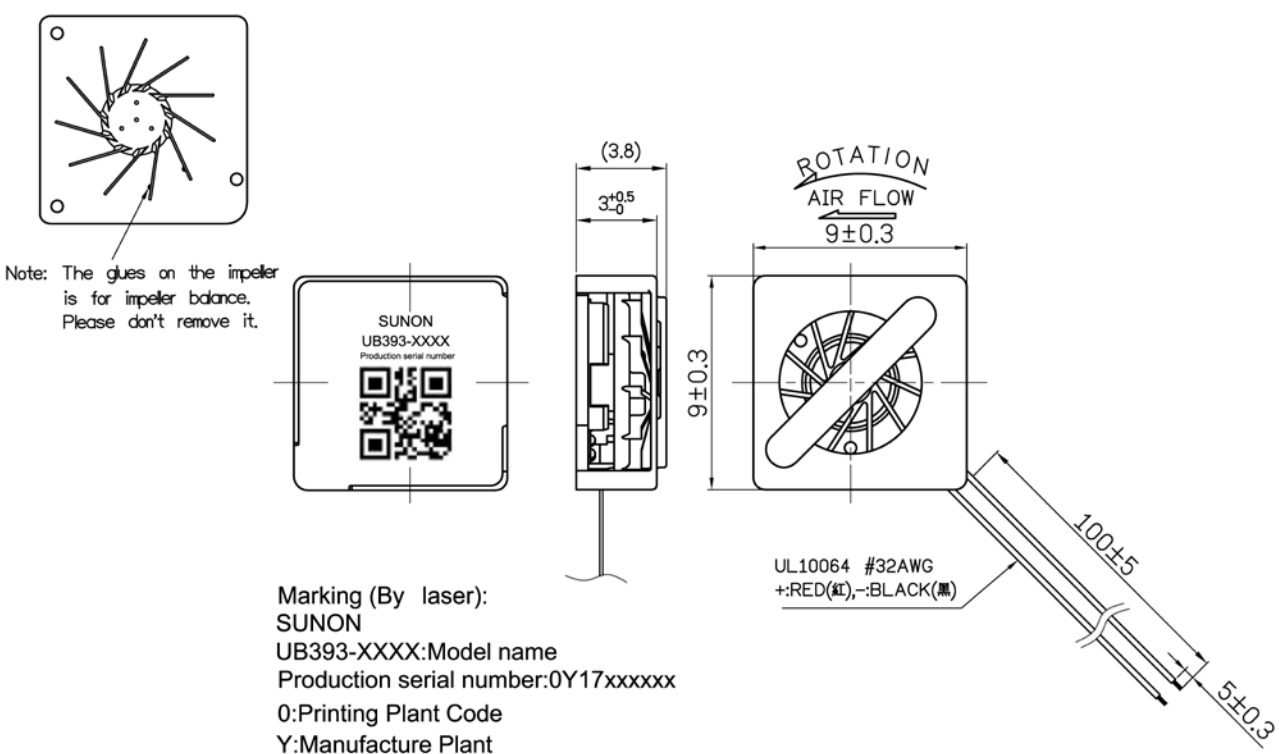
