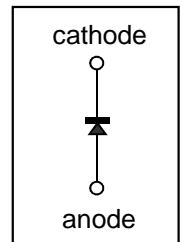

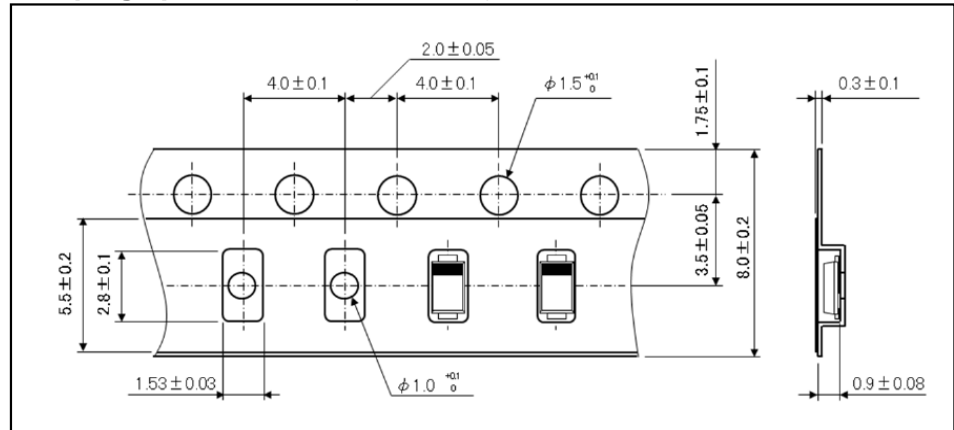
●Land size figure (Unit : mm)

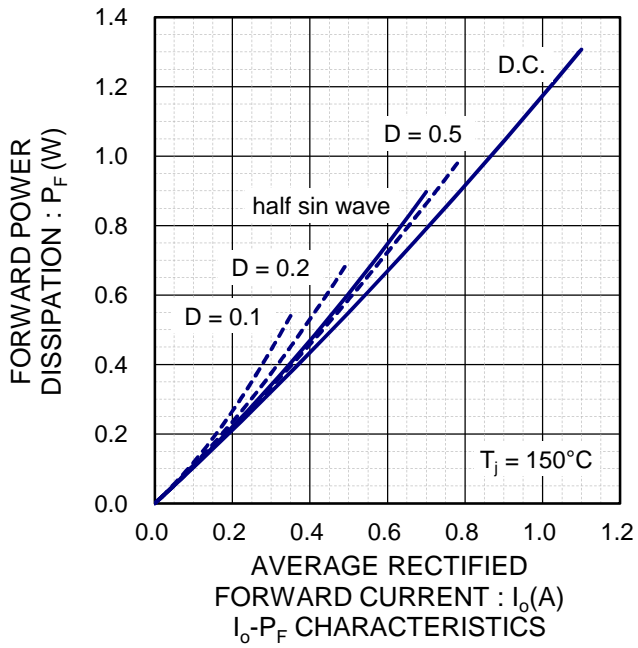
●Electrical characteristic curves
