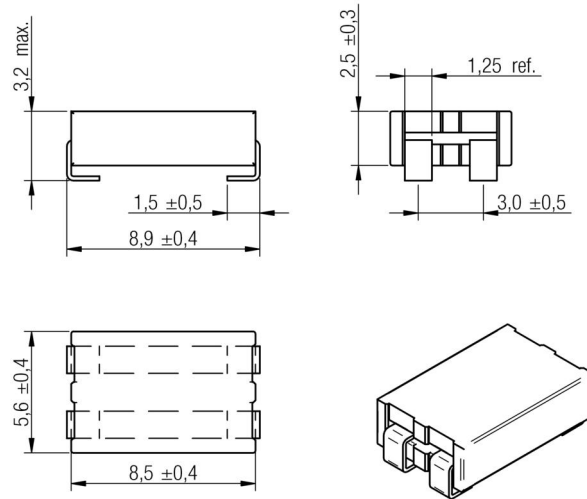

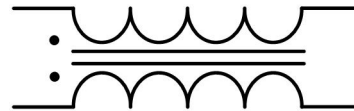

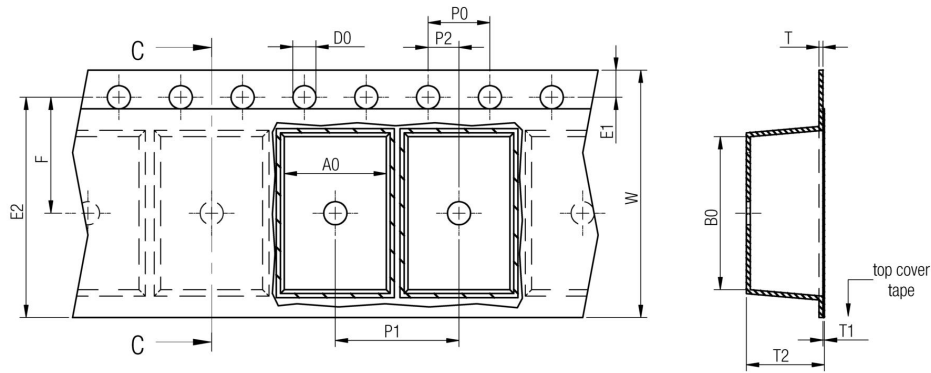
F Derating Curve:



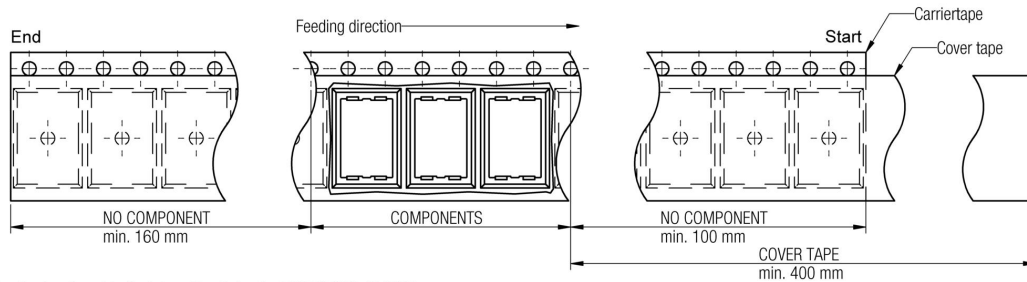
