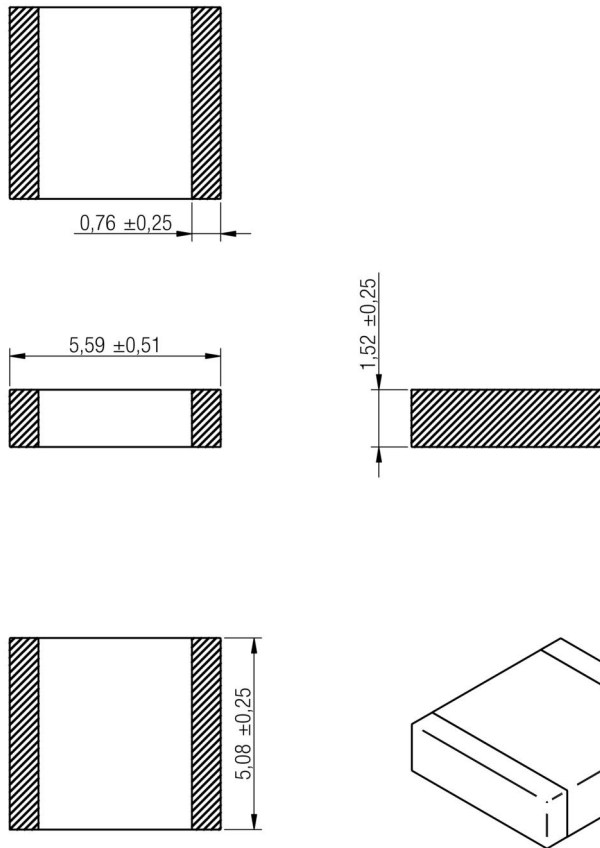
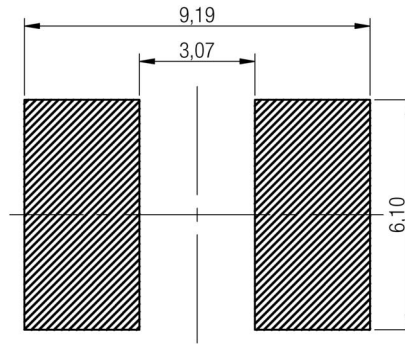

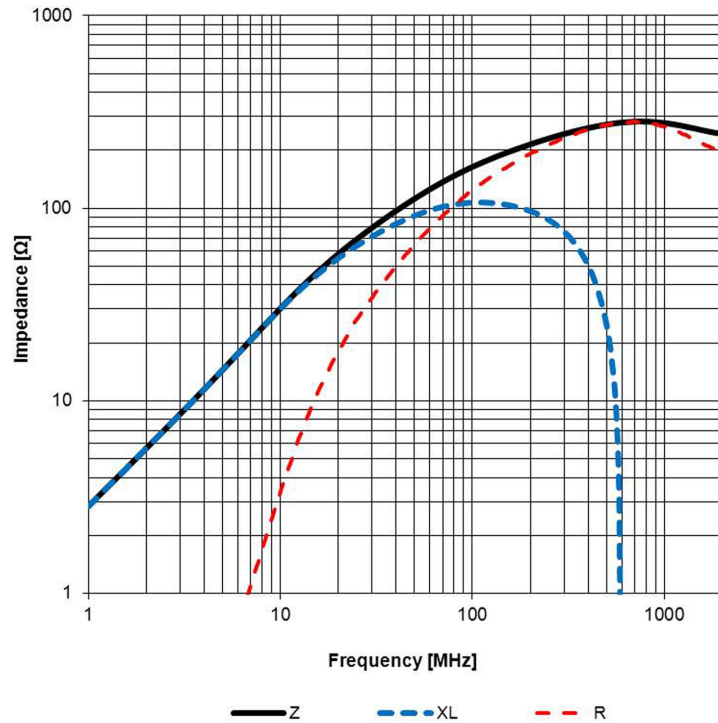

F Derating Curve:

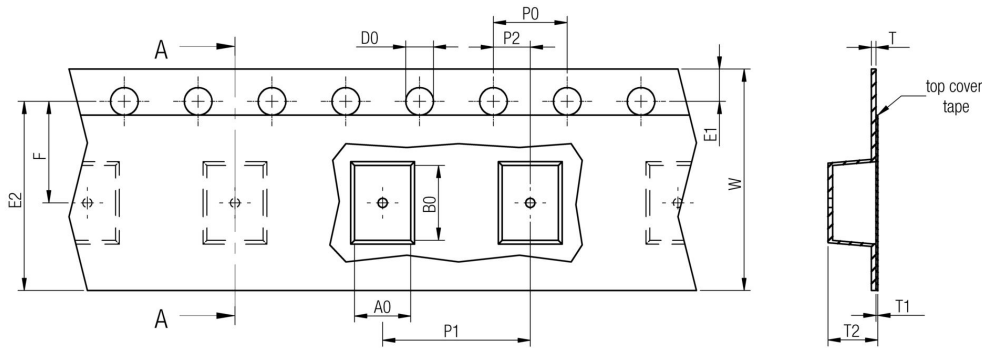
