F Derating Curve:

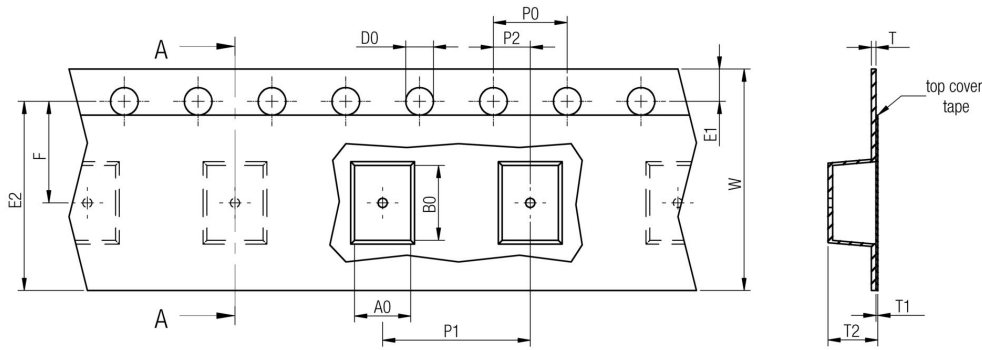

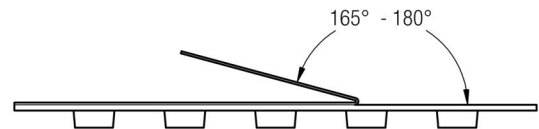

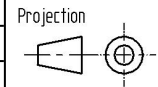
