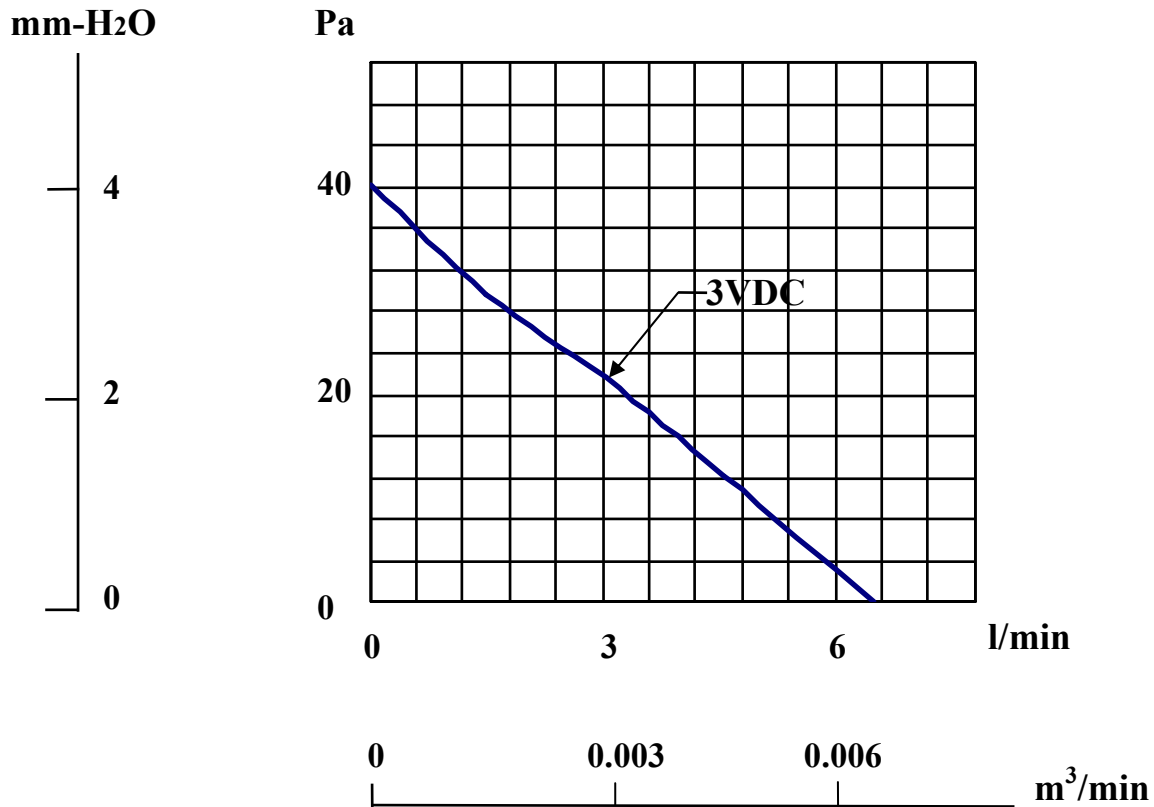

PERFORMANCE CURVES

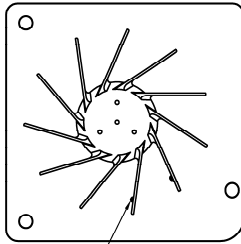
STATIC PRESSURE



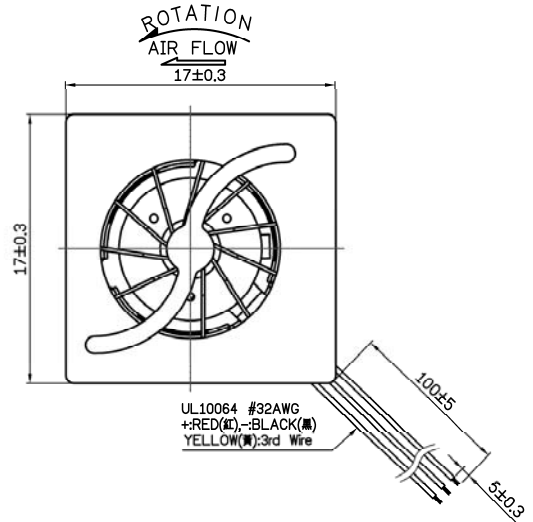

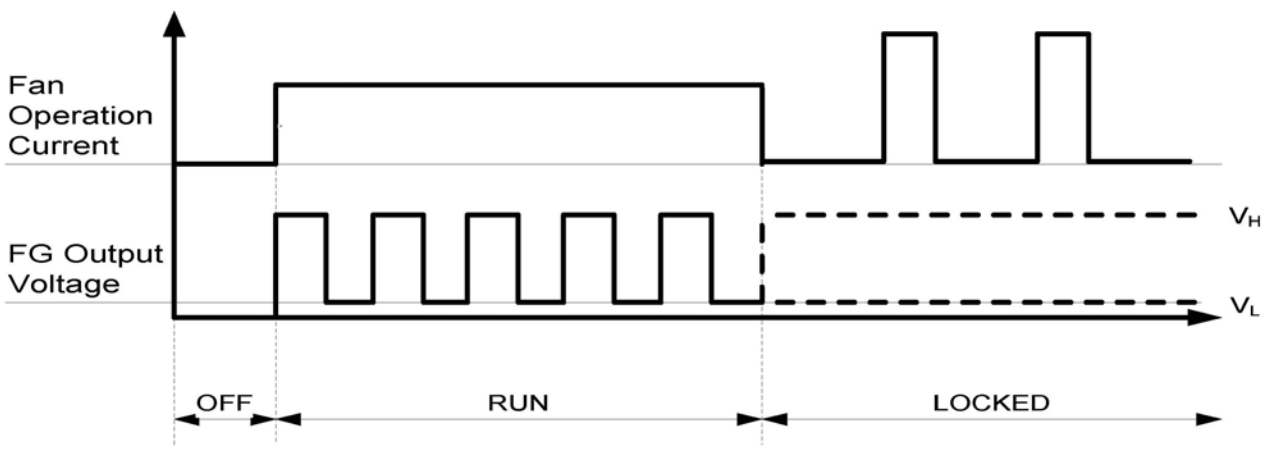
