

**1.5A ULTRA LOW DROPOUT LINEAR REGULATOR****AZ39151****General Description**

The AZ39151 is a 1.5A, high accuracy linear voltage regulator. It features 375mV dropout voltage at 1.5A output current and low ground current over all operating conditions .

The AZ39151 is specifically designed for low voltage, high current output systems, such as PC add-in cards where their tiny dropout voltage and ground current values are important attributes.

The AZ39151 has fixed 3.3V, 5.0V versions and ADJ(1.25V) version.

The AZ39151 is available in TO-252-4 (PPAK) (for fixed versions) and TO-252-5 (for adjustable version) packages.

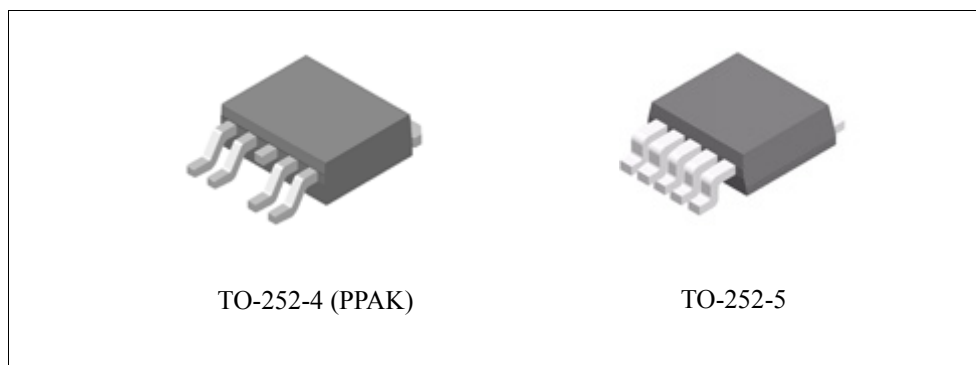


Figure 1. Package Types of AZ39151

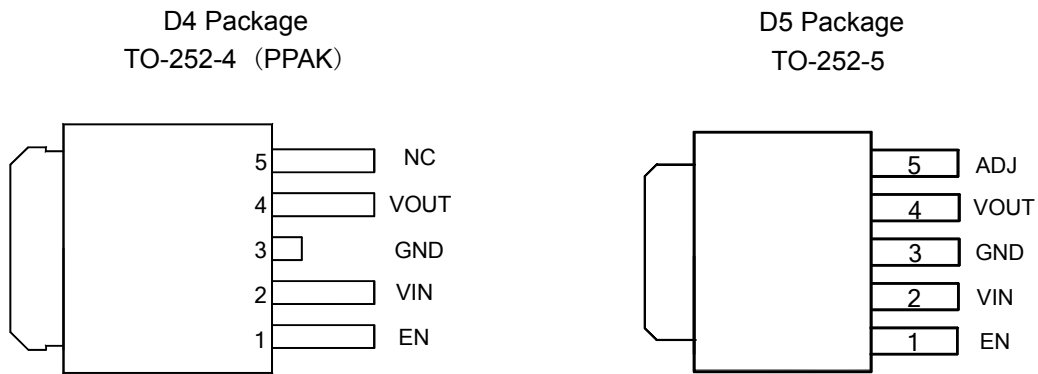


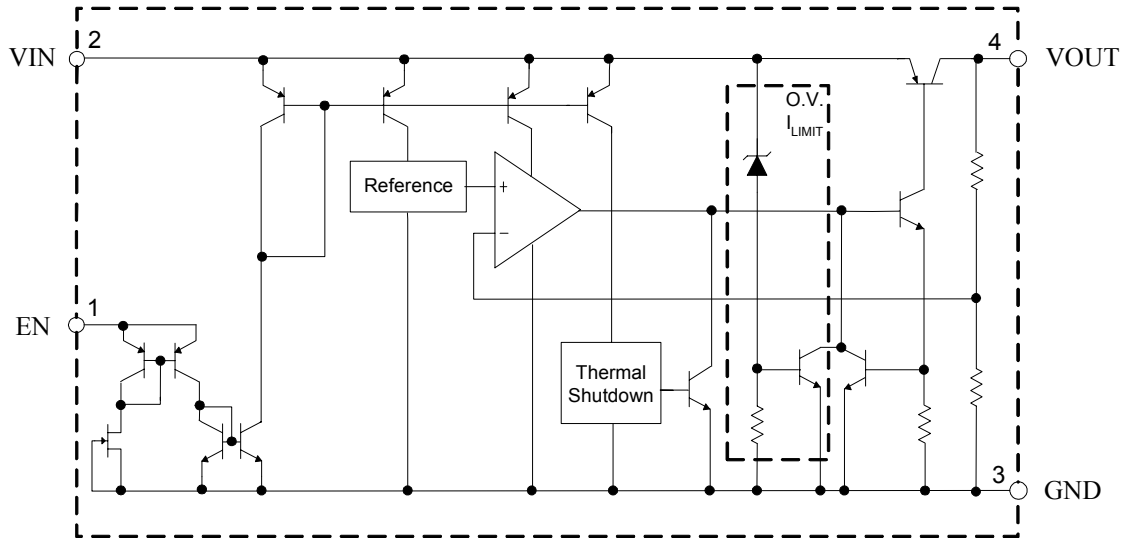
Figure 2. Pin Configuration of AZ39151 (Top View)

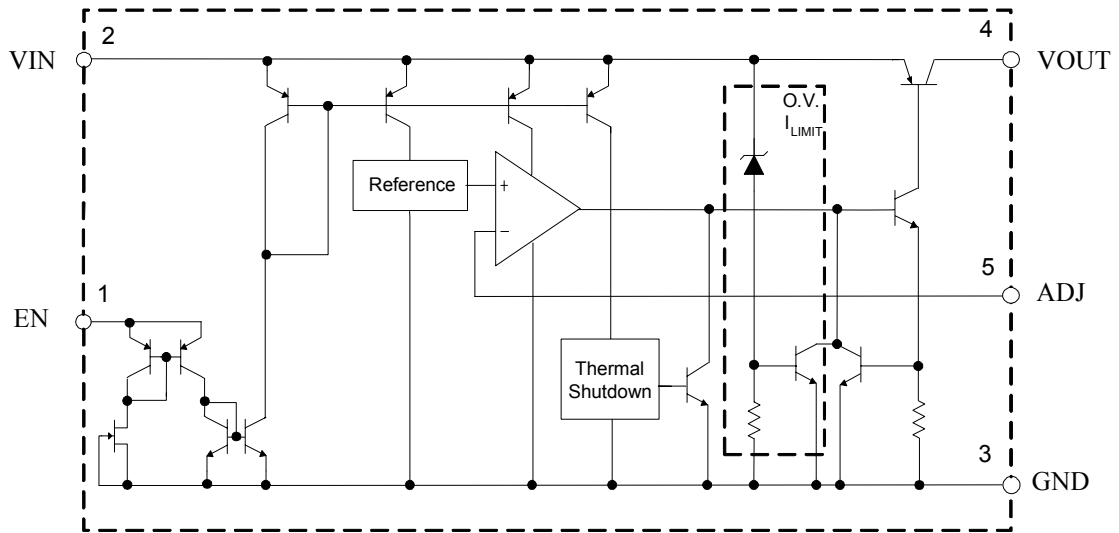

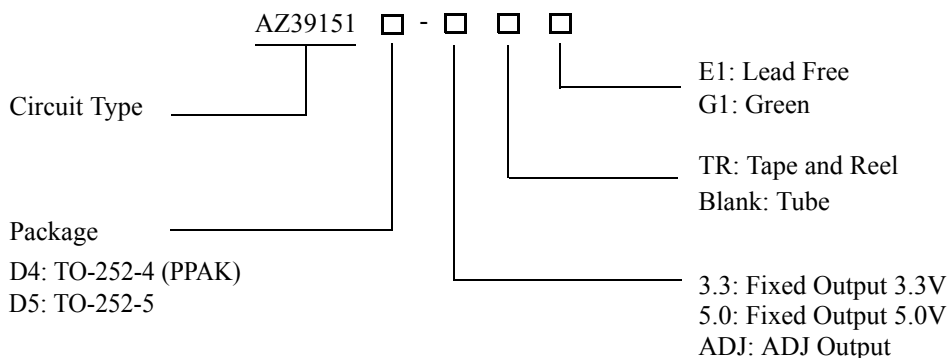
Figure 3. Functional Block Diagram of AZ39151

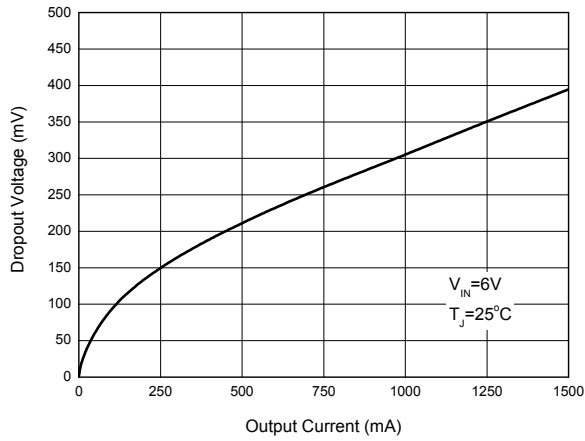


Figure 4. Dropout Voltage vs. Output Current

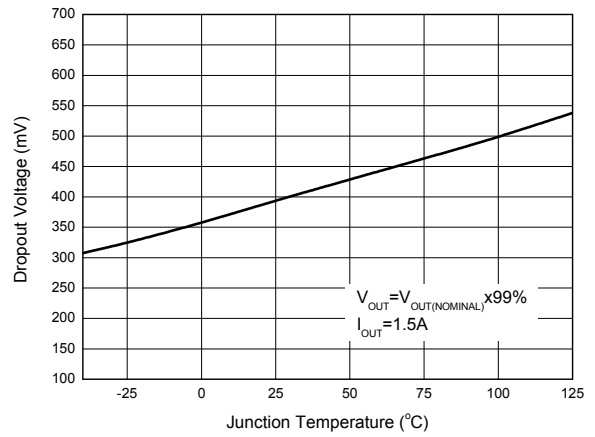


Figure 5. Dropout Voltage vs. Junction Temperature

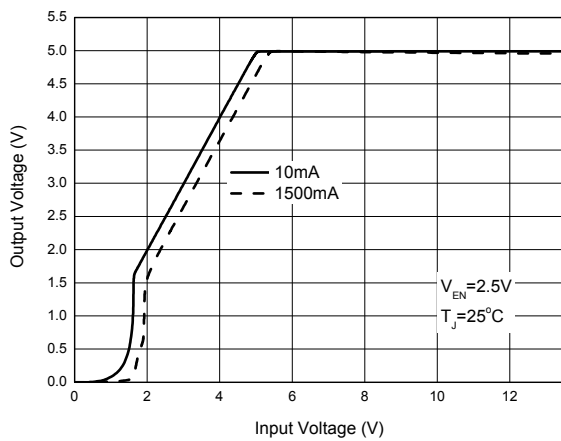


Figure 6. Output Voltage vs. Input Voltage

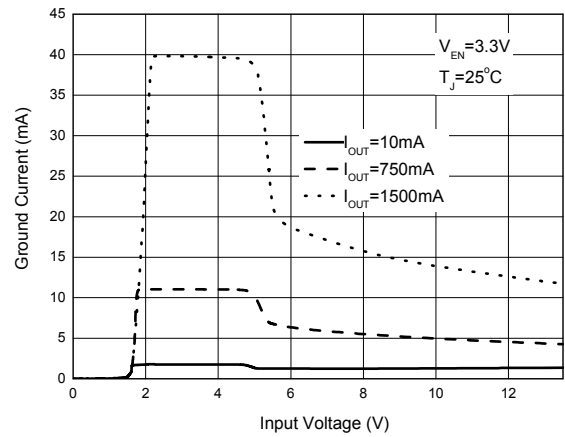


Figure 7. Ground Current vs. Input Voltage

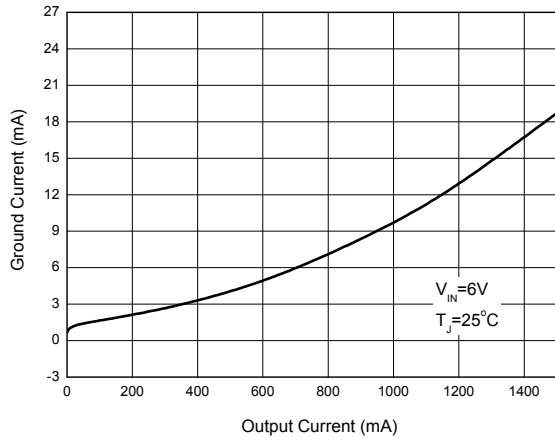


Figure 8. Ground Current vs. Output Current

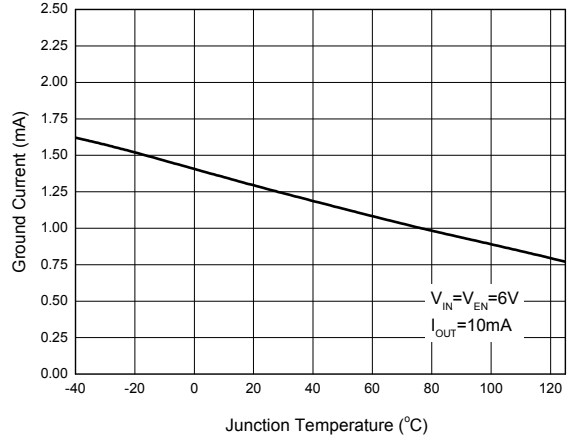


Figure 9. Ground Current vs. Junction Temperature

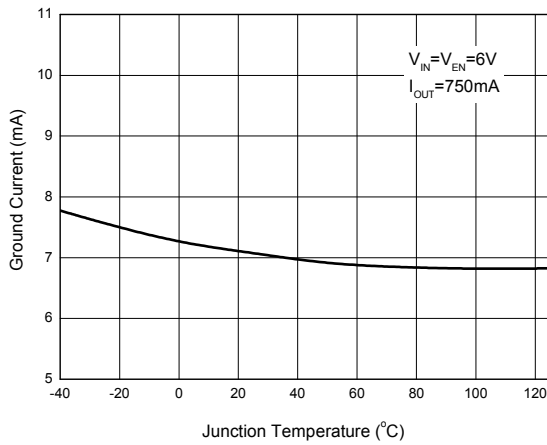


Figure 10. Ground Current vs. Junction Temperature

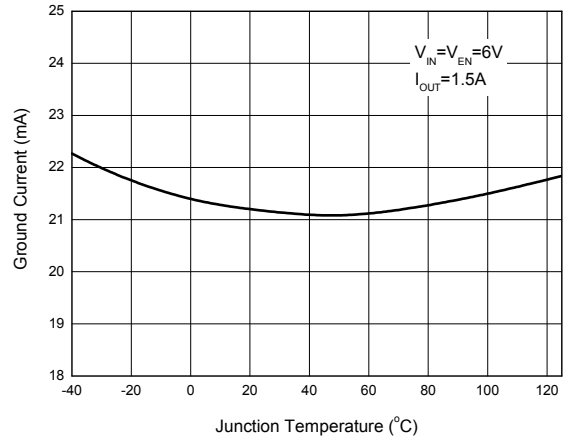


Figure 11. Ground Current vs. Junction Temperature

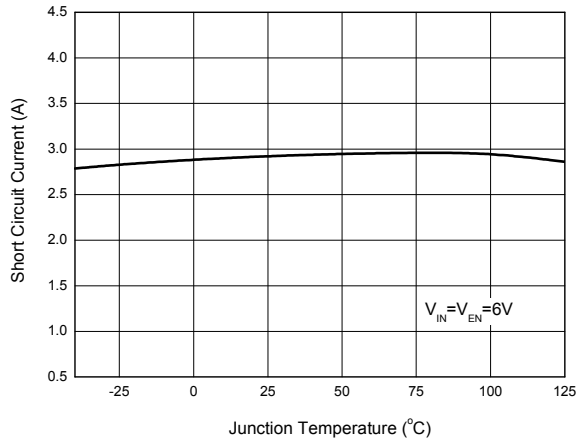


Figure 12. Short Circuit Current vs. Junction Temperature

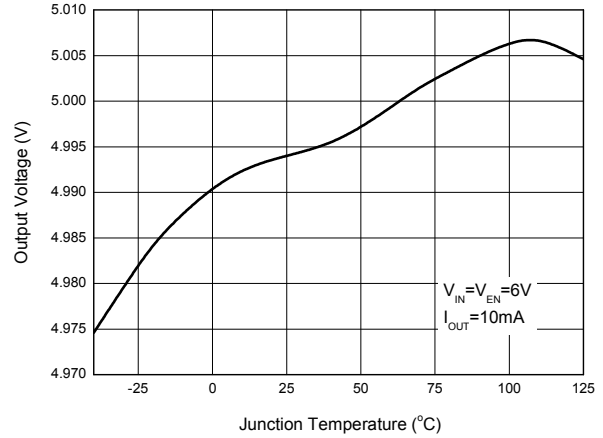


Figure 13. Output Voltage vs. Junction Temperature

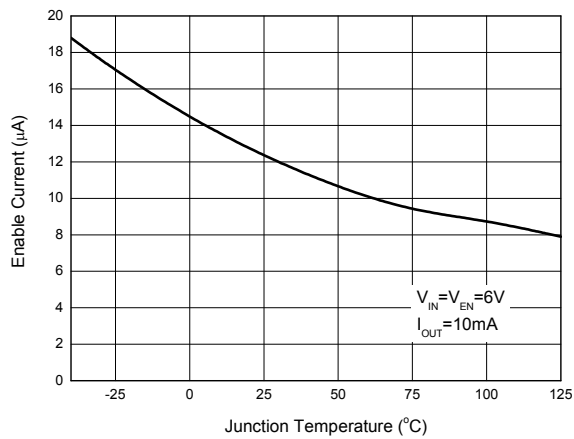


Figure 14. Enable Current vs. Junction Temperature

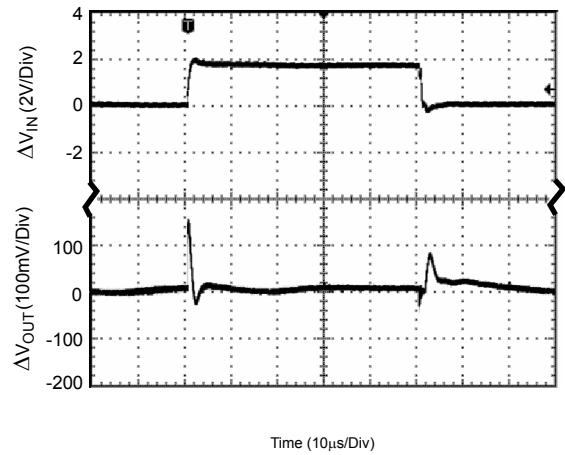


Figure 15. Line Transient

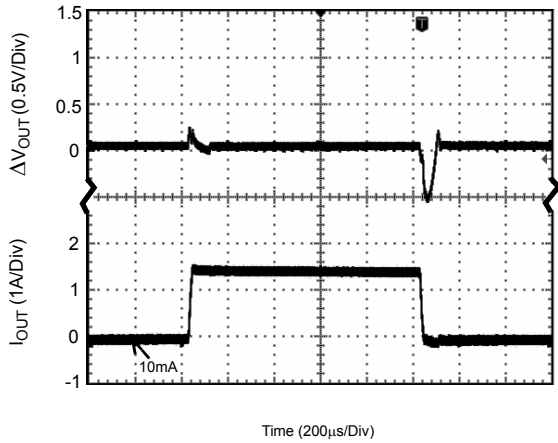


Figure 16. Load Transient

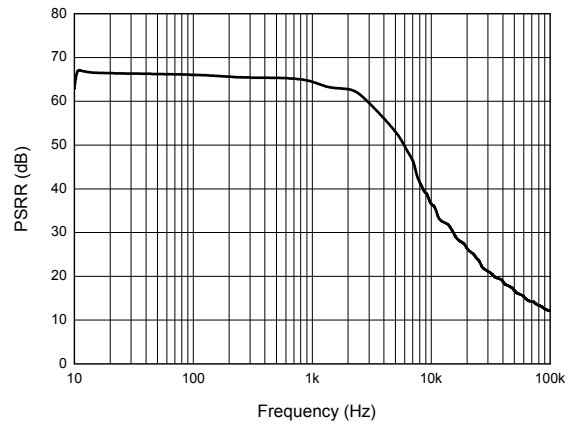


Figure 17. PSRR vs. Frequency

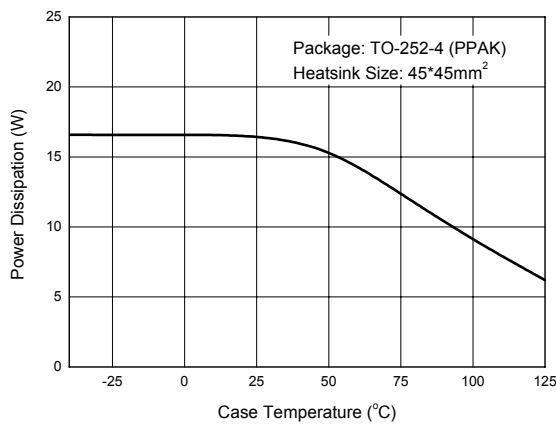
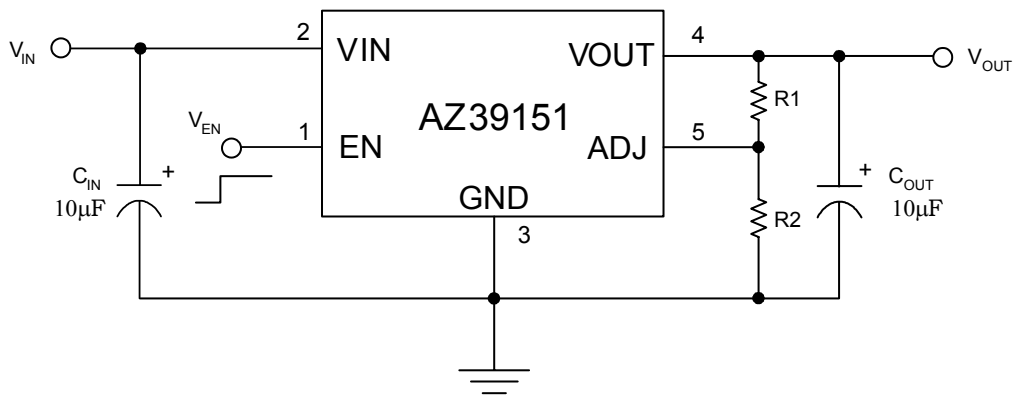
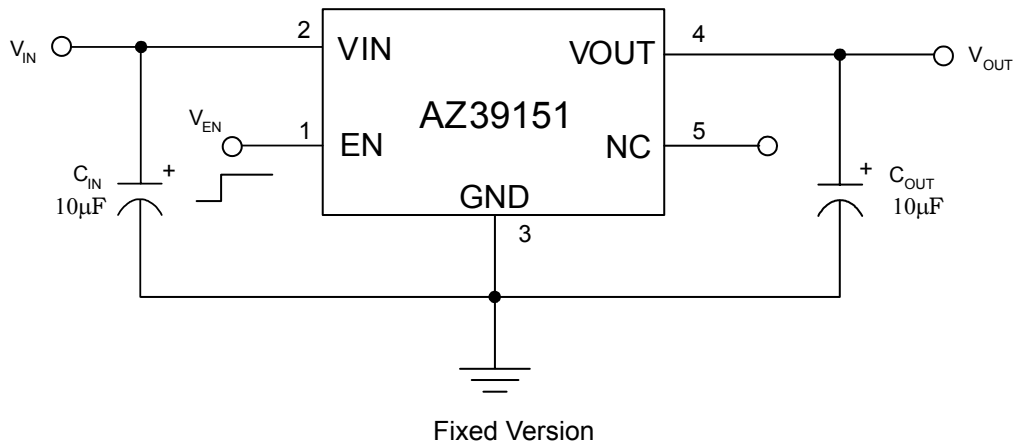


Figure 18. Power Dissipation vs. Case Temperature

Figure 19. Typical Application of AZ39151

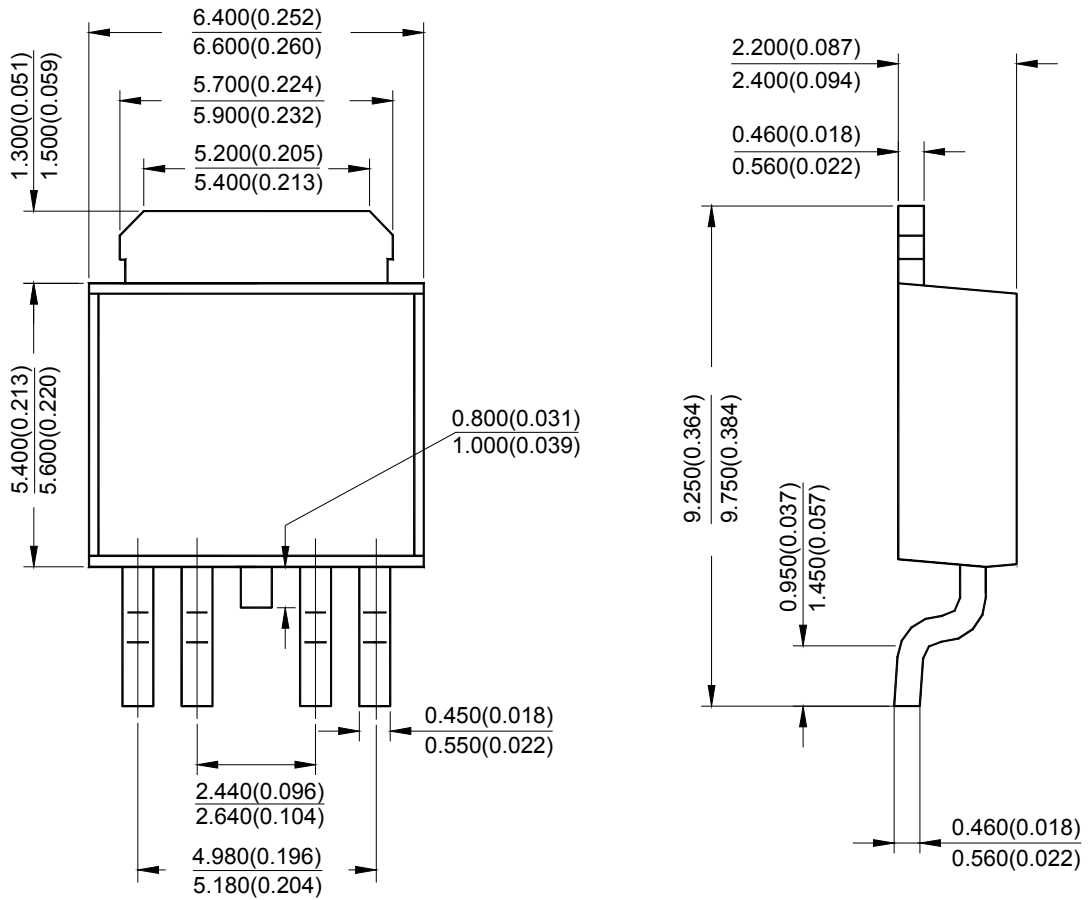

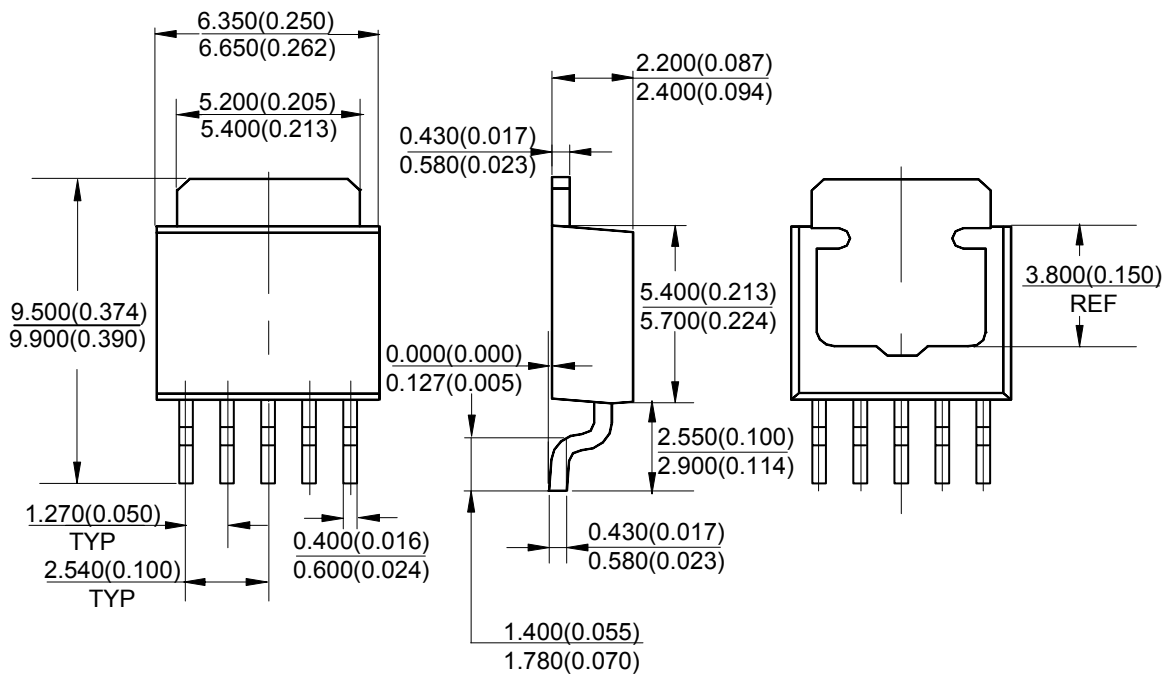
