The NC7WZ17 is a dual buffer with Schmitt trigger inputs from Fairchild's Ultra-High Speed (UHS) series of TinyLogic® products. The device is fabricated with advanced CMOS technology to achieve ultra-high speed with high output drive, while maintaining low static power dissipation over a very broad $V_{\rm CC}$ operating range. 



Figure 1. Logic Symbol







Figure 5. AC Test Circuit




Figure 8. 6-Lead, SC70, EIAJ SC-88a, 1.25mm Wide






Figure 10. 6-Lead, MicroPak2, 1x1mm Body, .35mm Pitch
