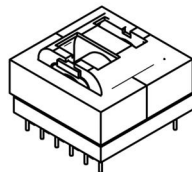

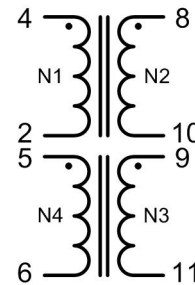


**B Recommended land pattern: [mm]**
