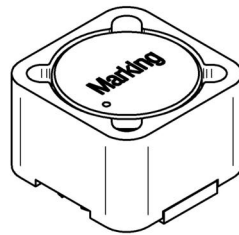

**F Typical Impedance Characteristics:**



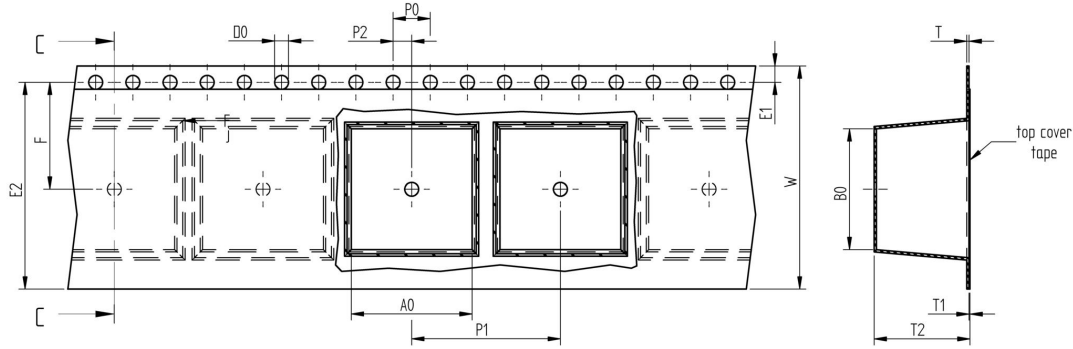
**F Derating Curve:**

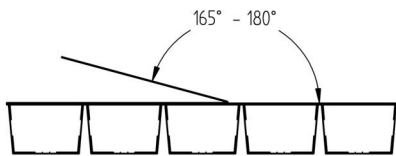
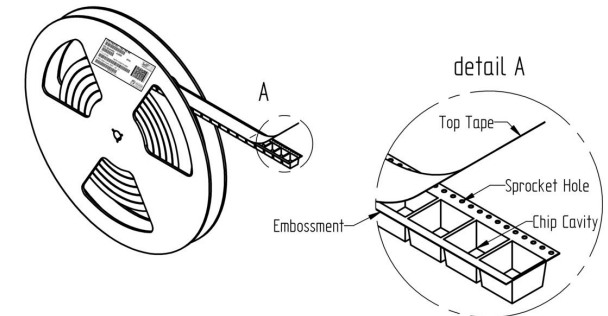
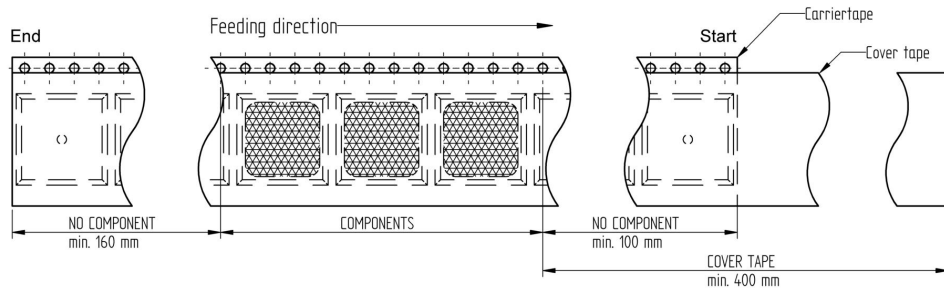
