



Fig. 1. Continuous drain current as a function of mounting base temperature

Fig. 2. Normalized total power dissipation as a function of mounting base temperature




Fig. 3. Single-pulse and repetitive avalanche rating; avalanche current as a function of avalanche time




Fig 4. Safe operating area; continuous and peak drain currents as a function of drain-source voltage.





Fig 5. Transient thermal impedance from junction to mounting base as a function of pulse duration.





Fig 6. Output characteristics: drain current as a function of drain-source voltage; typical values.





Fig 7. Drain-source on-state resistance as a function of drain current; typical values.





Fig 8. Transfer characteristics: drain current as a function of gate-source voltage; typical values.





Fig 9. Forward transconductance as a function of drain current; typical values.





Fig 10. Gate-source threshold voltage as a function of junction temperature





Fig 11. Sub-threshold drain current as a function of gate-source voltage





Fig 12. Normalized drain-source on-state resistance factor as a function of junction temperature





Fig 13. Drain-source on-state resistance as a function of gate-source voltage; typical values.








Fig 17. Package outline SOT669 (LFPAK)
