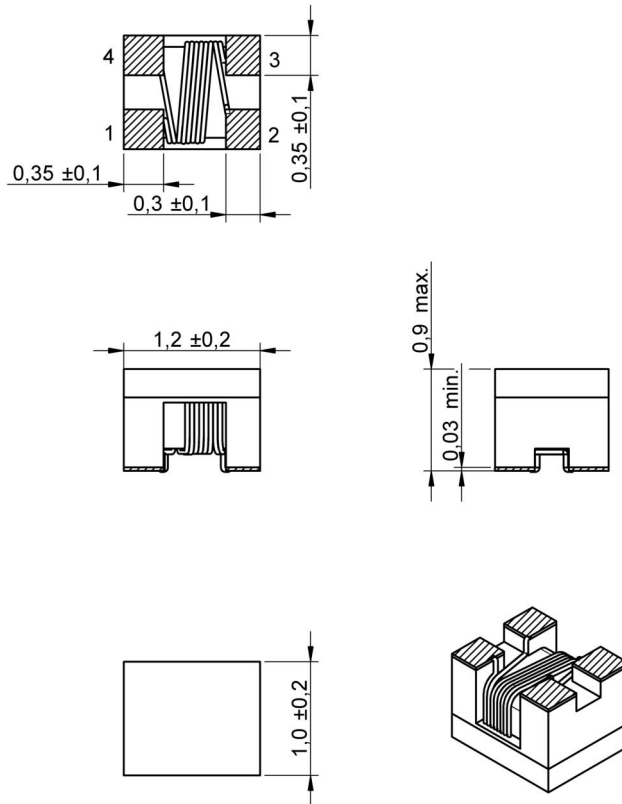

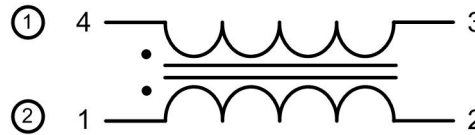

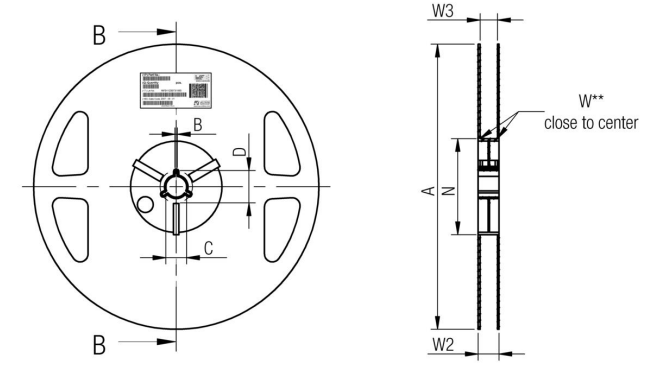
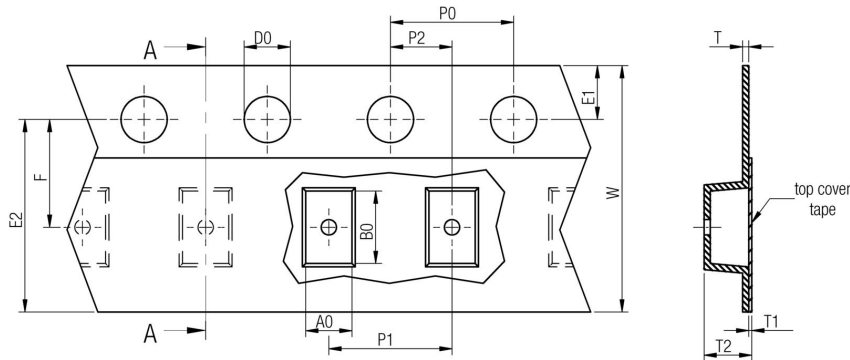
F2 Typical Common Mode Insertion Loss Characteristics:
