Soldering:




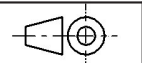
