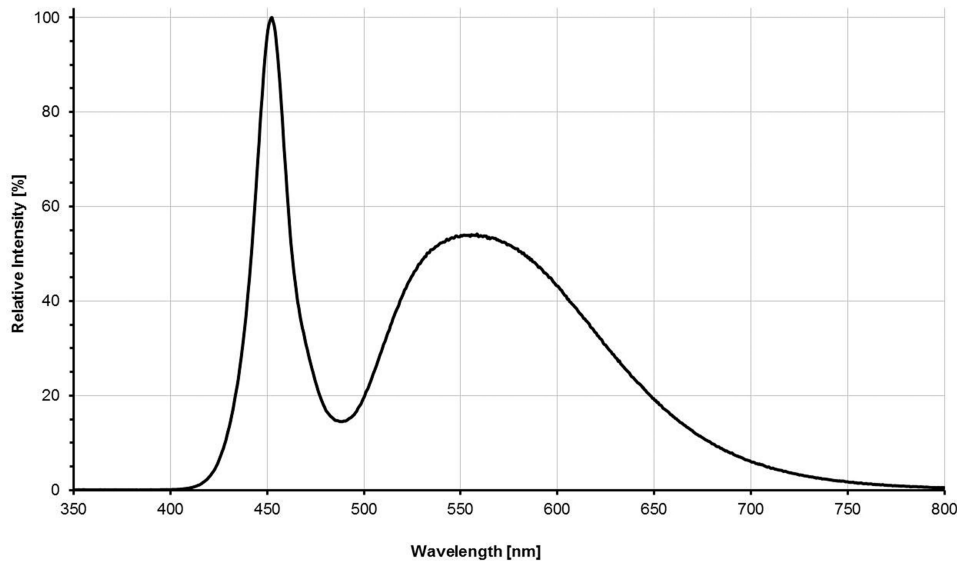

**F3 Forward Current vs. Forward Voltage:**

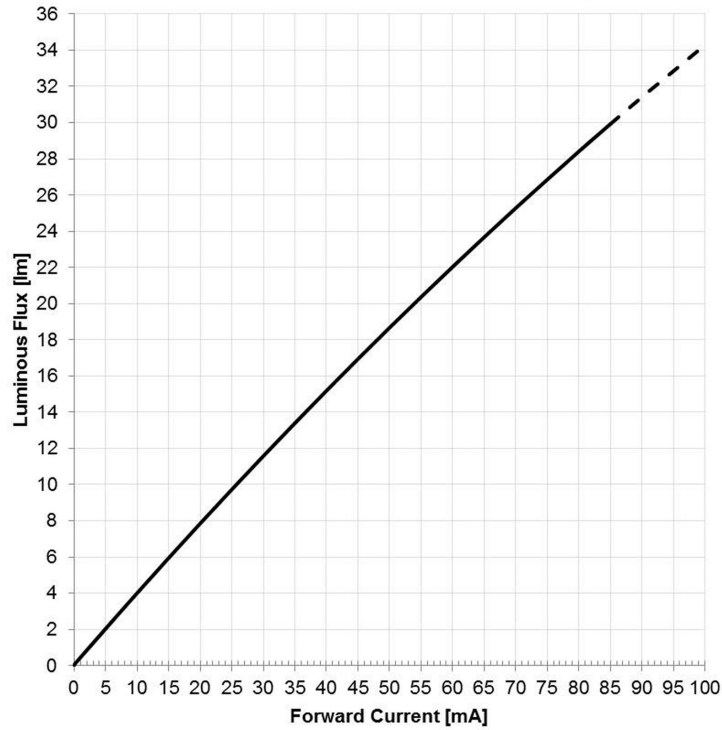

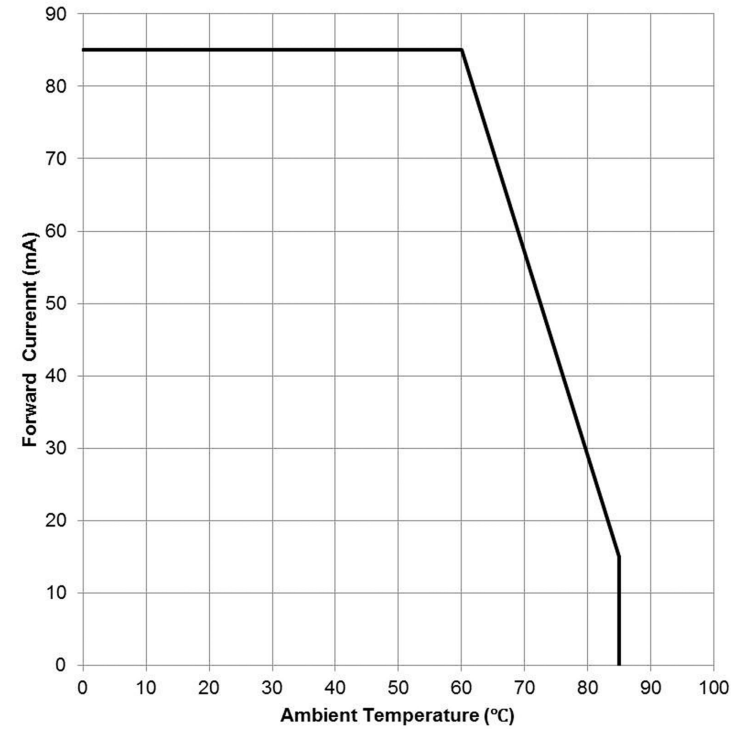

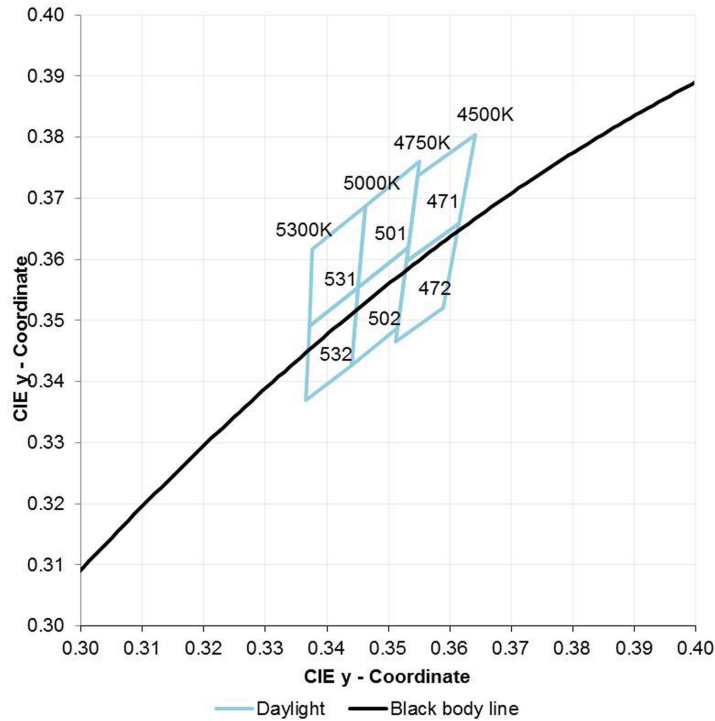

F6 Chromaticity diagram:



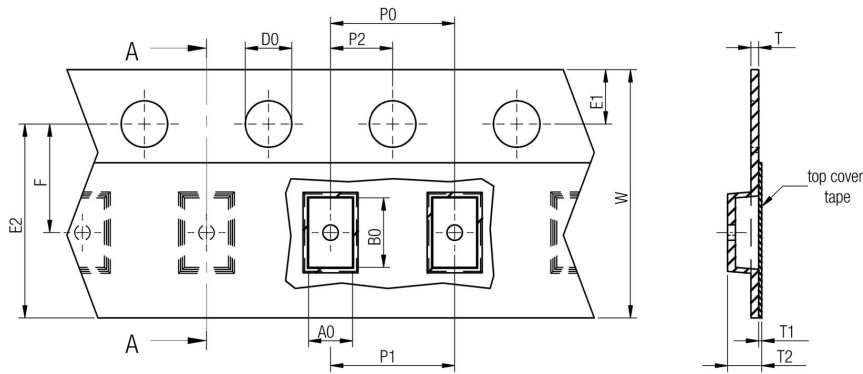
