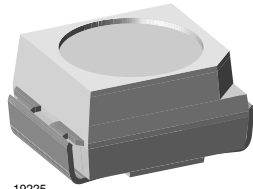

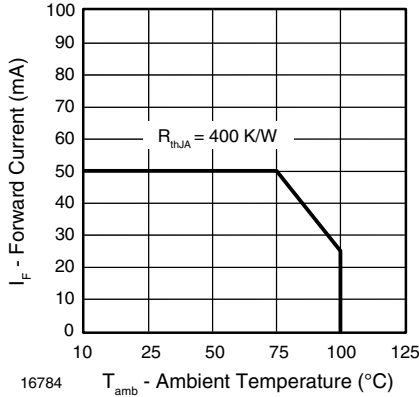


Figure 1. Forward Current vs. Ambient Temperature

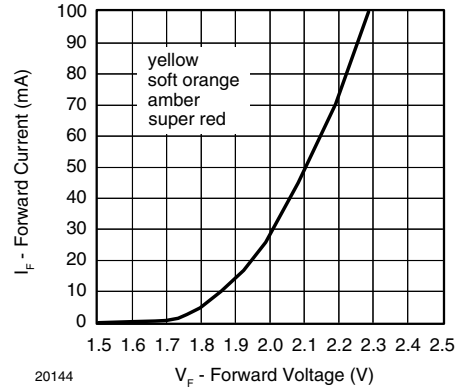


Figure 4. Forward Current vs. Forward Voltage

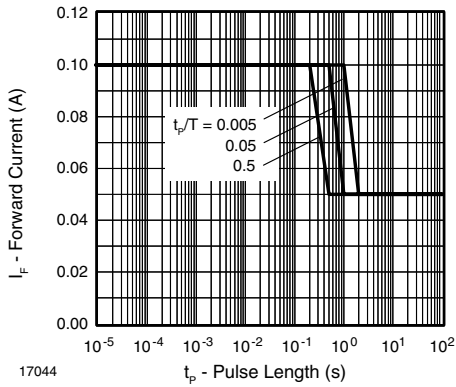


Figure 2. Forward Current vs. Pulse Length

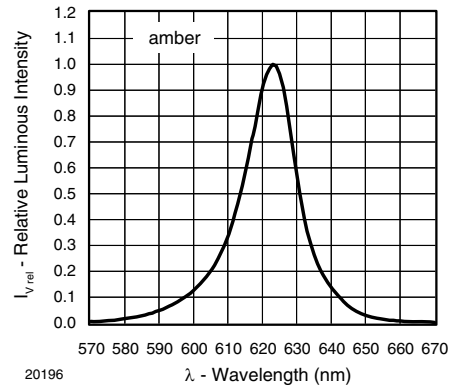


Figure 5. Relative Intensity vs. Wavelength

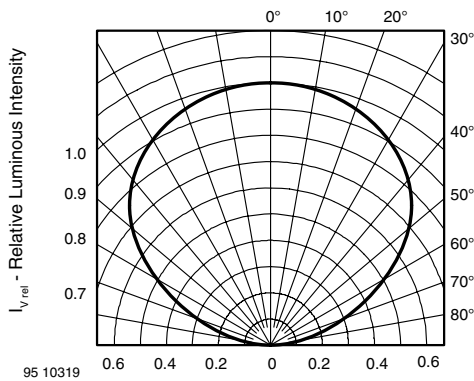


Figure 3. Rel. Luminous Intensity vs. Angular Displacement

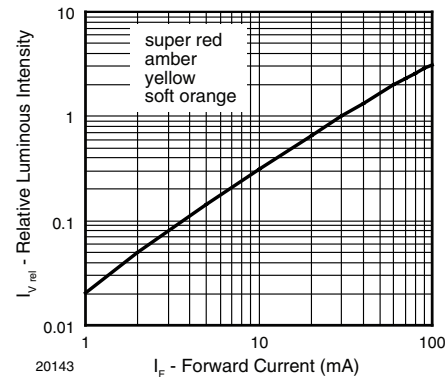


Figure 6. Relative Luminous Intensity vs. Forward Current

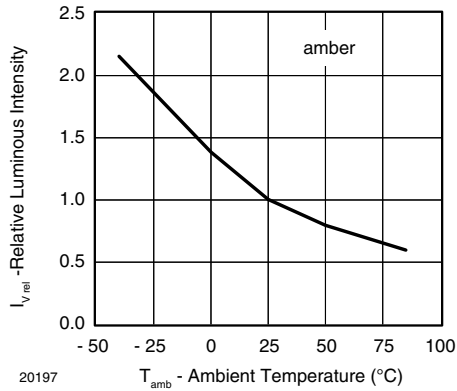


Figure 7. Relative Luminous Intensity vs. Amb. Temperature

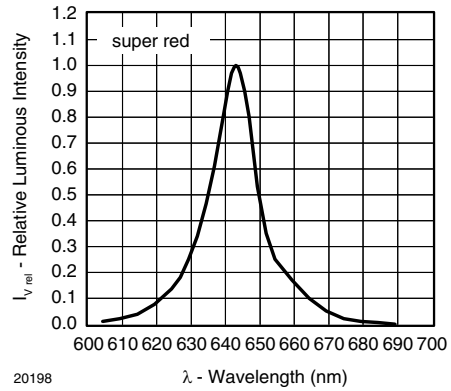


Figure 10. Relative Intensity vs. Wavelength

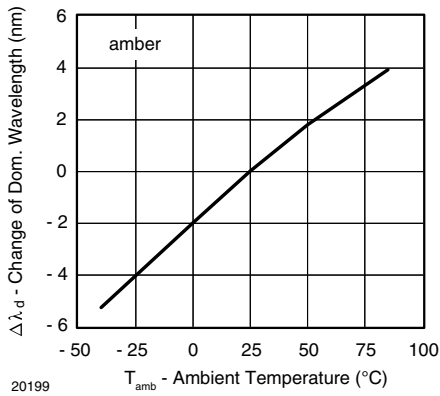


Figure 8. Change of Dominant Wavelength vs. Ambient Temperature

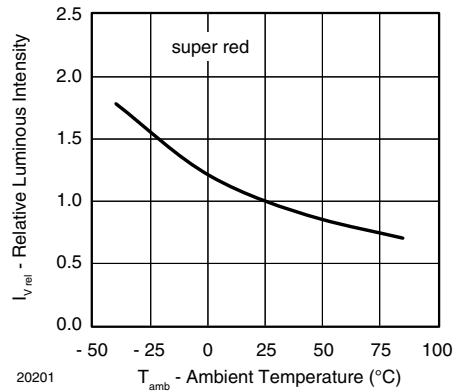


Figure 11. Relative Luminous Intensity vs. Amb. Temperature

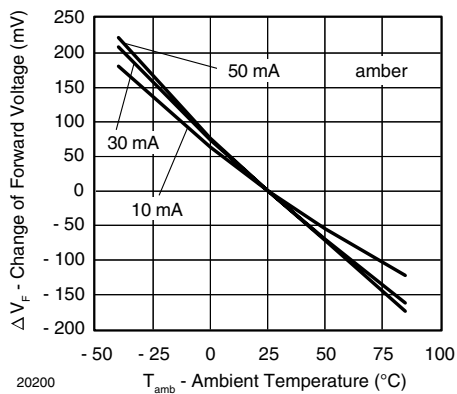


Figure 9. Change of Forward Voltage vs. Ambient Temperature

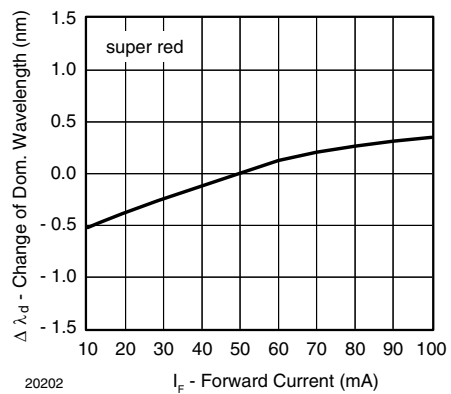
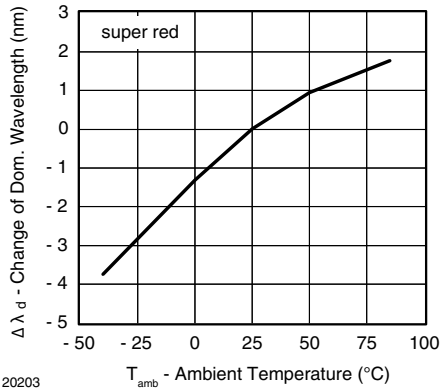
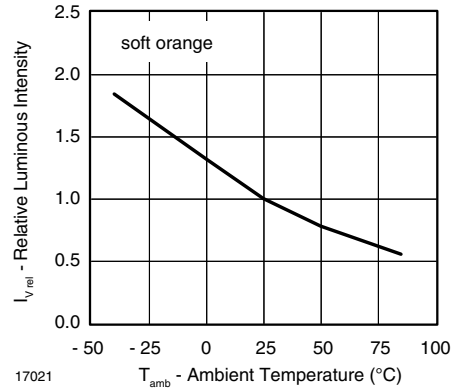


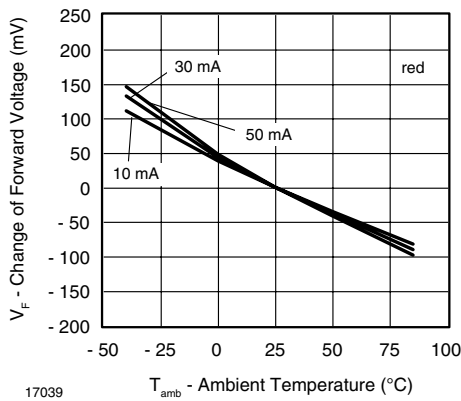
Figure 12. Change of Dominant Wavelength vs. Forward Current



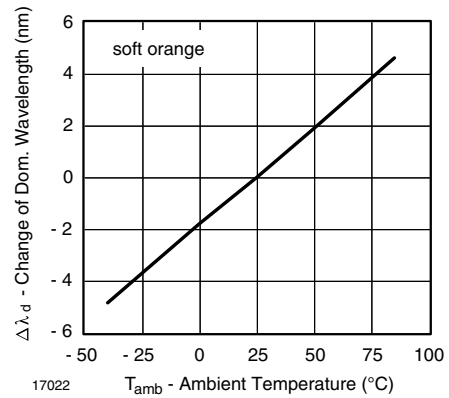

Figure 13. Change of Dominant Wavelength vs. Ambient Temperature



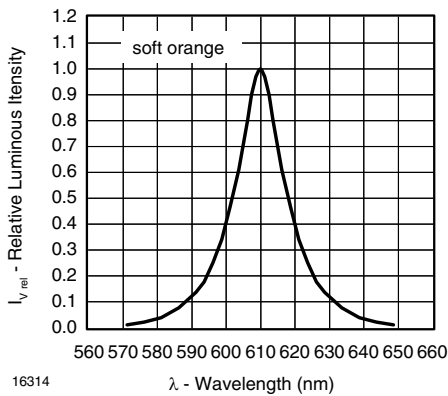

Figure 16. Relative Luminous Intensity vs. Amb. Temperature



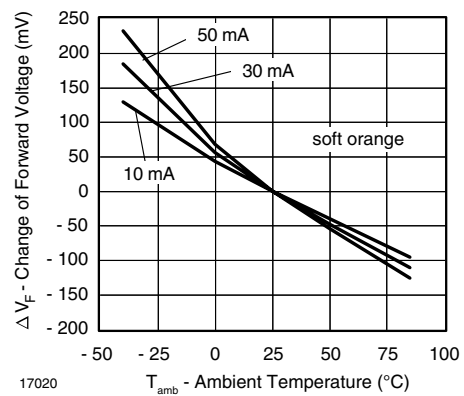

Figure 18. Change of Forward Voltage vs. Ambient Temperature

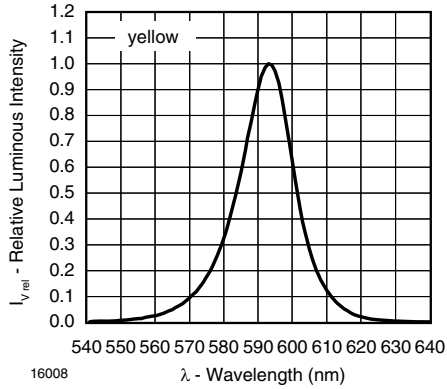


Figure 19. Relative Intensity vs. Wavelength

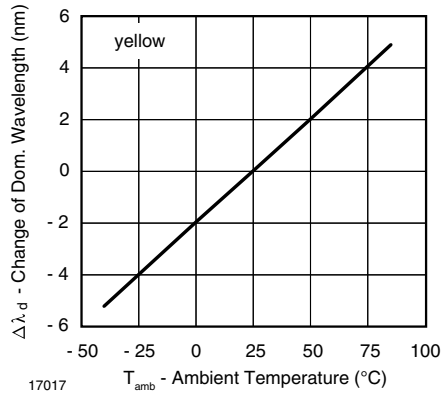


Figure 21. Change of Dominant Wavelength vs. Ambient Temperature

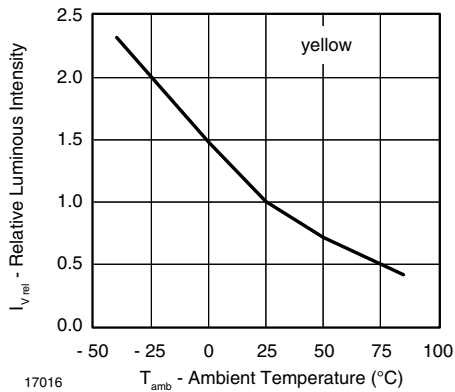


Figure 20. Relative Luminous Intensity vs. Amb. Temperature

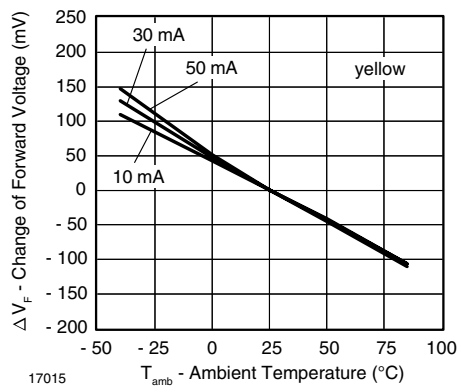
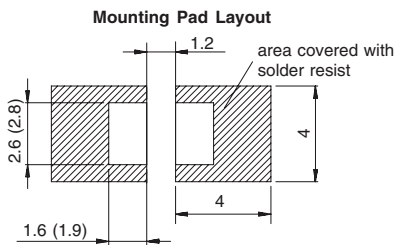
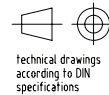
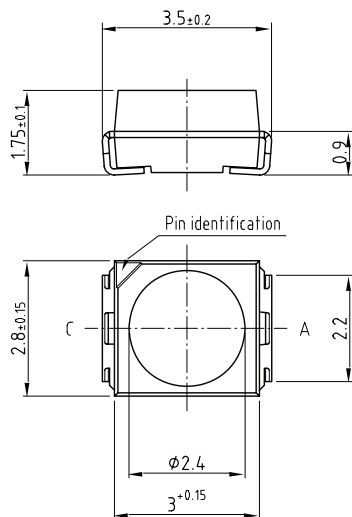


Figure 22. Change of Forward Voltage vs. Ambient Temperature

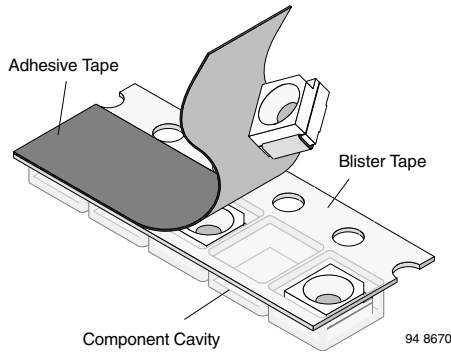

**METHOD OF TAPING/POLARITY AND TAPE AND REEL**

**SMD LED (VLM3 - SERIES)**

Vishay's LEDs in SMD packages are available in an antistatic 8 mm blister tape (in accordance with DIN IEC 40 (CO) 564) for automatic component insertion. The blister tape is a plastic strip with impressed component cavities, covered by a top tape.



**REEL PACKAGE DIMENSION IN MM FOR SMD LEDS, TAPE OPTION GS08 (= 1500 PCS.)**

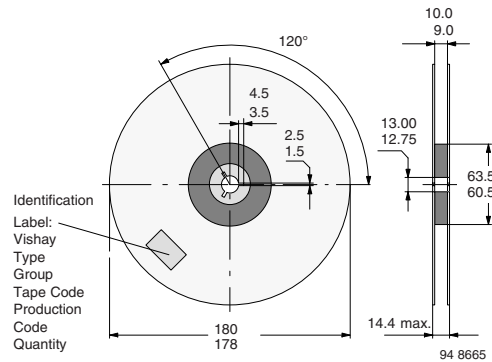


Figure 24. Reel dimensions - GS08

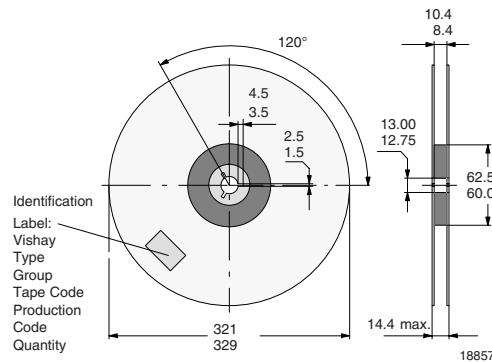


Figure 25. Reel dimensions - GS18

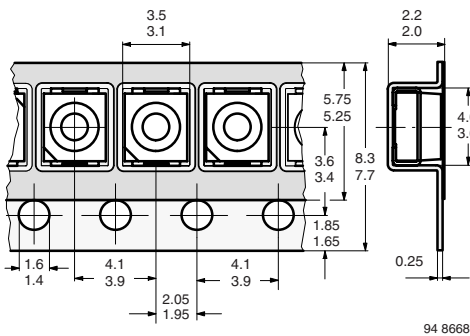


Figure 23. Tape dimensions in mm for PLCC-2

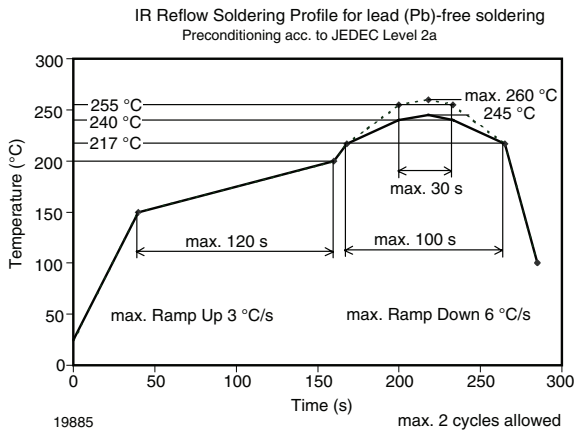


Figure 26. Vishay Lead (Pb)-free Reflow Soldering Profile (acc. to J-STD-020C)

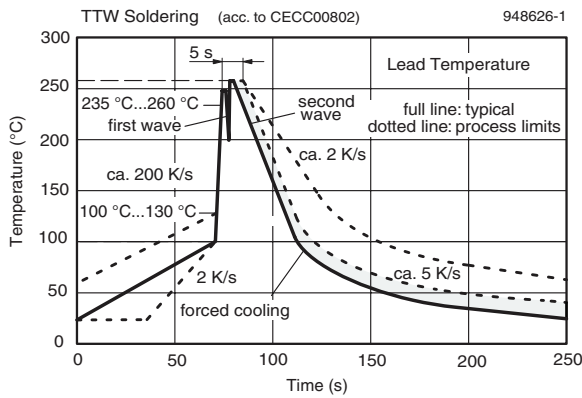
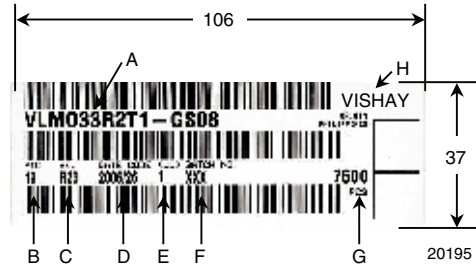


Figure 27. Double wave soldering of opto devices (all packages)

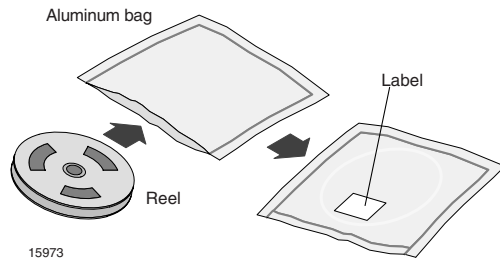

### DRY PACKING

The reel is packed in an anti-humidity bag to protect the devices from absorbing moisture during transportation and storage.



### FINAL PACKING

The sealed reel is packed into a cardboard box. A secondary cardboard box is used for shipping purposes.

### RECOMMENDED METHOD OF STORAGE

Dry box storage is recommended as soon as the aluminum bag has been opened to prevent moisture absorption. The following conditions should be observed, if dry boxes are not available:

- Storage temperature 10 °C to 30 °C
- Storage humidity  $\leq 60\%$  RH max.

After more than 672 hours under these conditions moisture content will be too high for reflow soldering.

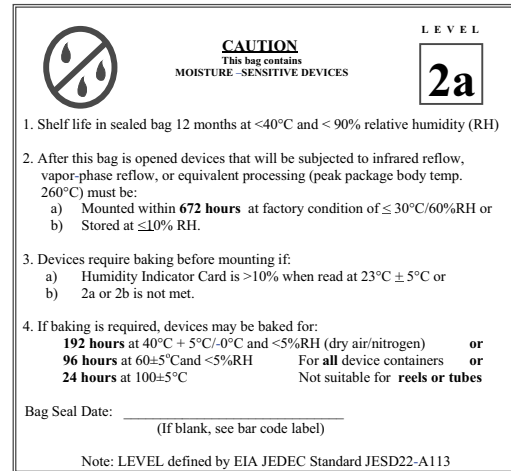
In case of moisture absorption, the devices will recover to the former condition by drying under the following condition:

192 hours at 40 °C + 5 °C/- 0 °C and < 5 % RH (dry air/nitrogen) or

96 hours at 60 °C + 5 °C and < 5 % RH for all device containers or

24 hours at 100 °C + 5 °C not suitable for reel or tubes.

An EIA JEDEC Standard JESD22-A112 Level 2a label is included on all dry bags.
