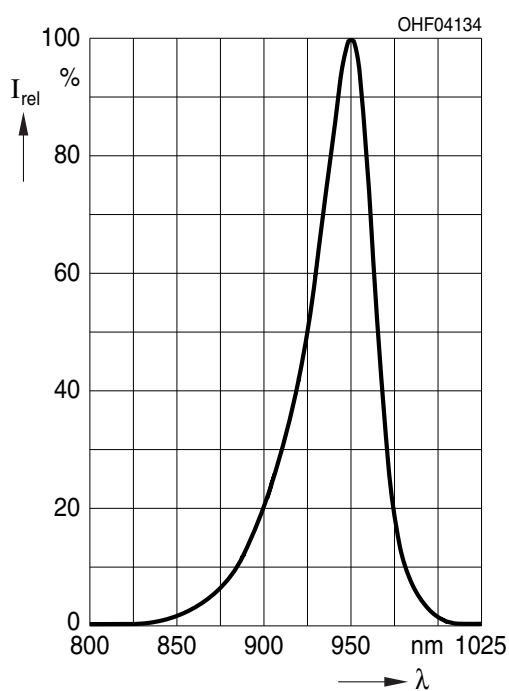

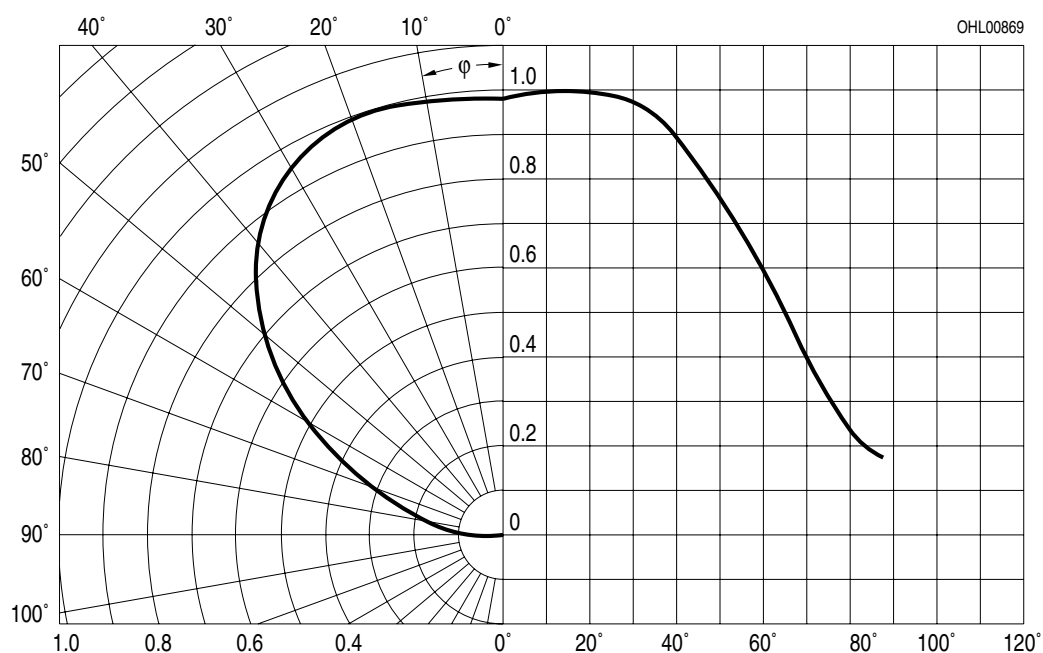

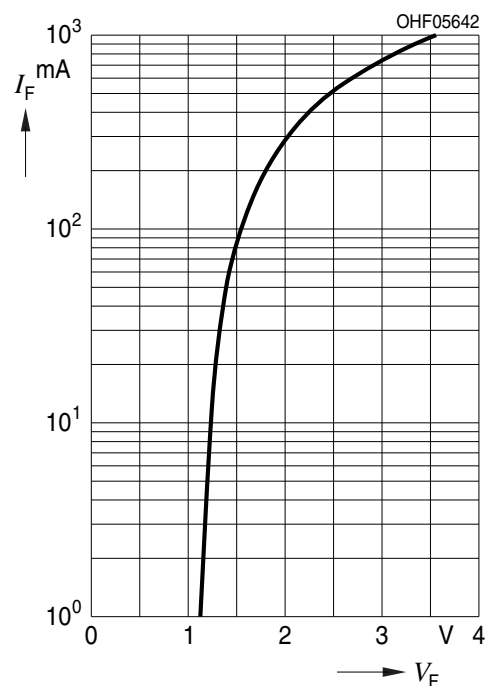

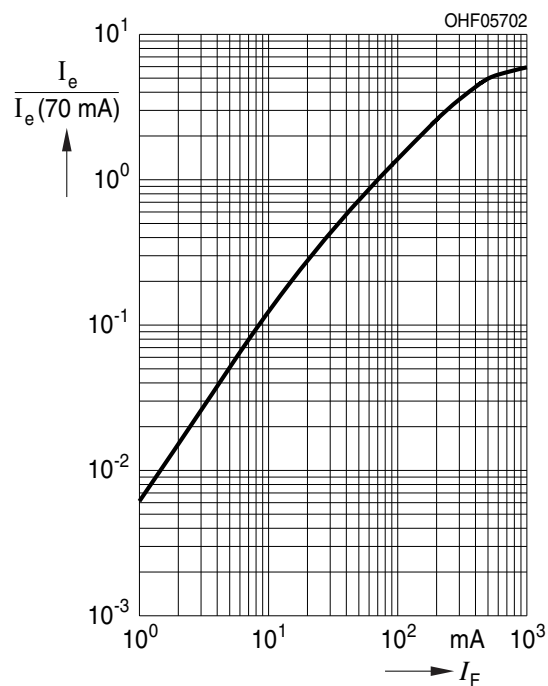

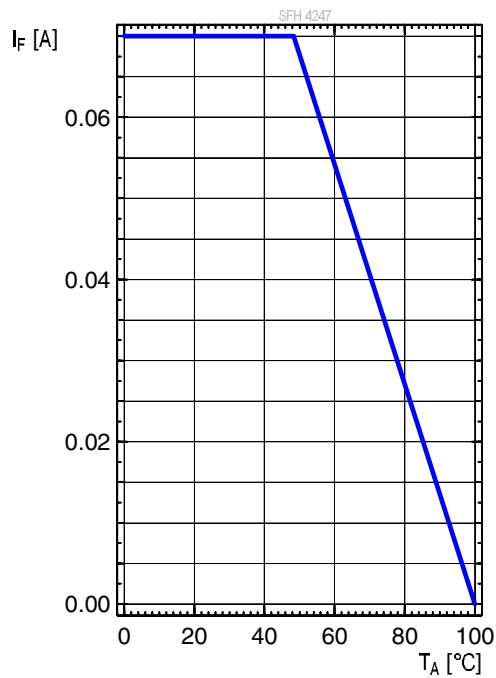

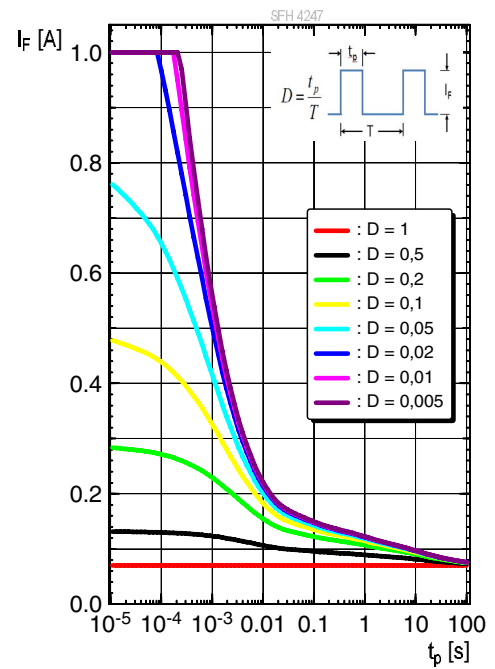

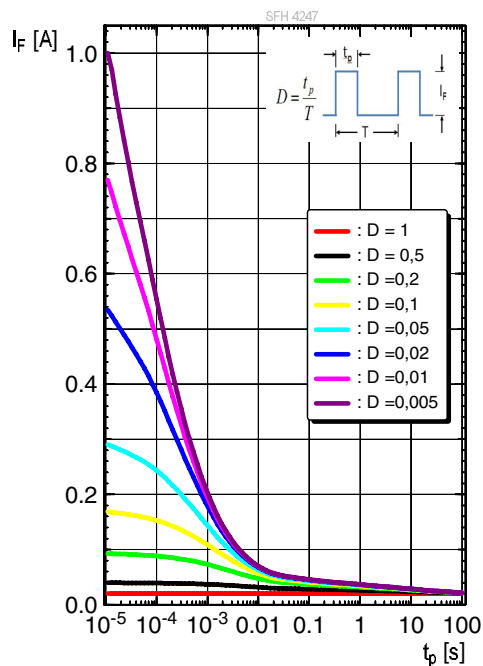

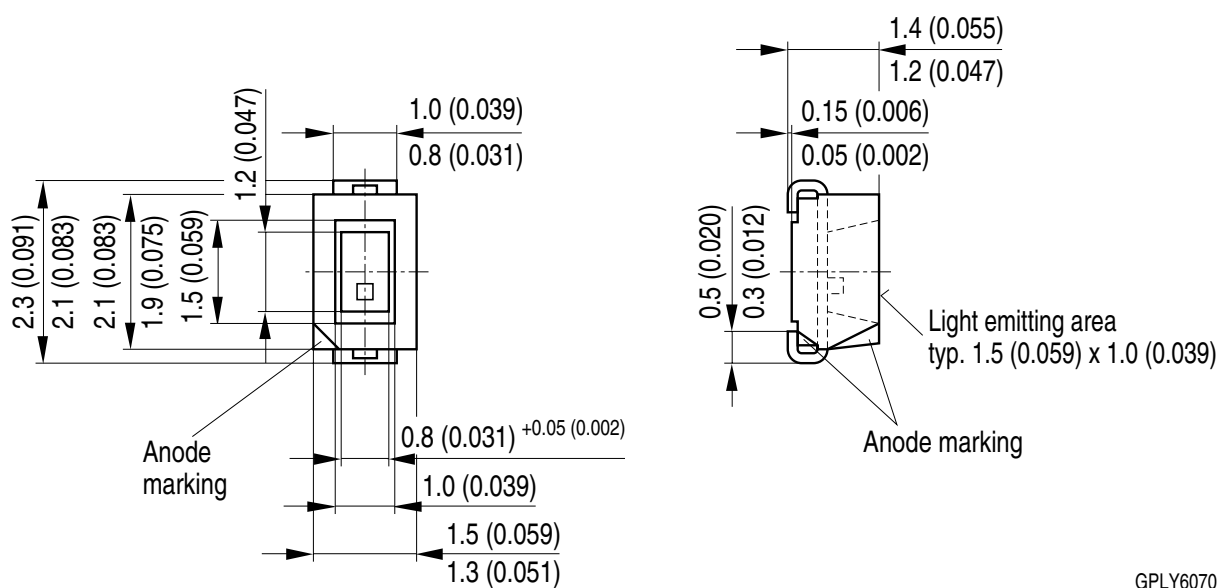


Permissible Pulse Handling Capability

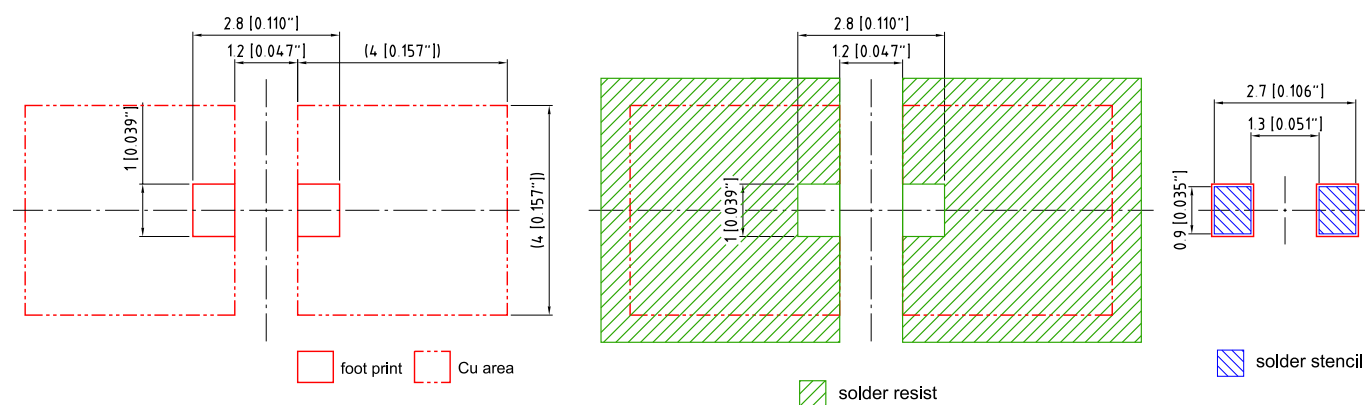

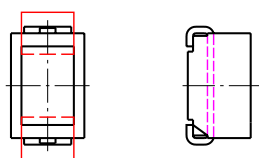

Recommended Solder Pad ⁸⁾



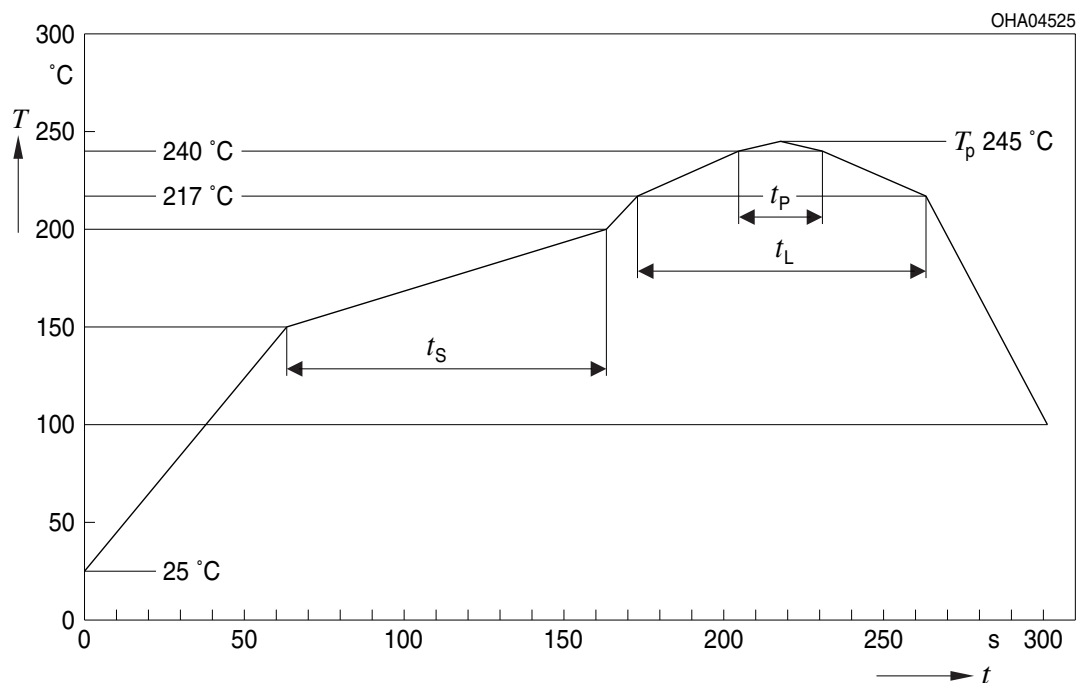
Component Location on Pad

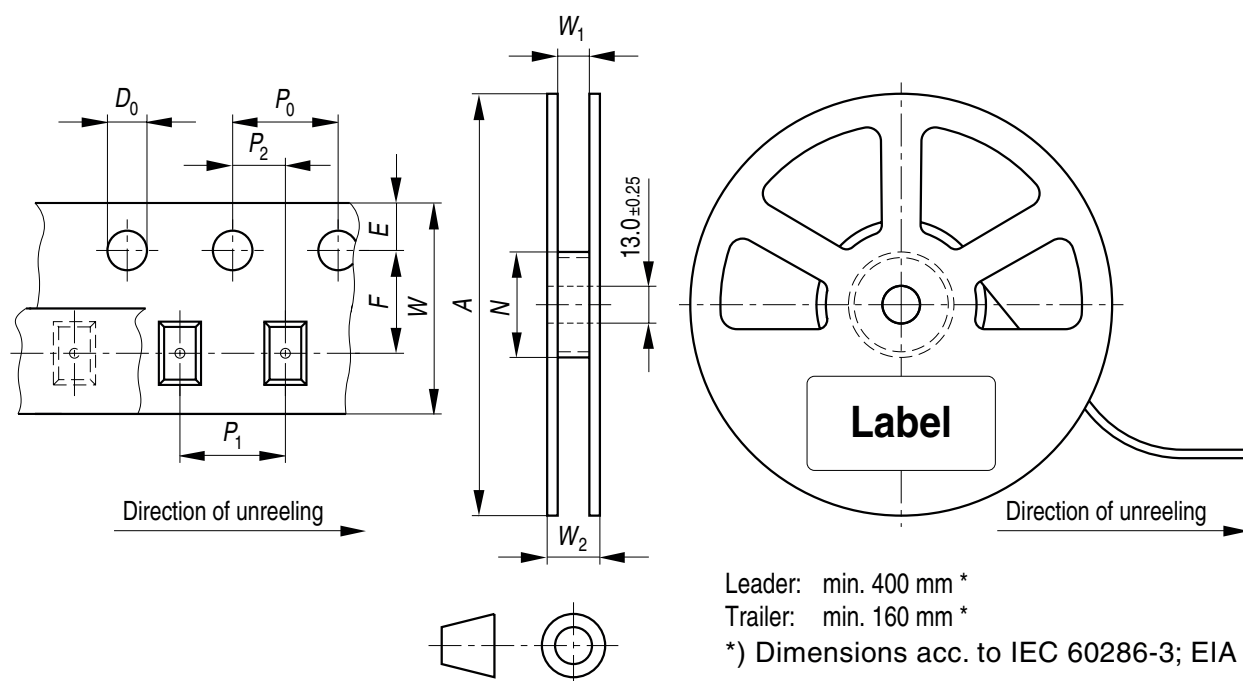

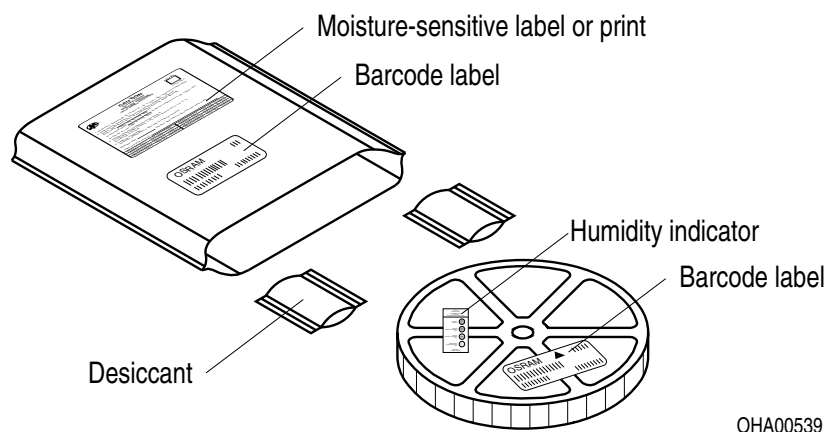

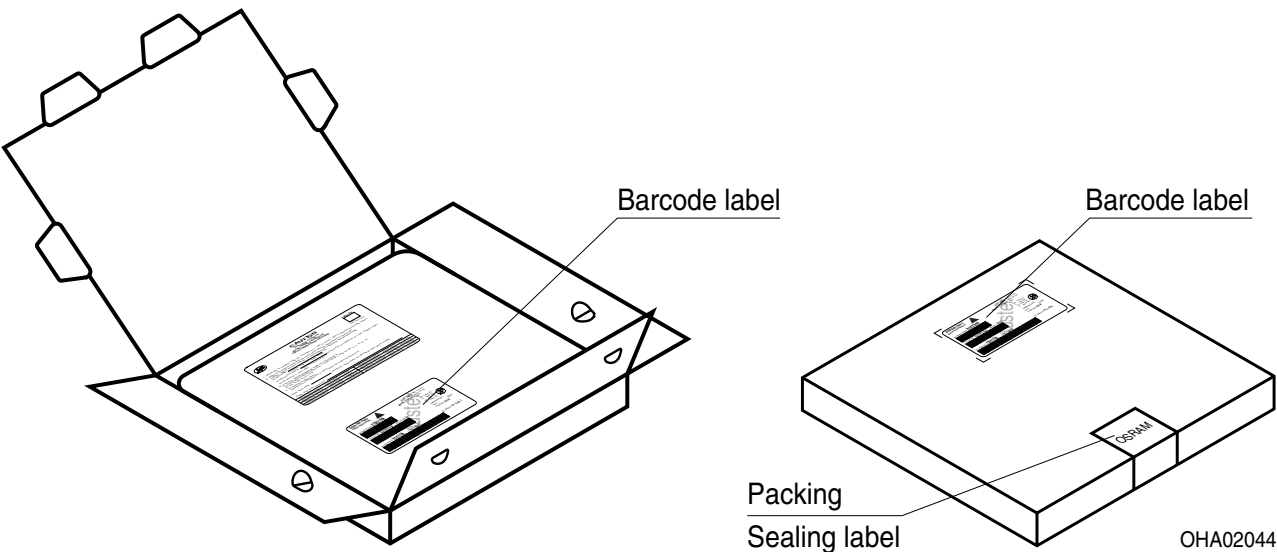


Dry Packing Process and Materials ⁸⁾
