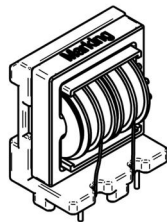

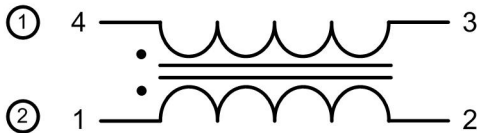

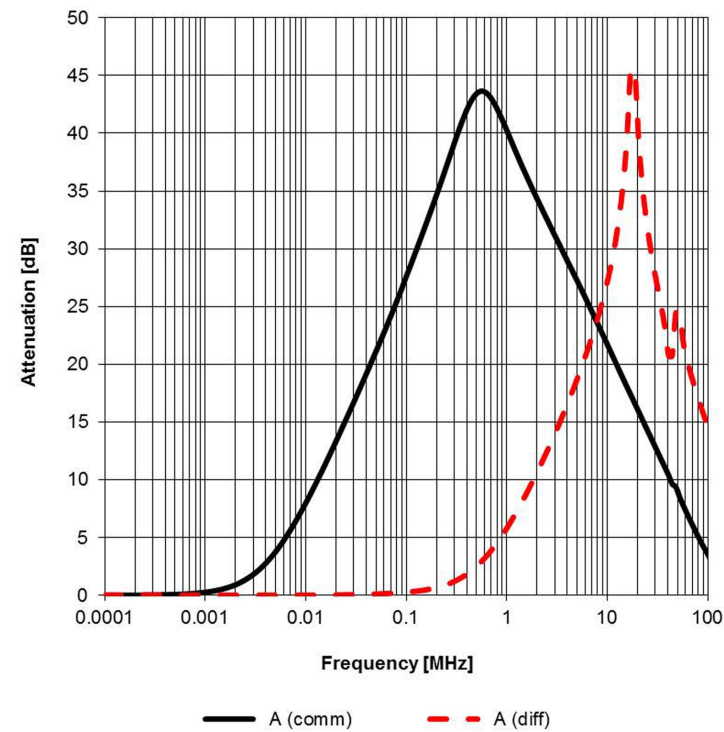

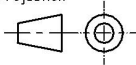

### Product specific:


