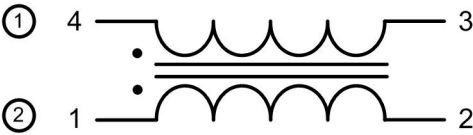

Differential Mode

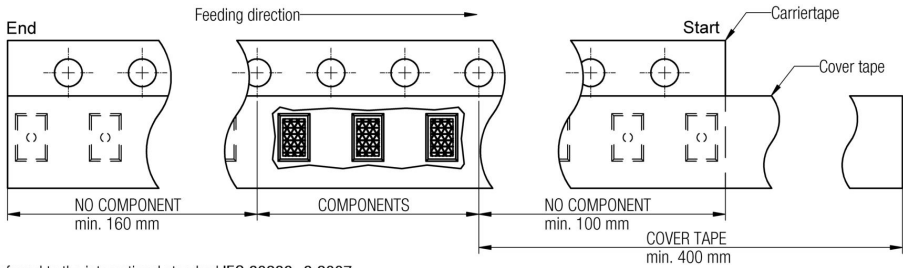
