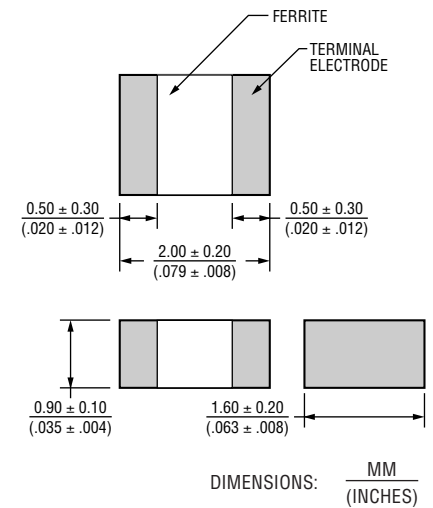

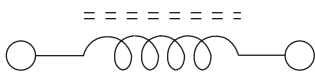

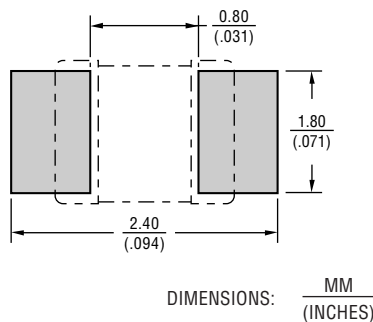

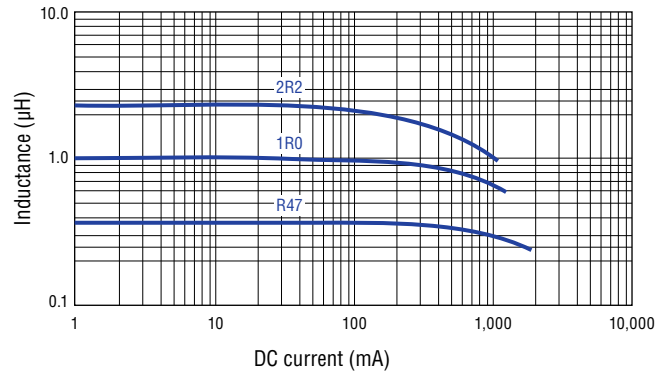

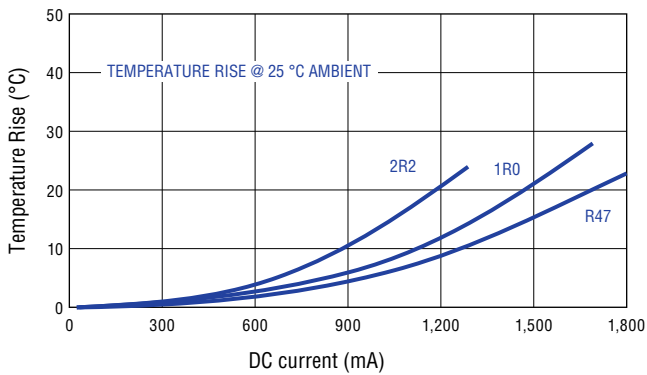
L vs. Frequency

Temperature Rise vs. IDC



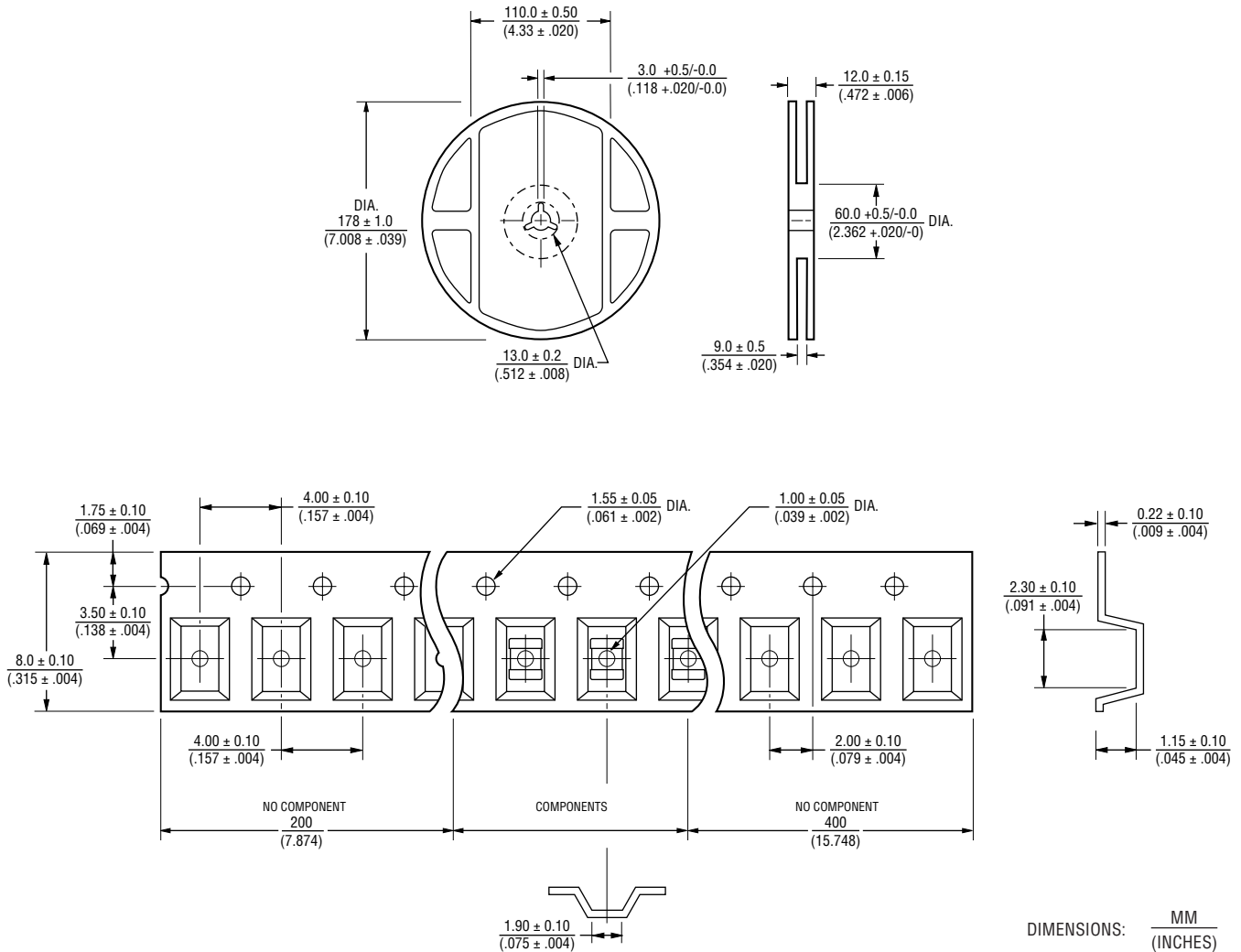
