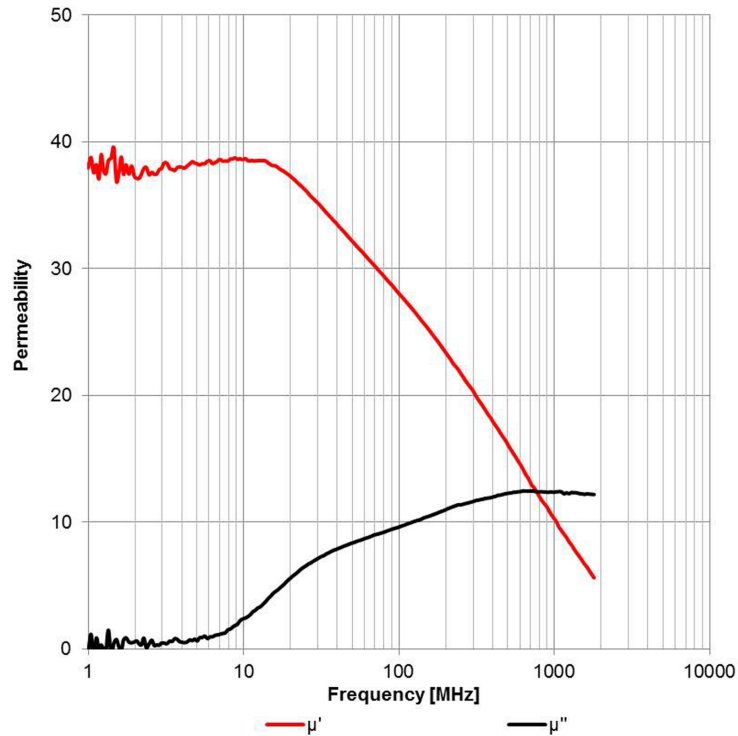



### Product specific:
