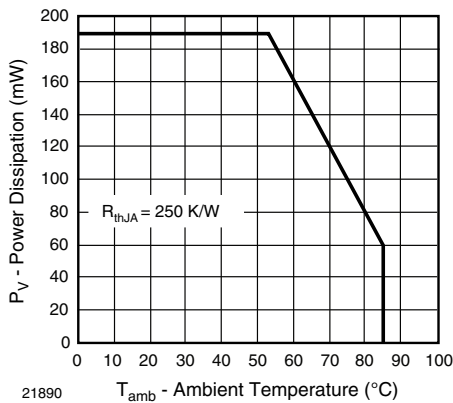


Fig. 1 - Power Dissipation Limit vs. Ambient Temperature

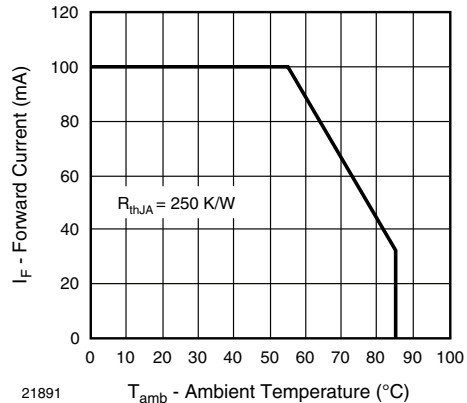
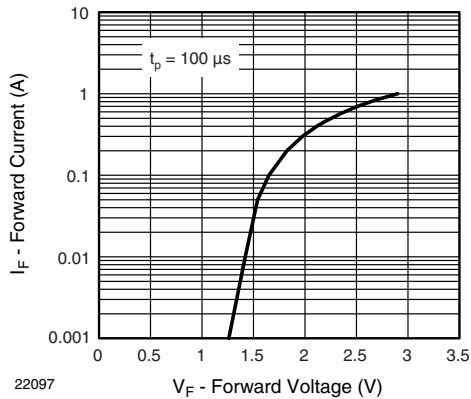


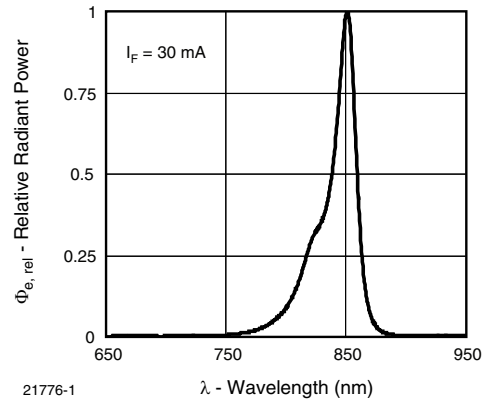
Fig. 2 - Forward Current Limit vs. Ambient Temperature

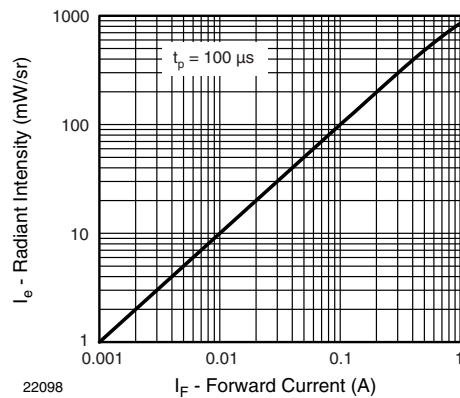

Fig. 3 - Forward Current vs. Forward Voltage



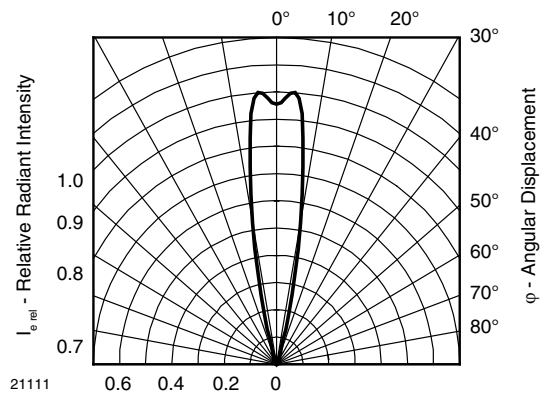

Fig. 5 - Relative Radiant Power vs. Wavelength



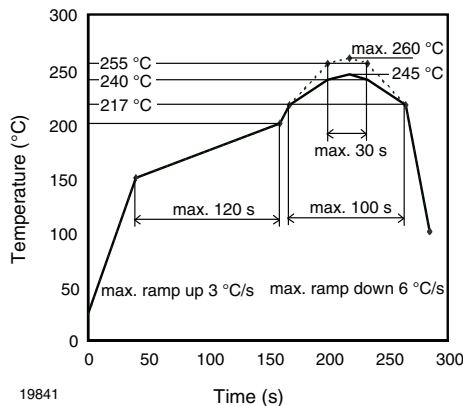

DRYPACK

Devices are packed in moisture barrier bags (MBB) to prevent the products from moisture absorption during transportation and storage. Each bag contains a desiccant.

FLOOR LIFE

Floor life (time between soldering and removing from MBB) must not exceed the time indicated on MBB label:

Floor life: 4 weeks

Conditions: $T_{amb} < 30\text{ }^{\circ}\text{C}$, RH < 60 %

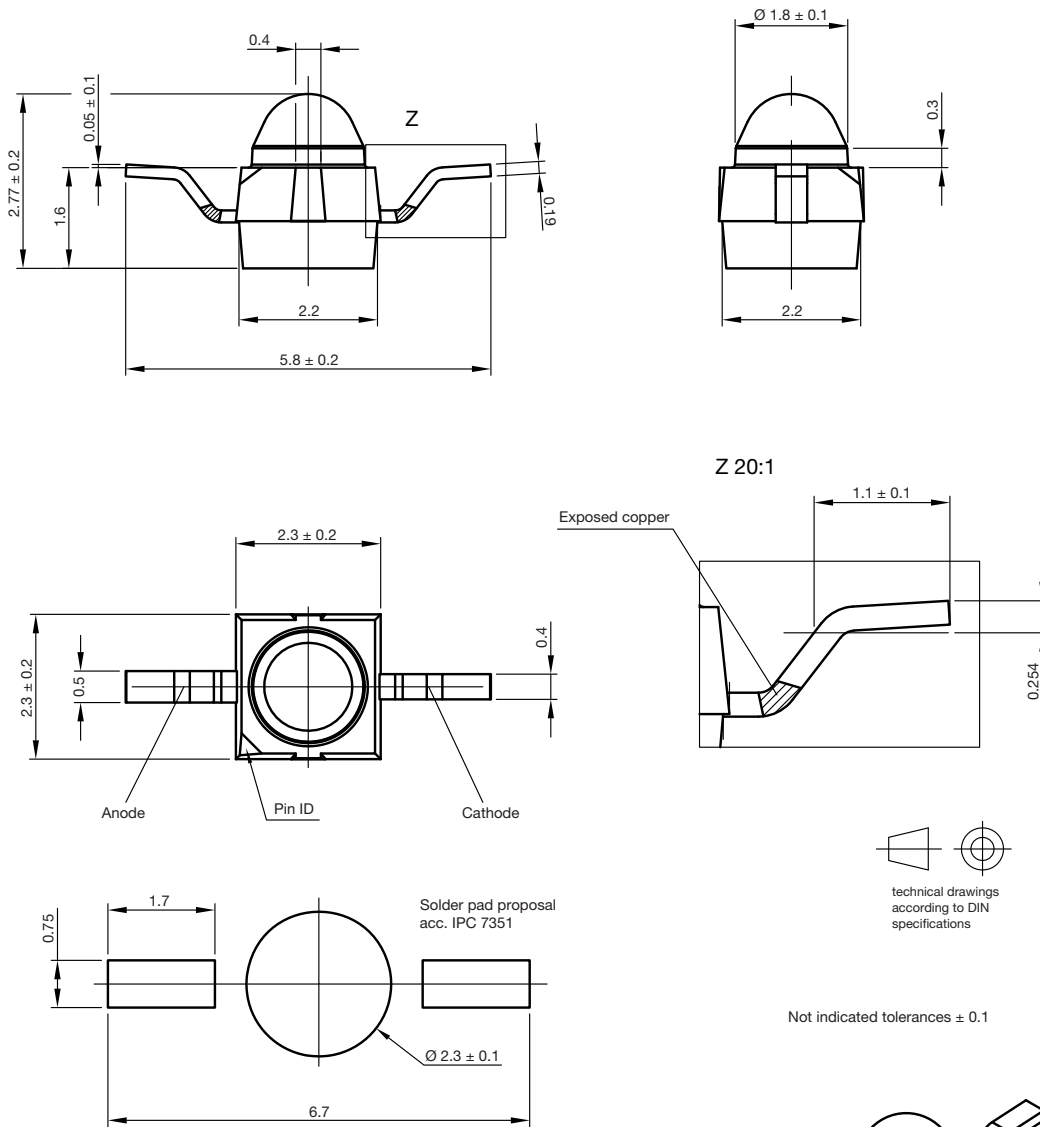

DRYING

In case of moisture absorption devices should be baked before soldering. Conditions see J-STD-020 or label. Devices taped on reel dry using recommended conditions 192 h at $40\text{ }^{\circ}\text{C}$ (+ 5 °C), RH < 5 %.

PACKAGE DIMENSIONS in millimeters: VSMY2850G



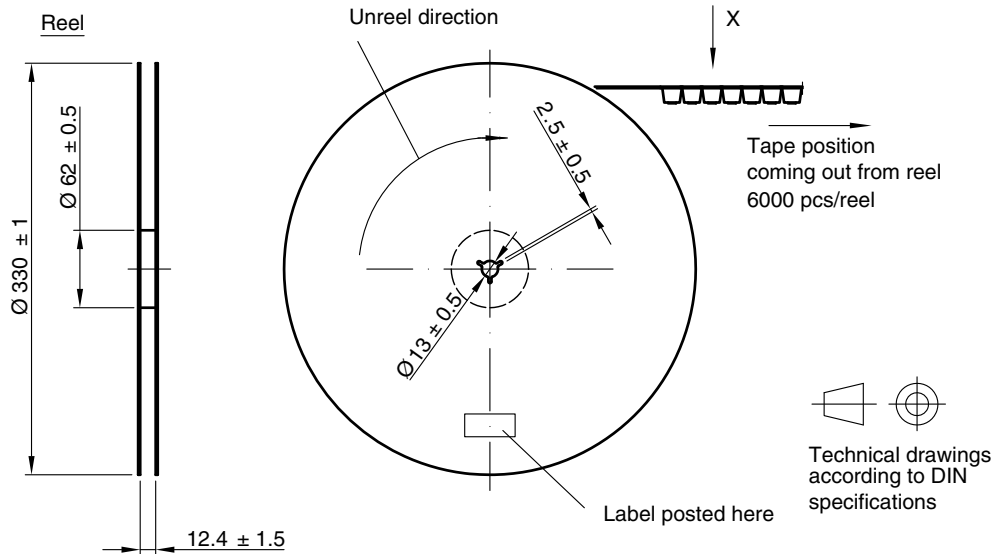
