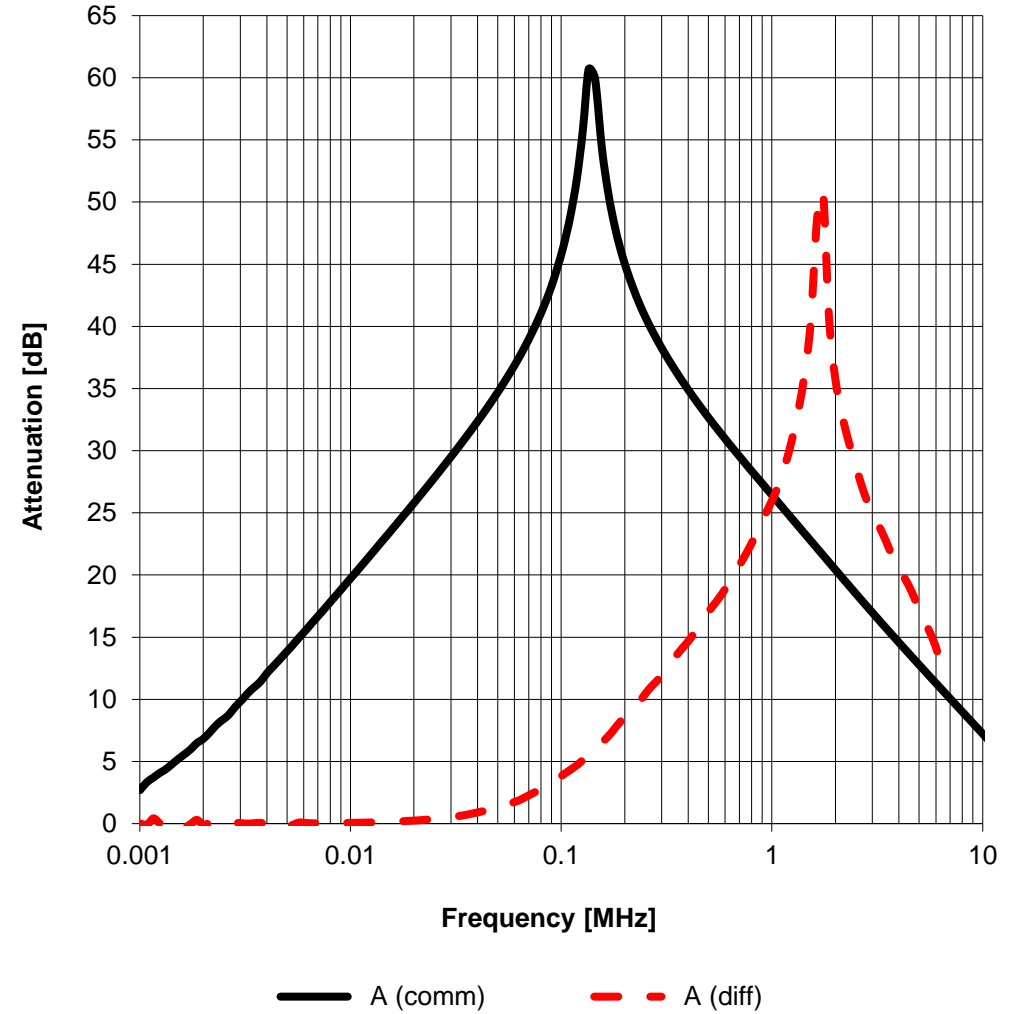
Common Mode


