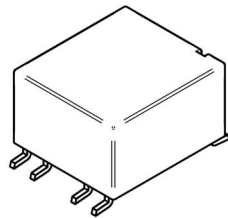

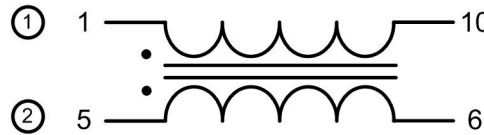

**F1 Typical Impedance Characteristics:**



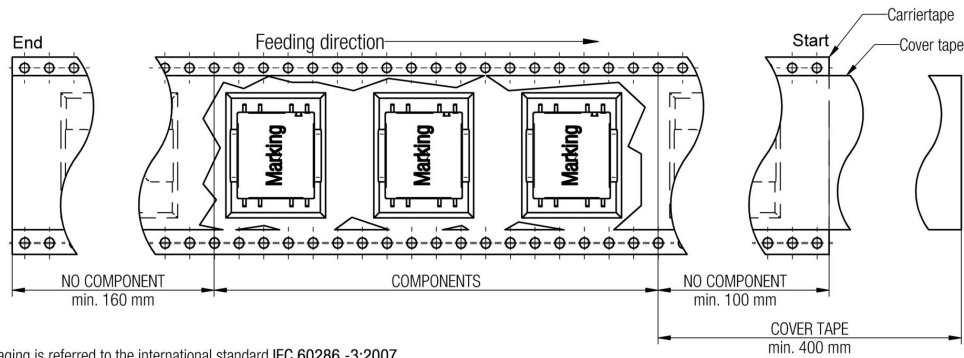
