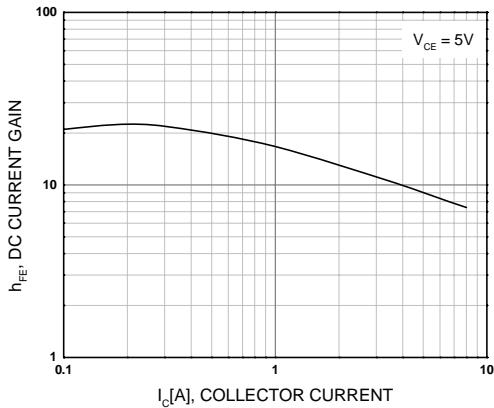

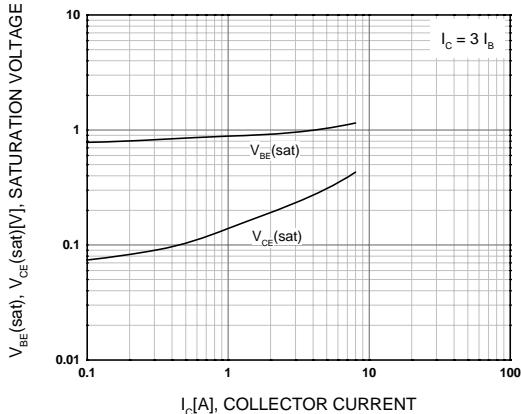

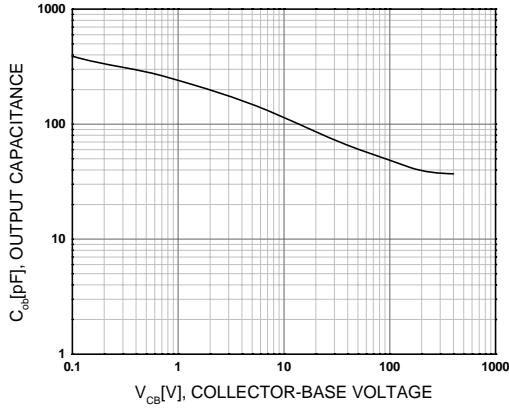
**Figure 1. DC Current Gain**



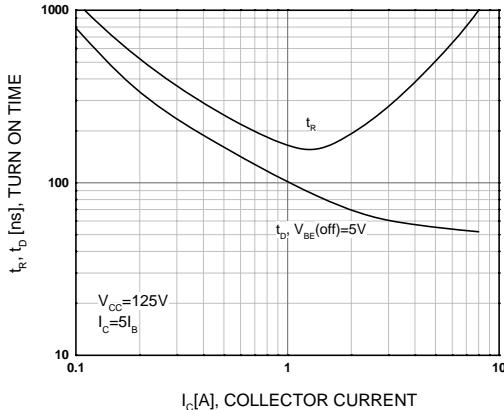
**Figure 2. Saturation Voltage**



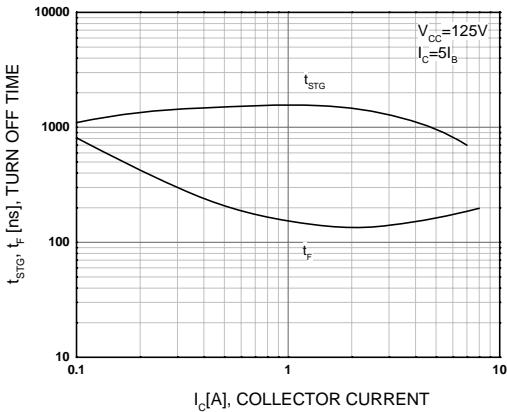
**Figure 3. Collector Output Capacitance**



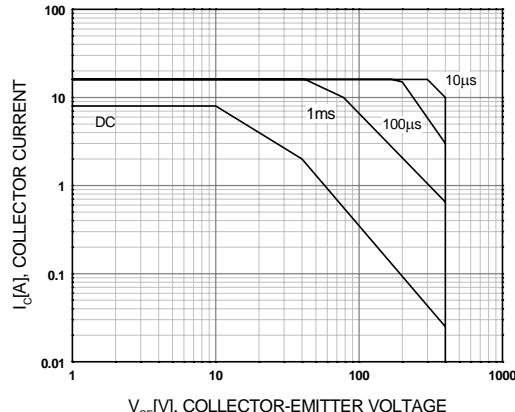
**Figure 4. Turn On Time**



**Figure 5. Turn Off Time**

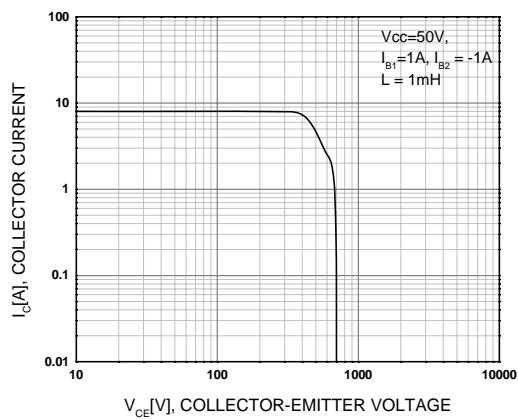


**Figure 6. Forward Biased Safe Operating Area**



**Figure 7. Reverse Biased Safe Operating Area**

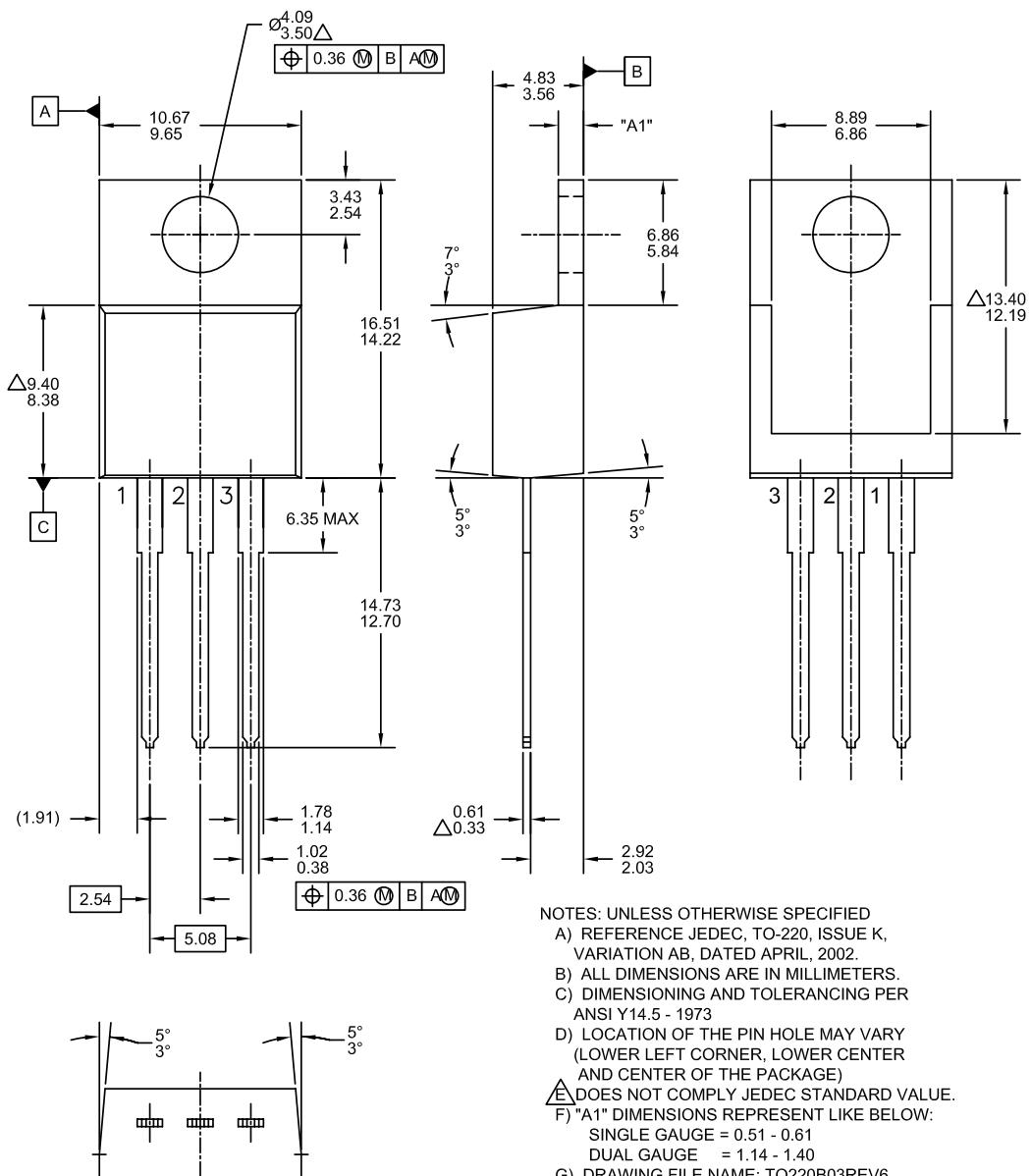


**Figure 8. Power Derating**
