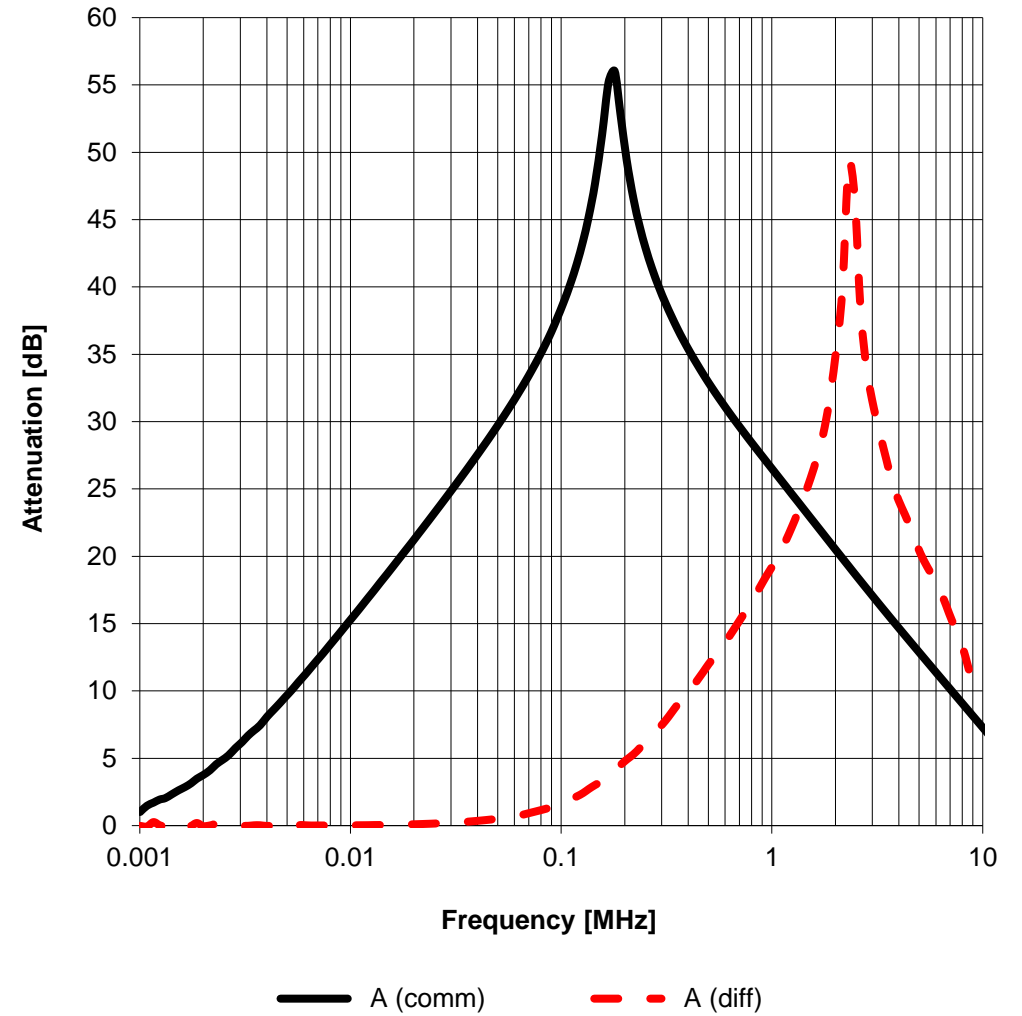
Common Mode




