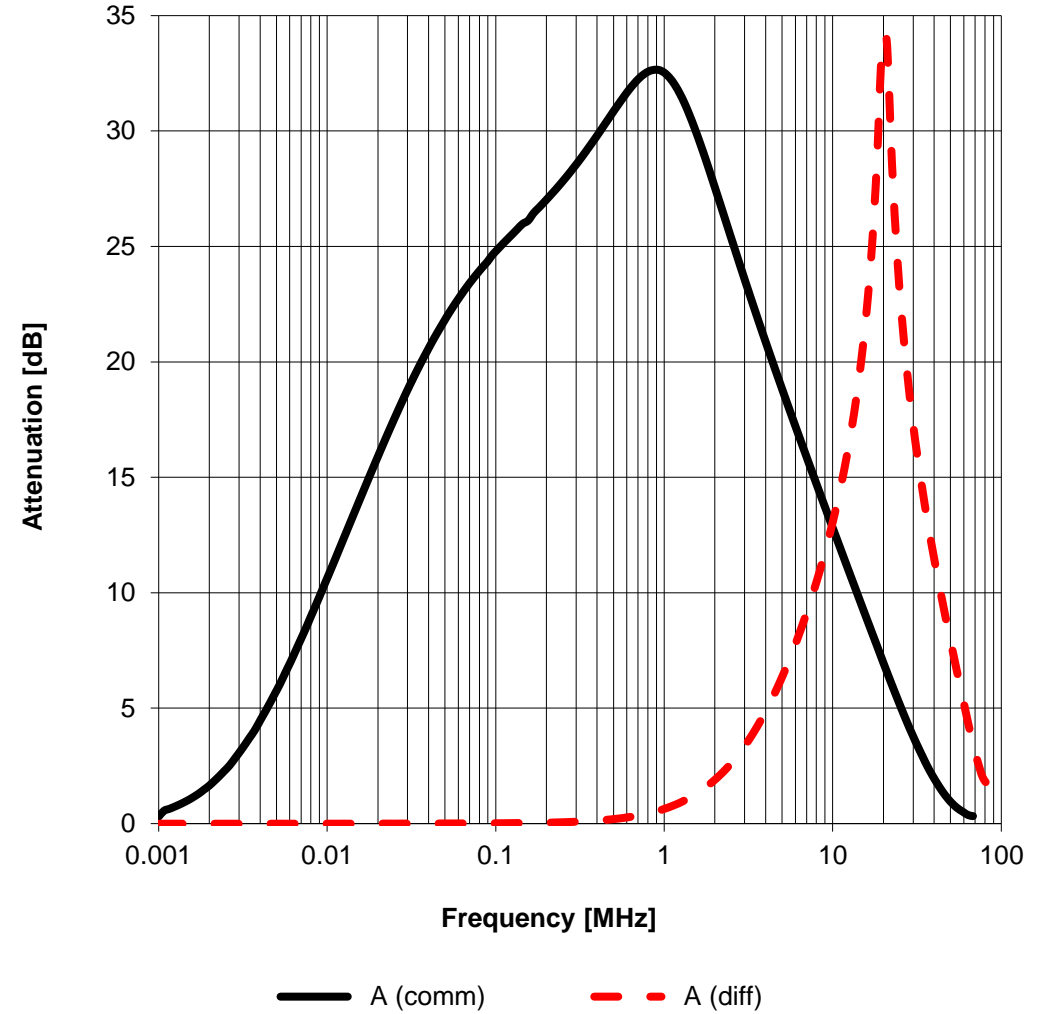
Common Mode




