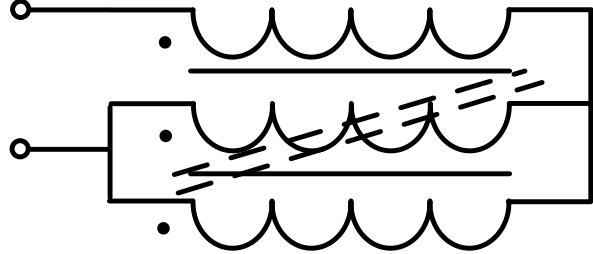

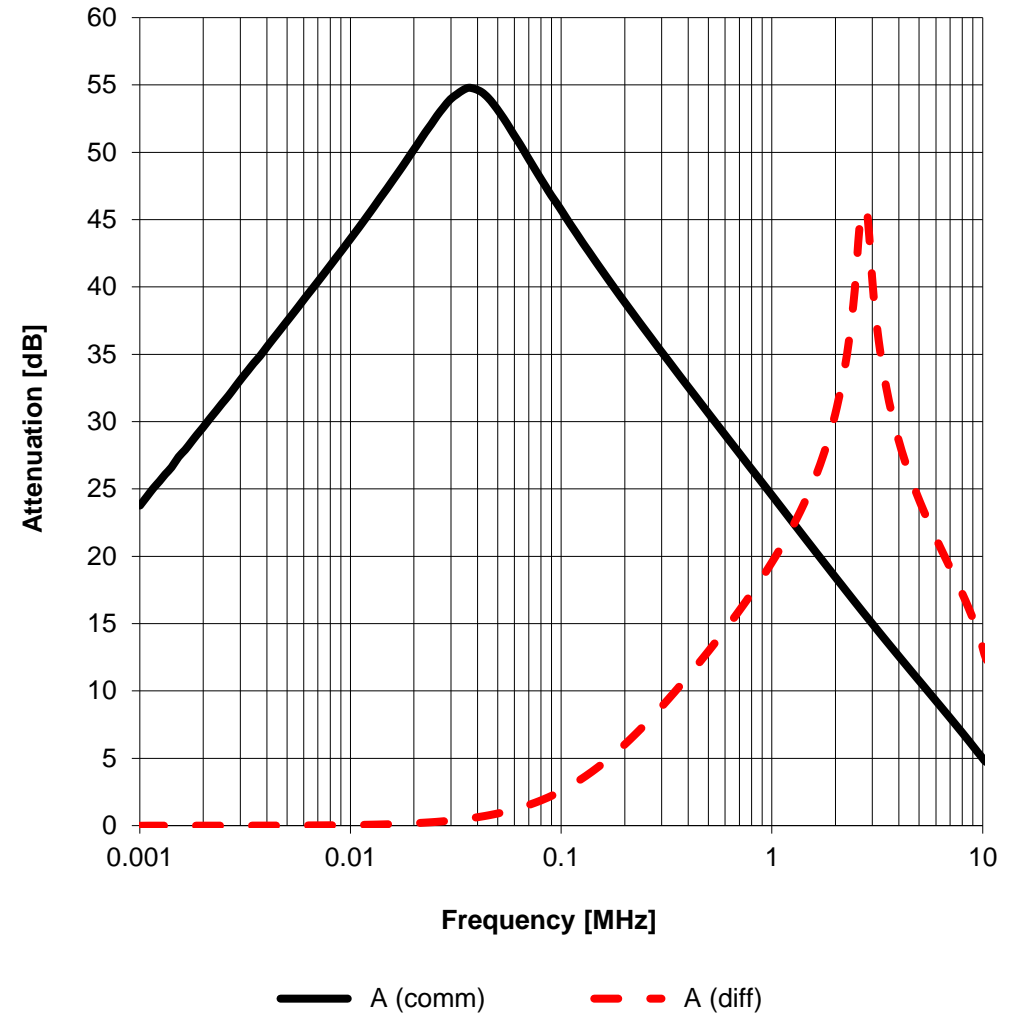
Common Mode




