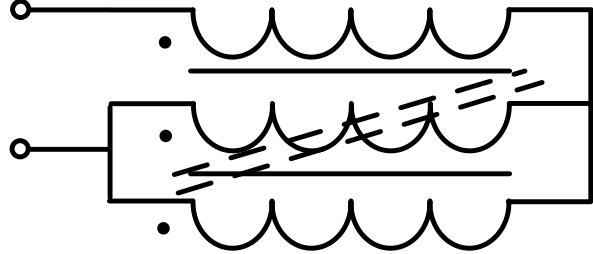

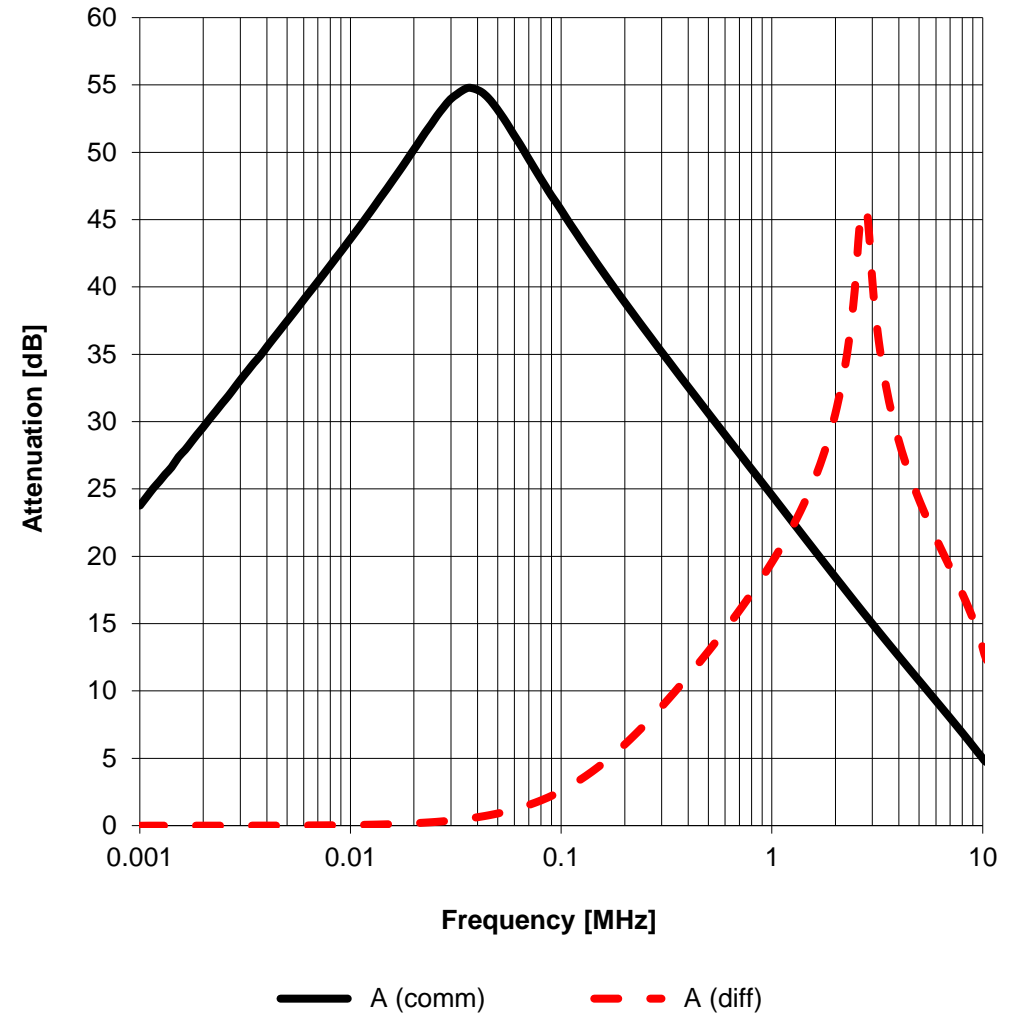
Common Mode




