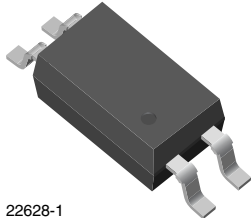
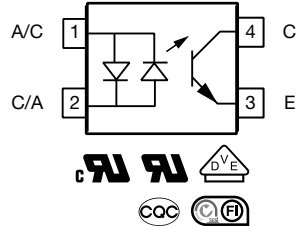


# Optocoupler, Phototransistor Output, AC Input, Low Input Current, SSOP-4, Half Pitch, Mini-Flat Package

## DESCRIPTION

The VOS627A series has a GaAs infrared emitting diode emitter, which is optically coupled to a silicon planar phototransistor detector, and is incorporated in a 4-pin 50 mil lead pitch mini-flat package.

It features a high current transfer ratio at low input current, low coupling capacitance, and high isolation voltage.

The coupling devices are designed for signal transmission between two electrically separated circuits.

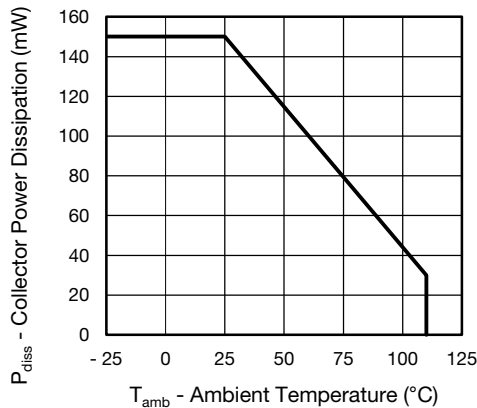


Fig. 1 - Power Dissipation vs. Ambient Temperature

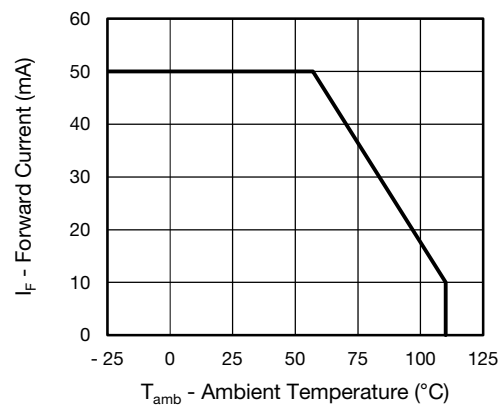


Fig. 2 - Forward Current vs. Ambient Temperature

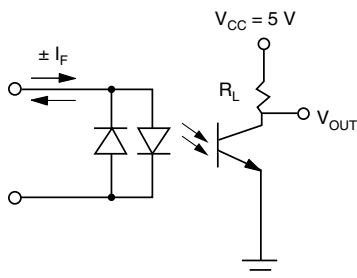


Fig. 3 - Test Circuit

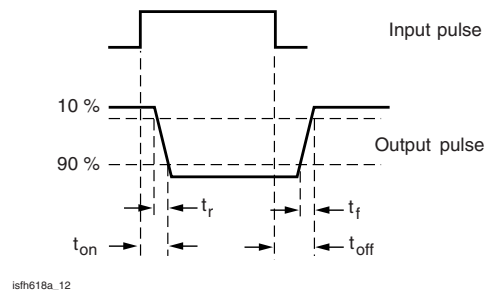


Fig. 4 - Test Circuit and Waveforms

Fig. 10 - Normalized Current Transfer Ratio vs. Ambient Temperature

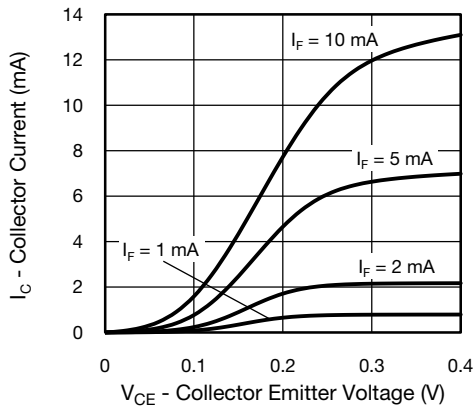


Fig. 8 - Collector Current vs. Collector Emitter Voltage

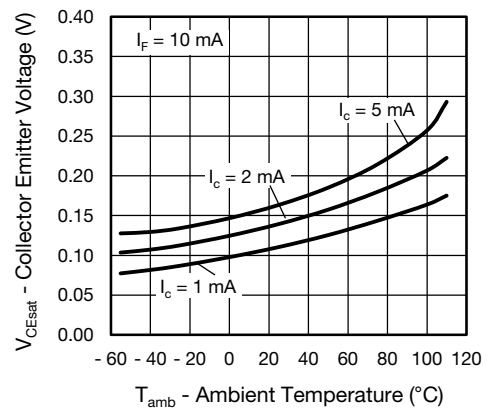


Fig. 11 - Collector Emitter Voltage vs. Ambient Temperature

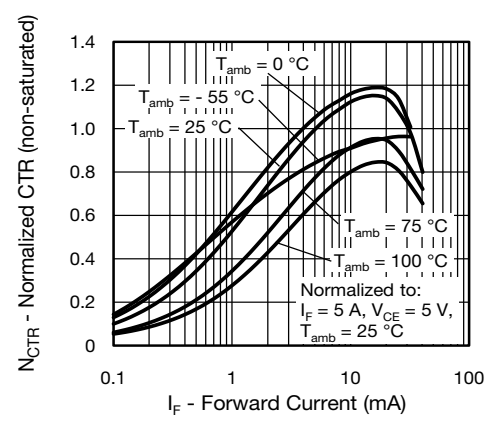


Fig. 12 - Normalized CTR vs. Forward Current

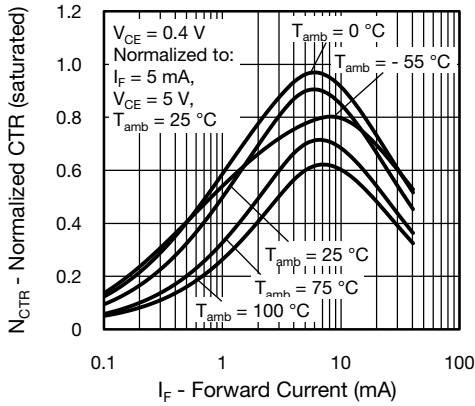


Fig. 13 - Normalized CTR vs. Forward Current

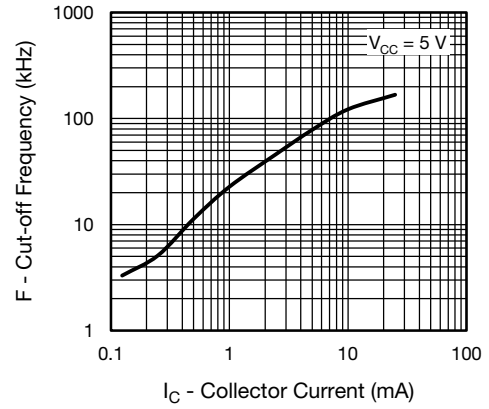


Fig. 15 - Cut-off Frequency vs. Collector Current

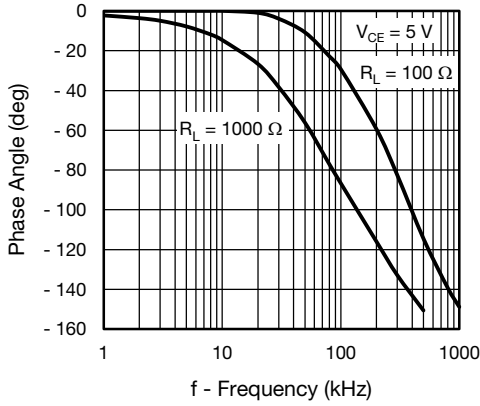


Fig. 14 - Frequency vs. Phase Angle

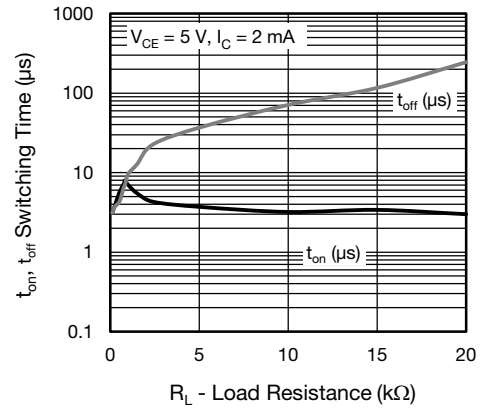
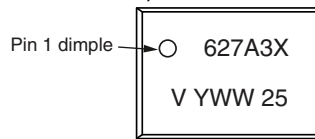


Fig. 16 - Switching Time vs. Load Resistance

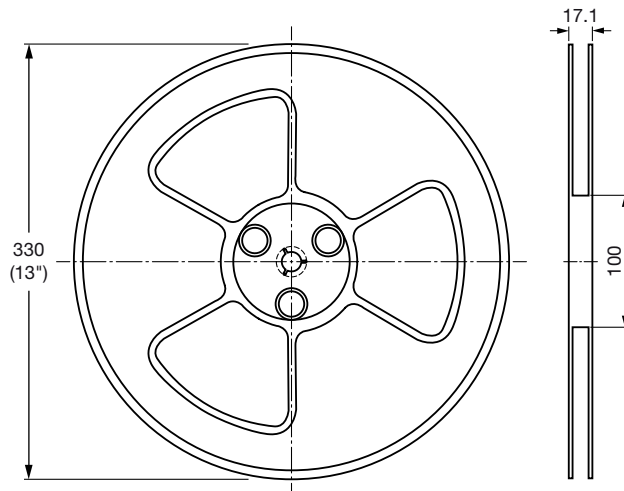


Fig. 17 - Reel Dimensions (3000 units per reel)
