Common Mode

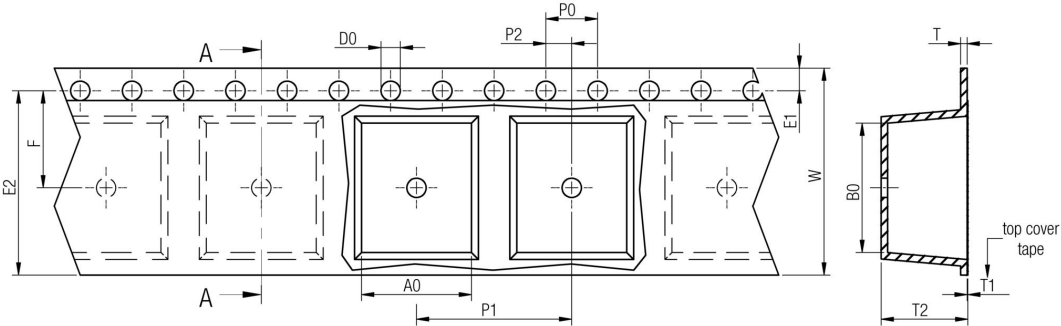
